PRESIDENT'S MESSAGE

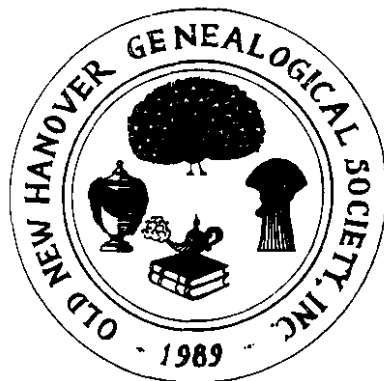
As the holiday season approaches, I am reminded that there will be many events scheduled and many requests made for your time. However, it is a very good time to talk genealogy with family members that you do not often see. You may glean a wealth of interesting information about your research project. Be sure to ask about birth, marriage and death dates for family members whose life events occurred before the states in which they lived began to keep records.

I receive many requests for the above three dates, particularly from members who live in distant places and have roots in North Carolina. Remember that North Carolina did not pass a vital statistics law until 1913. If a birth was recorded later, it was filed as a "Delayed Certificate of Birth".

Inquire as to whether there are family Bibles that may be in the possession of family members and, if possible, get a photocopy of the record, being sure to copy the title pages also. Be sure to record the name and address of the person who has the Bible in hand.

As always we are looking for informative, documented, genealogical records to publish in the Clarendon Courier. We will publish them as space permits. We are presently abstracting New Hanover County Guardian Bonds for publication in the newsletter and hope to have them first appearing in our next issue.

AN ALPHABETICAL LIST OF TAXABLES IN THE COUNTY OF NEW HANOVER

FOR THE YEAR 1762

Part One in a Series

The List of Taxables for 1762 in New Hanover County is divided between "St. James and St. Philip Parishes." St. Philip was the older of the two parishes, being in what is now Brunswick County. St. James was formed from St. Philip.

The definition of tithables, taxables, and polls was first made by the General Assembly of 1715, which enacted that "all Males not being Slaves in this Government shall be Tythable at the Age of Sixteen Years and All Slaves Male or Female, either Imported or born in the County shall be Tythable at the Age of Twelve years." The law was later broadened in 1749, and Legislatures during the period 1777-1784 experimented with several methods of applying the poll tax.

The first property tax was levied in 1715, in response to the heavy financial burden of the Tuscarora War, but this method of taxation was abandoned seven years later. The tax list in this series was taken in 1762. In 1777, much greater changes took place in the types of "property" listed. This list appears to have been a Poll tax only.

The original of this record may be found in Stack Reference SS-837 in the North Carolina State Archives. It is in poor condition. Some names and accounts were difficult or impossible to read. It is suggested that you refer to the original record for better reference.

The following is part of a series of Coroners' Inquests that will be **featured** in this publication. Though the entire document includes numerous counties we will only be printing the information for those counties in Southeastern North Carolina. The counties to be featured are as follows: New Hanover, Onslow, Duplin, Brunswick, Bladen, Carteret and Craven. The following selected portions of the article "North Carolina Colonial Coroners' Inquests, 1738-1775," by Haywood Roebuck, appeared in the North Carolina Genealogical Society Journal, Vol. I, no. 1 (January 1975), pages 11-37. NORTH CAROLINA COLONIAL CORONERS' INQUESTS

1738-1775

The following abstracts have been prepared from files of original and contemporary copies of coroners' inquests in the North Carolina State Archives, Raleigh. Every North Carolina county had a coroner, or "crown", who was as the name suggests, an official of the crown. As a crown official, the expenses of his office were met from the public taxes. To collect his expenses, the coroner submitted a copy of the results of each inquest to the General Assembly. The Assembly's Committee of Claims, in turn, voted by report the necessary reimbursement to the coroners when the committee approved colonial expenditures at each session of the Assembly. The "original records" from which the abstracts have been made are arranged in the Archives by date, and are a part of the Secretary of State's record group: SECRETARY OF STATE - Committee of Claims - Coroners' Inquests, 1738-1775 (shelf mark SS 316).

These abstracts are arranged chronologically by county where the inquest was held, and they report information in the following arrangement: Name of deceased; Occupation or other personal remarks relating to deceased; Cause of death; Details of death (if any); Place and date of inquest; Coroner; Jury.

Sometimes the names of the jury occur in the body of the reported inquest, and their signatures are appended at the end of the document. When substantial discrepancies appear in the two versions of the name, the information differing from the signature is shown in brackets; when the signature is by mark, the abstract shows only "(x)" whether the mark used was an "x" or whether a distinctive mark was used. Occasionally part of a juror's name has been torn away; in these instances an effort has been made to confirm the name from another record (such as deeds, tax lists, etc.), and the missing part of the name supplied in brackets. Uncertain readings are indicated by a question.

LEONARD, Roger. Accidentally drowned in Cape Fear River on 19 Mar 1738. Inquest held [at the house of Dr. Roger ROLEE] in Newton, New Hanover Co., on 25 Mar 1738. James MURRAY, justice. Jury: James SMALLWOOD; T[hos] SAWIER; Peter MORRES; Joshua JOHNSON; Robt. DAVIES; Edward MARTIN; Thos. HEDGES; Will. GRAY; Laurance HOWLEY; Anthony MADAN; Ja. CAMPBELL; Jno. LAYTHAM; John VOYER [called WIER in the summons]; Benjamin FUSSELL; Richd. MORTIMER; Thos. CLARK; John COFFIN.

NEW HANOVER COUNTY (Cont'd)

There are two accompanying documents:

Writ to call a jury issued by James MURRAY, justice, to Mr. James CAMPBELL, constable of Newton or in his absence to Mr. Rufus MARSDEN [Church of England minister in Newton]. Two persons called by Mr. MARSDEN did not appear: Robert HOGG and John MACHETT.

Two depositions on one page which are as follows:

SWINEY, Miles: Mr. MARSDEN's maid servant informed him of the discovery of the body, discovered by two slaves belonging to Mr. Rich. EAGLE. SWINEY with a Mr. TWANBROOK and others went in a canoe at the request of Mr. MARSDEN and brought the body ashore.

CLINTON, Rachel: A fortnight ago Roger LEONARD came to the house of Mr. Ralph SAMPSON and told her he wanted a passage to Brunswick and that he intended to go from there to Ireland.

TERNEY, Margaret, alias THORNE. Drowned when the canoe in which she was traveling to Newton with James MACLURE, Thomas MOORE and several others overturned at Gabourel's Bluff on Saturday, 26 May 1739. Inquest held at Gabourel's Bluff, New Hanover Co., on 29 May 1739. James MURRAY, justice. Jury: John SAMPSON, foreman. Thomas SAWIEK; John MARTINDALE; Josiah THOMAS; Loughlin O'BRIAN; Darbey HARNET; Robert GORDON; David BEVAN; Cornels. O'BRIAN; James GANEY; John SIMPSON; David PURSLEY; Joshua JOHNSTON. [NOTE: Signed only by the presiding justice and the foreman. An accompanying deposition contains the signatures of James MACLURE; Thomas (x) MOORE; Ja. MURRAY, J.P. & coroner pro hac vice.]

SUTLIFF, Sarah, of Wilmington, with an estate valued at 40 shillings. Drowned accidentally on 20 Jul 1752 after falling into Cape Fear River while endeavouring to get into a boat. Inquest held in Wilmington, New Hanover Co., on 20 Jul 1752. Richard HELLIER, coroner. Jury: John MAULTSBY; Joseph GLASS; Isaac BLACK; Richd. PLAYER; Ebnr. BUNTING; Benja. BERRYMAN; Anthy. EDMONDSON; James ARLOW; Simon ARMSTR[ONG]; Marmaduke WHIT[AKER]; Thos. (x) CUNNINGHAM; Wm. T[HOMPSON]. [NOTE: Torn.]

DAWCEY, Owen. Killed by a fall from the shrouds of a sloop commanded by John STEVENSON on 14 Jan 1753. Inquest held in Wilmington, New Hanover Co., on 14 Jan 1753. Joshua TOOMER, coroner. Jury: Robrt. RAITT; Thomas (x) CUNNINGHAM; James BLYTH; Isaac SANDARS; Jno. WAGNER; Robt. TATNALL; Benja. BERRYMAN; William ROBINSON; Thomas FINNEY; James ARLOW; John WALKER; Alexr. McDOUGALD; Robt. DUNCANSON; R[obert] WIER; Stephen McDOUG[ALD]; Saml. DUNBIBBIN; Saml. LINDSAY. Returned 30 Mar 1753, Ja. MURRAY.

JAMISON, David. Died after a two-bout fight with Michael STANTON at the house of Rowland CROKER on 18 Jan 1753. Verdict: chance-medley [a sudden or casual fighting; a melee]. Inquest held at the house of Rowland CROKER on Creek Island, New Hanover Co., on 19 Jan 1753. Joshua TOOMER, coroner. ab neptis: a great-great-granddaughter

abstract: a summary of the relevant information in a document

A.D.: anno domini - in the year of our Lord.

The Jargon of Genealogy (continued)

Adels: German nobility

administration: the process of settling an estate

administration cum testamento annexo (C.T.A.): administration with will annexed; an administration granted by the proper court when the decedent has left a valid will but failed to name an executor; named an incapable executor, or named an executor who refused to act; the estate is settled by a court-appointed administrator

administration de bonis r : administration of goods not already disposed of, as when one is appointed to succeed an administrator or executor who has died before completing the settlement of an estate

administrator: a person appointed by a court to settle the estate of a deceased person who has died without leaving a valid will or without appointing a capable executor.

alias: otherwise, at another time, formerly; also, in sixteenth-century Europe, used to link the names of a man and a wife if she had a good dowry and was the last of her line, thus perpetuating her family name, as Davies alias Clarke. In later centuries a hyphen might serve the same purpose.

ancestor: a person from whom one is descended

ancestress: feminine form of ancestor
