GENEALOGY NOTES PROM THE PUBLIC LIBRARY...



The Library thanks ONHGS for the generous contribution to the North Carolina Room. The funds will be used to purchase more genealogical books for the collection. A special thanks goes to Delmas Haskett, Bill Reaves, Lenore Gordon, Helen Sammons and all other library volunteers involved in the publication of local genealogical abstracts.

Many of you have been asking about when the library will buy the 1920 census for North Carolina. Perhaps the following excerpt will answer some of your questions. The Library will order them as soon as they are available for purchase.

1920 CENSUS RELEASE

(Excerpts from)
Opening the 1920 Census
by Oon W. Wilson, Archivist of the US

On Monday, Narch 2, 1992, the directors of the National Archives eleven regional archives fra coast to coast and 1, here in Mashington, D. C. will unlock the microfilm cabinets housing the 1920 census microfilm. This simple act will be the culmination of four years of work by more than forty staff members at a cost, rmt including salaries, of over \$1 million. In preparation for the opening of the 1920 census, the National Archives uill have produced seventeen complete duplicate sets of the material more than 3,400 miles of film. roughly the distance fra Washington, D.C. to San Francisco.

January 1 was the official enumeration date of the 1920 census. The National Archives is, then, enjoined from opening the census until January 1, 1992. My staff has selected March 2, 1992 - two months after the enumeration date - as the opening date for the 1920 census to ensure that all the necessary copies will be distributed and ready to use.

Preparations for 1920 opening

The next census opening is now in the planning stage. We have looked carefully at previous openings and not only begun to plan earlier for this opening but also to coordinate wr efforts better within the Archive..

The 1920 census exists only M microfilm and consists of 2.076 rolls of population census schedules and 8,590 rolls of the Soundex index. Every state in the 1920 census is indexed, which will simplify access for genealogists and family historians. Our Special Media Preservation Branch already has undertaken a frame-by-frame review of

each roll of microfilm. The rolls wre examined for density, scratches, focus, film curl, fungus, gasses, and fog. At the same fire, the staff mted for each roll of film the location of any physical problems that could not be corrected. The National Archives will produce the highest quality of the original film.

The microfilm catalog for the 1920 census rill be similar in format to the 1910 census catalog. **The most significant** changes uill be the **inclusion** of additional information about legibility problems on individual roll listings, a new appendix outlining the data elements included in the 1920 census, and a reproduction of an original schedule form. The 1920 catalog uill be published in the spring of 1991, nine to twelve months before the 1920 census is released. The catalog will be available free to libraries and for sale to interested individuals. Publishing the catalog in 1991 will allow prospective purchasers to place orders early.
Advance orders for complete duplicate sets or for copies of all rolls from a state that are received by September 1, 1991, will be shipped on March 2. 1992. All other orders will be shipped as soon thereafter as possible.

The National Archives Microfilm Rental Program will also have a set of the 1920 census and indexes available for rental beginning on March 2, 1992. Advance orders for rentals may be submitted after September 1, 1991. Those orders uill be filled beginning March 2, 1992.

The opening of a new census is a major event in the life of the National Archives. Uhen w unlock the cabinets, we unlock information about a generation of family life in the United States. We are as eager as all of you for that day.

IN SEARCH OF RICHARD CLINTON

Richard Clinton was one of Sampson County's most noteable citizens. He served as an officer in the American Revolution. He was a member of the North Carolina Legislature for many years. He introduced the bill in April 1784 that lead to the creation of Sampson County. He was a justice for many years in the county court and namesake of the county seat which was changed from Sampson Courthouse to Clinton in 1818 some 23 years after his death. Richard Clinton was an outstanding public service person and for this reason we are interested in discovering his genealogy.

John Sampson had a very close connection to Richard Clinton and tradition in Sampson County is that Richard Clinton was the natural son of John Sampson and Rachel Clinton. We believe he was born 1741 in Wilmington and grew up there.

John Sampson migrated from North Ireland to New Hanover county in 1734. He commanded a militia unit during the Spanish Alarm at Wilmington in 1748. As a New Hanover County legislator in 1749 he introduced to the N.C. General Assembly the legislation that lead to the creation of Duplin County. He married Ann Walker of Wilmington in 1759. He became the first mayor of Wilmington in 1760. He erected Sampson Hall on Great Coharie about 1761. He was appointed Lt. General of the Duplin County militia in 1768. He aligned himself with the Revolutionary Cause in 1776. John Sampson was very much a public service person, and his genealogy back about ten generations is known.

On 7 August 1762, John Sampson gave land to Richard Clinton, as follows: "For affection, love and good will" and five shillings (about 50 cents), for 507 acres "on the east side of Great Coheary and on both sides of the Beaverdam Swamp, being part of the same survey where the said John Sampson now hath his dwelling" (called Sampson Hall). This area is now in northeast Clinton

In his will written October 1783, John Sampson gave much of his worldy goods to Richard Clinton and his children. This was in addition to the previous gift of 507 acres of land. 7

On 14 March 1738, Ralph Sampson and John Sampson gave bond to the New Hanover County court to "discharge said precinct and parish from all charges on account of a bastard child which Catherine McDaid charges the aforesaid Ralph Sampson to be the father of". Ralph Sampson and John Sampson were brothers.

Also in March 1738, Roger Leonard was accidentally drowned in the Cape Fear River. Rachel Clinton gave a deposition to the New Hanover County Coroner stating that a fortnight ago Roger Leonard came to the house of Mr. Ralph Sampson and told her he wanted a passage to Brunswick and that he intended to go from there to Ireland. It appears that Rachel Clinton was living in the home of Ralph Sampson.

Prior to Mr. Sampson's gift of land in 1762, we have found no official record of Richard Clinton. Thus the generous gift of 507 acres may have been concurrent with his 21st birthday.

Richard Clinton and wife Penelope Kenan were married in 1762 and their first child was born in 1763. They named their fifth child Rachel. 3

The Dictionary of North Carolina Biography states that Richard Clinton is believed to have been a natural son of John Sampson and a nephew of Colonel Charles Clinton, the father of Governor George Clinton and of General James Clinton of New York. The Clintons came from Ireland. 2

Masonic historian Fred A. Olds has stated that Richard Clinton was a natural son of John Sampson. 11

MOORE'S CREEK

The Vidow **Moore**, for whom Hoore's Creek was named, has been an indefinite widow - several widows **Moore** lived on Hoore's Creek prior to 1750. Ve presume the creek was named for the first one who owned land there and who left land and many descendents to live on her plantations. Such a person was one Nrs. Elizabeth Xaore.

The Court Ninutes of Bew Hanover County, 16 March 1737/38, show that the Rocky Point District of New Hanover County included all the land above Begrohead Point opposite Vilmington between the Borth East and Borth Vest Rivers and up the Black River as high as Widow Noore's. The Vimble map of 1738 shows "V. Noore" on the Black River at the approximate location of the lands of Vidow Elizabeth Noore. Since we find no other Vidow Noore in the area at that time, it would seem he was referring to Vidow Elizabeth Noore. Vimble also shows a V. Noore on Cape Fear River at the location of Pleasant Oaks Plantation. Ve know that this is Justina Noore, widow of John Noore of Pleasant Oaks. There can be found no man of the Noore name in the area at this time who name begins with the initial "V."

The Vidow Elizabeth Moore had formerly lived on the Borth East River where she sold a plantation to John Marshall, who owned it for several years. It was part of his plantation around Marshall's Ferry across the northeast branch of the Cape Fear River. In 1735, John Marshall. Mariner, used two tracts of land in a business deal, stating that one tract (adjoining the other) was a tract he had bought from the Vidow Elizabeth Moore, and lying on the south side of the northeast branch of Cape Fear River, adjoining Mr. Roger Haynes an the west and Colonel Maurice Hoore on the east.

Records are conclusive that when this Vidow **Moore** sold her land on the Borth East River, she settled on Black River near the mouth of Hoore's Creek.

Vas this Elizabeth Moore the widow "Elizabeth" who was the administratrix of her husband. Dennis Moore, whose Estate Inventory is in the Secretary of State's papers of Borth Carolina? This Dennis Moore died in 1734 in Craven County.

The positive identiy of the "first Vidow Moore" to live on Hoore's Creek, and the lady for whom the creek was named, would be of value to researchers of this very large family.

ALDERMANS IN AMERICA: REVIEW

ONHGS member James Alderman Ezzell has graciously donated a copy of Aldermans In America by Villiam Alderman Parker. Raleigh: Villiam A. Parker, 1957. Hard cover, [ix] + 713 pp., photographs, full-name index. 6 1/4" x 9 1/4". The 1977 reprint is distributed by Mr. Ezzell at P.O. Box 67, Harrells, BC 28444.

This work is primarily an account of the descendants born before 1942 of Daniel and Abigail (Harris) Alderman's sons John, Daniel, and David, who came from Hew Jersey to southeastern **North** Carolina in 1755, and allied families named Bland, **Bowen**, Case, Cashwell, Hall, James **Newton**, and Spencer. Its forty-two page index is replete with the names of people well known to students of Borth Carolina genealogy and history, including a number who have been benefactors of the State university system. There is also an appendix with some of the source material the compiler used.

The numbering system is unorthodox and inconsistent, but easily managed. **Most** of the documentation consists of published sources, reminiscences of people the compiler contacted, and other correspondents. The index lists **known** identifying dates for the people it names. so as to distinguish each from others of the same name. Such a system is a time-saver for researchers that would be welcome in others works. In this book is a great deal of information not easily available elsewhere, that should suggest clues to family members and other for independent verification and further research. Students of any families in the **ONHGS** area might benefit from consulting this work.

Information for Ordering Social Security Applications

Social Security Administration Applications show the address of the applicant, date and place of birth, father's name and mother's maiden name. To obtain a copy of the application form for a **deceased** relative for Social Security, complete Form F **SSA-L997**, available from any S.S.A. office.

The Social Security Administration plans to destroy the original 37 million applications for Social Security. They have computerized some of the information, but general information has been omitted. This information will be lost when the original forms are destroyed. The early files include many persons born in the 1860s and 1870s and many were naturalized citizens. It is suggested that letters be written to the Social Security Administration, 6401 Security Blvd., Baltimore. MD 21235, and to your representatives in Congress for assistance in retaining these valuable records.

Due to the number of articles submitted for this issue of the newsletter, we were unable to print Part 3 in the series, "North Carolina Colonial Coroners' Inquests: 1738-1775." Ve will continue with this series in September.

FOR THE YEAR 1762

Part Three in a Series

The List of Taxables for 1762 in New Hanover County is divided between "St. James and St. Philip Parishes." St. Philip was the older of the two parishes, being in what is now Brunswick County. St. James was formed from St. Philip.

The definition of tithahles, taxables, and polls was first made by the General Assembly of 1715, which enacted that "all Males not being Slaves in this Government shall be Tythable at the Age of Sixteen Years and All Slaves Male or Female, either Imported or born in the County shall be Tythable at the Age of Twelve years." The law was later broadened in 1749, and Legislatures during thr period 1777-1784 experimented with several methods of applying the poll tax.

The first property tax was levied in 1715, in response to the heavy financial burden of the Tuscarora War, but this method of taxation was abandoned seven years later. The tax list in this series was taken in 1762. In 1777, much greater changes took place in the types of "property" listed. This list appears to have been a Poll tax only.

The original of this record may be found in Stack Reference SS-837 in the North Carolina State Archives. It is in poor condition. Some names and accounts were difficult or impossible to read. It is suggested that you refer to the original record for better reference.
