\* Angus **Baxter** is the author of six best-selling books on genealogy. He has given over 1000 lectures in the past 13 years, as well as making some 350 appearances on TV and Radio programs. He has also been a guest lecturer at the National Archives in Washington, DC. Mr. Baxter is a contributing editor of "He tage Quest," a leading genealogical magazine. His book, European Roots, was chosen by the American Library Association as one of the four best reference books published in 1986. Mr. Baxter has been researching genealogy for 40 years and during this time has traced his own family back to 1195 and his wife's family to 1153. He was born in England, educated at Bristol Grammar School and Bristol University, and immigrated to Canada in 1953. He is a Canadian citizen and lives in an 1841 house in Lakefield, Ontario.

**HITHER AND YON**

A Guide to Researching in Various Repositories

According to Mrs. Mary Painter, the speaker for our February meeting, there are lots of exciting things going on in the Family History Center in Wilmington and in other centers across the country. In addition to the material on file on microfiche and microfilm: The International Genealogical Index (IGI), The Family Group Records Collection, The Family Histories, and the Family Registry, the center has a computerized genealogical information system called "**Family Search.**"

"Family Search is a collection of easy to use computer files developed to help individuals find information about their ancestors. The files are on compact disks and include:

**ANCESTRAL FILE** - contains genealogies linked together by family groups and pedigrees. One can trace an ancestor's ascent or descent as far back or forward as the family information that others have contributed will allow.

**INTERNATIONAL GENEALOGICAL INDEX (IGI)** - contains names and vital information for over 147 million people, listing them alphabetically by country or state of birth or marriage.

**FAMILY HISTORY LIBRARY CATALOG (FHLC)** - contains lists of every book in the Genealogical Library in Salt Lake City that can be ordered on microfilm. For a small fee, you may order the microfilm for three weeks, six months, or on **indefinite** loan.

**SOCIAL SECURITY DEATH INDEX** - a collection of 39.5 million names of deceased persons who had social security numbers and whose deaths were reported to the Social Security Administration. It will give you the person's Social Security Number, the month and year of death, the state and zip code (which allows you to ask the computer for the town.) The index will also give you the address of the Vital Records office in that state where you can write for an official death certificate. You may also write to the Social Security Office for a copy of the application packet on file for that person for a fee of about \$7.00.

Mrs. Painter and the other members of the local **LDS** church who volunteer their time are very cordial and eager to assist visitors to the Family History Center. You may want to call ahead and reserve time on the computer if you plan to use it.

NEW HANOVER COUNTY GUARDIAN BONDS - 1843-1854

These abstracts were taken from microfilmed records located in the Local History Room of the New Hanover County Public Library in Wilmington, NC.

Property often came into the possession of persons who were unable to handle it because of age or infirmity. Probate authorities appointed guardians, receivers, trustees, or collectors to take charge of such property. Guardians were appointed for orphans; for children of living parents but who were possessed of estates; for children who were parties to legal proceedings; for incompetents such as lunatics, idiots, and inebriates. However, most researchers will probably be most concerned with guardians of orphans.

Guardians were appointed from among relatives or neighbors of the ward or from other persons considered trustworthy by the probate authority. Those persons under the care of a guardian were called wards, but this did not necessarily mean the ward was an orphan. Children fourteen years of age or older were allowed to choose their own guardians and were allowed to change guardians. They were legally minors or infants until the age of twenty-one years.

Upon appointment by the probate authority, guardians were required to take oaths and post bonds before receiving letters of guardianship. Guardians were also required to submit an annual report or account to the court and to renew their bonds periodically. A surety was a person who assumed responsibility for the guardian's character and financial stability.

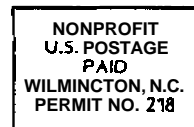
