New Eanover County Court of Pleas & Quarter Sessions Minutes

[Here is the beginning of a new series submitted by Helen Moore **Sammons**. The New Hanover County Court Minutes prior to 1800 were abstracted many years ago by Alexander Walker. They are in four volumes and can be purchased from ONHGS. A Courthouse fire destroyed the county court minutes from 1800 to 1805, therefore, Mrs. Sanmons begins her series in 1805. Monday, 17 June, 1805 - County court began and held at the Court House in Wilmington, in the county of New Hanover.

Present: Worshipful Samuel **Ashe**, H. Kelly, H. **Walters**.

John Colvins, John Scott, John London, J.F. **Burgwin**, Samuel **Mabson**, James Howard, B. **Batson**, James **Newton**, and Zadock James excused for attending this term as jurors.

Deed from James B. White to James **Moore** proved by Alex. **Anderson** and ordered to be recorded.

William **Giles**, H. Kelly, and John N. Gabie appointed to audit the accounts of guardians.

Deed from Nathan **Huggins** to John Greer proved by B. **Mills** and ordered to be registered.

Deed from R. **Langdon** to W. H. Beatty proved by Alex. Peden and ordered to be registered.

John **Walker**, an orphan, bound to William **Harris** to learn the trade of tailor.

Ordered that the sheriff hire out a **mallato** boy named James **Shephard**, and that he advertise him in the Wilmington Gazette, the said boy supposed to be a runaway slave who passes himself as a free man.

The last will and testament of **Barnabas** Fuller exhibited in court and proved by Michael **Sherlock**, Moore ~~Wood~~ qualified as executor, and ordered to be registered.

Court adjourned till 4 o'clock this afternoon.

Monday evening- Court met according to adjournment.

Present: Worshipful H. Kelly, Robert **Nixon**.

Grand Jury drawn and sworn: John **McLellan**, Daniel **McLammy**, James Devane, Michael **Sherlock**, Hinton ~~James~~, George **Sidbury**, Samuel **Stuckey**, John Stuckey, John **McAuslen**, Alex. Frederick **Buford** appointed to attend the Grand Jury.

H. **Wright** returned as constable to attend Grand Jury.

Ordered that the sheriff for the succeeding year give bond for the collection of the county taxes in the penal sum of 1000 pounds.

Major Samuel **Ashe**, Timothy **Bloodworth**, Esq., and Samuel **Buxton** appointed to divide the estate of John **Larkins**.

Paul **McCall** took the oaths required by law of Congress directing the mode of naturalization.

Ordered that a Negro fellow put in jail by Samuel **Bloodworth**, now in custody of the jailor to take bond from the hirer.

Upon motion ordered that George **Hooper's** petition be granted. John **McAuslen** and John **McFarlane** securities.

Court adjourned to 9 o'clock tomorrow.

Tuesday, 18 June, 1895- Court met according to adjournment.

Present: Worshipful David **Jones**, Sr., John **Bloodworth**, Benjamin **Sutton**.

Admn. on estate of James **Taylor** granted to Jonathan **Johnson**, giving bond in 900 lbs. with Thomas **Devane** and James **Devane** as security.

Admn. on estate of John **Sullivan** granted to Mary **Sullivan** giving bond 1000 lbs. with Nathaniel **Gufford** and D. **Turnan** as security.

Admn. on estate of James **Jones** granted to **R. Bostic**, giving bond 250 lbs. with Thomas **Snead** and Thomas **N. Gautier** as securities.

Francis **Devane**, the widow of Thomas **Devane**, dec'd, came into court and made known her dissent to the will of her said husband.

William **Giles** and P. **Maxwell** appointed to take the private examination of Charity **Jennings**, wife of G. **Jennings**, relative to her signing some deeds.

O. **Kenan** qualified as Justice of the Peace.

Rebecca **Williamson** made choice of George **Newton** as her guardian, giving bond 400 lbs. with security.

An election held to elect a clerk of this court, Thomas F. **Davis** was elected.

**Allman Ball** was re-elected county trustee.

Ordered that a tax be laid of \_\_\_ on every poll and \_\_\_ on every 300 acres fraying the expense of erecting a bridge over **Rockfish**.

Ordered that F. ~~Simpson~~ be excused from attending courts as a juror on account of deafness.

Ann ~~Devane~~ chose John Bloodworth as her guardian, giving bond of 4500 lbs. with James Devane and Thomas Devane as securities.

Ordered that a tax be laid of \_\_\_ on every poll, \_\_\_ on every 300 acres of land, and \_\_\_ on every 200 lb. value of town property for purpose of repairing court house.

Thomas Gautier appointed to assist the Treasurer of Public Buildings to contact someone to perform the repairs on court house.

William Wright appointed to take care of the court house and allowed the sum of 5 (?) lbs. per year.

A deed from Joseph ~~Lamb~~ to James **Moore** acknowledged and ordered to be registered.

A bill of sale from Thomas **Rutledge** to James **Moore** proved by Moses Uoore and ordered to be registered.

A deed from Aaron **Morgan** to James Uoore proved by Moses **Moore** and ordered to be registered.

David ~~Jones~~, Esq., Spirus ~~Stanley~~, Hardy **Malpass**, and Sweeten Bond appointed to lay off one year's provisions to Jane ~~Stokely~~ out of the estate of her deceased husband.

James ~~Register~~ vs James ~~Rogers~~. Jury impanelled- Wm. **Harriss**, John **McCall**, Timothy Wilson, Samuel Bloodvorth, James Portivent, Benjamin Sheppard, Jonathan Stanley, John **McLendal**, David Parker, William Collins, D. ~~Greer~~, and James Wright and affirm the judgement of the Justice for 3/4 costs.
