State of N.C. - At a Court of Pleas and Quarter Sessions began and held for the county of New Hanover the Court House in Wilmington on Monday, 16 Sept A D 1805 and in the 30th year of independence.



*** The Dangers of Ancestral Research ***

A Washington man who prides himself upon his family connections is just recovering from an attack of nervous prostration, says the <u>Washington Star</u>. This man lately became possessed of the idea of constructing a family tree, feeling assured he could produce a growth that would dwarf the giants of the California forests into insignificance. He began on one branch of his growing tree, and had gone back but four generations when he was amazed to strike a great-grandfather who had died from strangulation brought on by a rope encircling his throat, his death occurring in the presence of a large gathering of curious people, who had taken a day off during harvest time in order to see the hanging. By this time the man of family pride had become intensely disgusted with genealogical investigations but all that his friends knew of his disappointment was the fact that he remained away form the busy haunts of his fellows for several weeks. It took quite awhile for the family physician to revive the man's health, and the final results of his many hours putting together a family tree was never known.

Brunswick County, North Carolina Assessment North West District for the year 1863

[Property assessment lists for North West and Shalotte Districts of Brunswick County survive for the year 1863. The originals can be found in the North Carolina Department of Archives, located in Raleigh, N.C. They include a list of slaves, which may be helpful to the African-American genealogist. Although only the first name of each slave is given, the time is only seven years before the 1870 census where emancipated slaves were recorded in full for the first time. Hopefully, with the use of names and ages some connections can be made, and the findings helpful in African-American research. Also, locations and acreage may assist in the investigation of landowners. Here begins a series of these valuable lists, submitted by Lucille Blake.]

Included in each entry, in the following order, are <u>Names of Owners</u>, <u>No. of Acres</u>, <u>Location</u>, <u>Value of Land</u>, <u>Names of Slaves</u>, <u>Age</u>, <u>Value of Slaves</u>. When a landowner owned more than one plot of land, the data may begin over again. The value is in dollars.

SPECTACULAR FIND!

Don't give up on your family history. You never know where great information might turn up. While removing the chimney of the Ebron House (1853-1854) in Williamston, North Carolina, owner Buck Davis found the following tucked in between the bricks:

WONDER! WONDER! WONDER! To PRINCE POSTERITY Stranger Open and Read Martin County, N.C.

TO PRINCE POSTERITY:

The undersigned, a mason by trade (as well as belonging to the free and accepted order) most respectfully represents unto you that he built this stack of chimneys for William Eborn, counsel and attorney at law of this place. The building of this chimney commenced Tuesday, November the first day A.D. 1853 and the sixty eight year of the Independence of the United States of America (North) the land of the free and the home of the brave. The building of this chimney cost \$20. The bricks and lime came from Mr. Wright and _____ of New York City, State of New York. The house was built by Joseph M. Bryan and is now new.

The undersigned is the son of Thomas <u>Liddon</u> (the son of Thomas and Margaret <u>Liddon</u>) by **Eliza**, daughter of Sherry <u>Locke</u> and his wife Susan, and was born in Wilmington, New Hanover County, in the state of North Carolina on 29th February (supposed on Sunday morning) in the year of our Lord 1820-- was married on the 23 day of May 1839 (Thursday night) to Rebecca <u>Johnston</u> of **Onslow** County, daughter of John <u>Johnson</u> and his wife Mary Margaret <u>Ward</u>. Said undersigned after his marriage moved to Tarboro, Edgecombe County, N.C. in 1847 and from there to Hamilton, Martin County, N.C. in 1849 and from there to Williamston, county and state aforesaid, in March 1853. Undersigned has by said marriage at this time five children, 2 sons and 3 daughters viz:

David Liddon born October 1st day -- 1840 Francis(a daughter) born October 20th -- 1845 Virginia born October 13th - 1851 Thomas born August 29th -- 1853

The above is undoubtedly correct. Given under my hand in the town of Williamston in the county of Martin and state aforesaid this the 4th of November -- 1853.

The owner of this house and lot is Wm Clark Eborn, the son of Zachari and Florence Eborn by his second wife Betsy Clark. Was born 29th September 1808 on Pungo Creek, then Hyde, now Beaufort County, N.C. Was admitted to the position of the law in said state in the county courts 1833 and the Superior Court practice in 1835. Settled in Greenville, Pitt County in 1834. Was elected clerk of Beaufort County Court July 1837 and served 4 years. Was married to Martha Sally Ann Williams, daughter of Lewis A. Williams by wife Pricilla

Kearney (of Warren County). Before his marriage at the late residence of said Lewis A. Williams on 3rd of April, 1838, Wednesday evening. Settled first in the town of Washington, Beaufort County from ______ to latter part of 1841. Purchased land in the upper part of Martin County between Samuel Williams and Joseph I. Williams in 1839 and 1840 and commenced farming on said plantations in January 1841, which land he now owns. He resided on his farm from 1841 to 1st January 1852 when he moved to Williamston, Martin County, N.C. to practice law and educate his five sons by said marriage viz:

Lewis Zachariah-- born January 26th A.D. 1842

John Philip-- born August 19th A.D. 1843

Wm. K.A.W. -- born May 5th A.D. 1845

Charles Carroll-- born November 2nd 1846

Samuel Robert -- born October 10th 1850


Zachariah F. Eborn was the son of Colonel John Eborn (a Revolutionary soldier and officer) by his wife Arcadah Foreman born in Hyde County, December 13, 1777. Col. Jno Eborn was the son of Henry Eborn by Martha Smith. The Eborns are of German descent (a town in Germany same name). Arcadah Foreman was daughter of Joshua Foreman by Rebecca Martin, born on Pungo Creek, Hyde County. Lewis A. Williams was son of Samuel Williams by his wife Charity Dawson, whose father was General John Dawson of Halifax. The grandfather of Lewis Williams was Wm Williams, Esq. by a Miss Whitmell, widow of Pollock.

Priscilla Kearney, wife of Lewis A. Williams was the daughter of Philip Kearney by his wife Betsy Kintchen of Warren County. Wm Williams above was the first Register of Martin County and laid off the town of Williamston. Wm C. Eborn, the husband of his great granddaughter is the Eborn of Beaufort County. Wm C. Eborn has two brothers Samuel C. and Robert D. Eborn of Beaufort County. Samuel married Polly Ann Clark, widow of T.R. Blount and has 2 children. He has one sister, Mary Elizabeth D. who first married James H. Blount of Beaufort County and had one child Elvira Blount that survived him. She afterwards in 1853 in June or July married James Garrason, Esq. (a widower with no children of Long Creek, New Hanover County, N.C.) where she now resides happily married.

The two lots on which this house and my law office is built was purchased by me from D.W. <u>Bagley</u> of Williamston for \$125 in 1852. The two back lots were purchased by me from John D. <u>Latham</u> and <u>Amalek C. Williams</u> in 1853 for \$100. See deeds in Registers office in Martin County Book P and from Mr. <u>Hassell</u> and <u>Williams</u> to <u>Bagley</u> and from same to A.C. <u>Williams</u> 1850. These lots are not at this time within the corporation of Williamston. This writing is done on the premises by the owner and occupant this fourth day of November 1853.

** Death of Capt. Uieting **

[From the <u>Charleston Daily Courier</u>, December 8, 1868 is the following obituary of Capt. Wieting, who brought many Germans to Charleston, S.C. during the three decades before the Civil War. A large number of Wilmington's German emigrants entered the United States through the port of Charleston, and no doubt they too knew of Captain Wieting. Death of Capt Wieting-- Our community was pained yesterday by the announcement of the death of this widely known and highly respected old veteran. Capt. H. Wieting was born in the Free Hanse town of Bremen in the year 1813 and was consequently at the time of his death 55 years old. The greater part of his life has been spent on the sea, and for the past thirty years he has been engaged in trading between Bremen and this city. He made his first trip to this port as Captain of the Johan Frederich, on which he sailed for seventeen years, first as a sailor before the mast, and then successively as Mate and Captain. The Johan Frederich, was lost in the year 1849, after which Capt. Wieting assumed command of the Copernicus. He sailed in this ship until 1859, when he took charge of his present vessel, the Gauss. In her he made several voyages to Charleston before the war, and two since the termination of the war. His first trip made here after the conclusion of hostilities was in 1867, when he brought a large number of emigrants. The Gauss arrived here on the 29th ultimo, after a passage of fifty-five days. Captain Wieting was taken ill on the 6th of November, and from that time until his arrival in port, was incapacitated from attending his duties. Immediately after his arrival he was conveyed to the residence of Mr. N. Ferrenbach, where he remained until the time of his death. When removed the best medical aid was called to his side and some hopes were entertained that the fever (a type of typhus fever) might succumb to the effects of the climate. But these hopes were destined to disappointment and on Wednesday morning, at twenty minutes past eight o'clock, the spirit of this brave, generous and lamented man winged its way to eternity.

Captain Wieting leaves a family, consisting of a wife and eight children in Bremen, to mourn his loss.

He had many warm friends of all nationalities in this city, but upon none of them will his loss fall more heavily than upon our German fellow citizens. By them he was universally looked upon as a father; more than three-fourths of the native Germans having been brought here by him. His mind and amiable disposition, combined with his generous heart, made him beloved by all who knew him. His kindness to those who sailed under his care; his attention to their wants, and readiness to relieve them, never failed to win their heartfelt gratitude, and the name of Captain Wieting is now a household word in every German family in this city.

John Gambier Scull, Esq. A Brief Biography

The subject of the following sketch is the great, great, great grandfather of the author, who wishes to correspond with anyone interested in the Scull family. More information on John Scull and full documentation for this article can be found in the "Scull Family" file, New Hanover Public Library.]

John Gambier <u>Scull</u>, born around 1755, was the son of **Pantwell (a.k.a.** Cantwell) Scull who may have been the P. <u>Scull</u> of the War Office under Governor Caswell. John's mother was the widow of George <u>Belume</u>. Her given and maiden name are unknown to the author. John's sister was Eleanor who first married William <u>Vernon</u> and had issue, second married Thomas <u>Neale</u>, and third married in 1798 <u>James</u> Williams and had issue.

John's first wife, who he married after 1775, was Mary <u>Colvin</u>, the daughter of John and Ann <u>DeRosset Colvin</u>; the grand-daughter of Alexander <u>Colvin</u> of Scotland by wife Margaret <u>Robinson</u>. John's second wife's Christian name was Dorcas, her last name unknown to the author.

John and Mary's (first wife) children were Eleanor, who remained single; Mary Catherine, who married John Mills <u>Vernon</u>; Jean (a.k.a. Jane), who married Nathan <u>Williams</u>; Joseph Gambier, who married Margaret <u>Burch</u>; Flora, who died young; James H. Scull, who married Celia **Evans**.

John and Dorcas' (second wife) children were William, Dorcas. John, Mary Elizabeth, and Sarah Scull, all still minors on 15 May 1815.

John Gambier <u>Scull</u> joined the colonial army soon after hostilities with Britian commenced. He was appointed to ensign on 1 June 1776; second lieutenant on 15 August 1776; and first lieutenant on 13 April 1777. He served with Brown's Company of the 1st Regiment and by 9 June 1779, he had risen to the rank of Lt. Colonel. On that date General Alexander Lillington sent a letter to Governor Caswell asking the Governor to retain John in the Army and that he be commissioned to hold permanent rank of Lt. Colonel.

John owned land in present day Columbus County, New Hanover County, Brunswick County and Pender County. His family seat was adjacent to what is now known as Neal's Eddy (formerly Port Vernon), in Ransom Township, formerly Brunswick, now Columbus County.

As New Hanover County representative during the 1789 Convention in Fayetteville, John Scull voted on the issue of ratification of the Constitution. He was a Justice for the Court of Pleas & Quarter Sessions for New Hanover County from 1791 to 1797, represented New Hanover County in the General Assembly from 1790-1792, and Brunswick County from 1801-1803. Later he served as Lt. Colonel of the Brunswick County militia and High Sheriff of Brunswick County. He died at his family seat in Brunswick County on : er 1811.

The **Stringfield** Boys of New Hanover County by H.C. Stringfield

[The following is an excerpt from a number of reminiscences by H.C. Stringfield. The original can be found at the Duplin County Historical Society's McEachern Library, in Rose Hill, N.C. Submitted by June Swinson.]

Savannah, Ga., April 9th, 1907

"I remember my Grand-father told me that his Father was a Virginian, of Dutch decent, a soldier in the Revolutionary War. After the war, married a Miss Fellows in Duplin County. North Carolina, settled there, raised six children: John, the eldest moved to Alabama. William to Augusta, Georgia, Elisha didn't know where, Edward and his sister Rachel, to Barnwell County, South Carolina.

My father Peyton Randolph Stringfield was the first child born to Grand-papa Joseph. I have forgotten the month but the year was 1807. My mother was a Miss Jones, born twenty miles above Wilmington, the youngest child in the family born 1810. All mothers family except one brother died before I was born. Papa P.R. and mother Susan Jane, had thirteen children, I am the sixth, the first two died before I was born. I, Charles Henry Calhoun Stringfield, so recorded in the old Bible was born April 9th. 1841. When I grew up I left off the Charles, for no reason that I know of unless it was so long.

I was born at the Roger's House near grand-fathers. The house was on a hill south of the old mill built across a little stream called Wild Cat..." "Billy and Nic Fennell, Stewart DeVane would come to our house for mother to cut their hair. One time they were there mother clipped Nic's ear, scared Nic until he almost fainted..." "Left of the orchard was papa's office. He was a Doctor the Homepath. He had a sorrel horse named Trim. On the other side of the orchard was old Jeffry's house and spring, would get water when old Jeff was away. We were afraid of old Jeff; he was a little old black African Negro."

"The first preacher I ever recollect was George Fennell, and with his slave Balaam they would come to papa's on horseback each of them and spend the day in conversation. At dinner mother would prepare a side table for Uncle Balaam. Fennell was a rich man in everything. He and Balaam did nothing else but preach." (More from Mr. Stringfield in future Couriers).

New Hanover County Deed Book C

[Many of New Hanover County's earliest records have been destroyed by Courthouse fires. The first two deed books, A and B, were combined to form Book AB. They have been abstracted and published by ONHGS member Mae Blake Graves. New Hanover County was formed in 1729 from Craven. Bladen and **Onslow** Counties were formed from New Hanover in 1734, Duplin County in 1750, Brunswick County in 1764, part of New Hanover was annexed to Sampson County in 1795, and Pender County was formed from New Hanover in 1875. The following abstract of Deed Book C was compiled by Ida Brooks Kellam in 1939. Here begins a new series of early New Hanover County records from Book C.]

Note: This book begins with the 88th page of the original book-- 87 pages which cannot be found.

Page 1. City of Cork, Ireland, June 29, 1742. Before "Right Worshipful Richard Bradshaw, Esqr. Mayor of said City" - in presence of John Long of same place, Notary Public. Henry Linscom of said City, Peruke Maker, and Sarah Sheehy of same, widow, made oath that Henry Linscom is "natural and lawful Son of Thomas Linscom of the town of Bandon in City of Cork, merchant, deceased, and said Henry is the eldest brother now living of John Linscom, Gent. of North Carolina, decd., and James Linscom of Bandon is youngest brother of said John and there is no issue of said Thomas Linscom and Elizabeth his wife, also deceased, except Henry, James and Elizabeth their sister who is supposed to be living in North Carolina. Recorded April, 3, 1744.

Page 2. Sept. 23, 1742- Robert <u>Colley</u> of New Hanover County in the Province of N.C., Planter, to Henry <u>Linscom</u> of City of Cork, in Ireland, Barber, a plantation in New Hanover County on North West side of North West River in fork between Livingston's Creek and Vaugh's Creek. 640 acres granted to William <u>Lord</u> and by said William <u>Lord</u> his wife Margaret (1742) to Robert <u>Colley</u>. Recorded 1744.

Page 4. Elizabeth Colley, wife of Robert Colley, signed the above deed.

Page 4. Jan. 23, 1744. John <u>Cowan</u> of N.C., New Hanover County, to William Routledge of same place, a tract of land on North East branch of Cape Fear River on Maple Branch, 640 acres. Wit: Pat <u>Donald</u>, Will <u>Hedges</u>.

Page 5. March 7, 1743. Gabriel Wayne to James <u>Oram</u> of same place, a lot on Front Street "bounded on South by John <u>Squires</u>, on North side by <u>Wayne</u>."
Wit: Will Hedges, Alex'r <u>Edwards</u>.

Page 6. Mar 7, 1743. Peter Cliffs of New Hanover County, Sail Maker, to Alex'r Edwards of Wilmington, N.C. Chair Maker, lot in Wilmington on Red Cross and Front Streets. Wit: James Oram, Gabriel Wayne.

Page 7. June 28, 1743. John <u>Porter</u> of New Hanover County, merchant, to George **Minot**, "late of Boston in Province of Massachusetts Bay,, merchant," a plantation in New Hanover County about four miles above Rocky Point, "land whereon John Arthur formerly dwelt, 640 acres. Wit: Sam'l <u>Swann</u>, John <u>Swann</u>, Thomas **Jones**.

Page 9. Dec. 24, 1743. Anthony <u>Debose</u> of Wilmington in New Hanover County, to William <u>Perry</u> of same place, lot on Front Street, joining Thomas <u>Hedges</u> and Joshua Grainger. Wit: James <u>Brown</u>, James <u>Smallwood</u>.

Page 10. Jan. 3, 1743. Anthony <u>Debose</u> and Rebecca his wife, to William Perry, a lot in Wilmington. Signed: Antoine Debose Rebecca <u>Debose</u>. Wit: Will <u>Hedges</u>, Jonathan Chase.

Page 11. Feb. 17, 1743. Antoine <u>Debose</u> of **Wilmington** to William Perry, a lot in Wilmington. Wit: James <u>Smallman</u> and Charlotte <u>Smallman</u>.

Page 12. Dec. 17, 1743. New Hanover County, John <u>Bone</u> to James <u>Marr</u>, both of Bladen County, NC, Planters, lot on Middle Street in Wilmington, on South side of Red Cross Street. Wit: James <u>Smallwood</u>, John <u>Goodale</u>.

Page 12. Aug. 23, 1743. James \underline{Marr} of Bladen County, NC, Planter to Antoine \underline{Dubose} of Wilmington, NC, lot in same on Middle Street and "also deed from John Watson to James Long."

Page 13. Will of John Watson. "In the name of God Amen, I, John Watson of the Sound in North Carolina, Planter, being in Low State of body but in sound and perfect mind and memory, praise be given to Almighty God, do make and ordain this to be my last Will and Testament in manner and form following: Imprimis-- I will that my debts and funeral be paid and discharged.

I give to my son John this part of my plantation Bolony Swamp, to the head, to Dirty Branch, taking in the Old Plantation.

I give to my sons Joseph and Jonathan all the rest of the Plantation to be equally divided and not to hinder John taking back of their land at any time.

I give to my son Job two cows and one likely young horse if he comes to Cape Fear.


I give all the rest of my personal estate to be equally divided between my sons John, Joseph and $\dot{Johathan}$ and my daughter Sarah at the time of my son Jonathan coming of age.

I will and appoint my wife Sarah Watson and my son John Watson, Executor and Executrix of this my last Will and Testament... In Witness whereof I have set my hand and seal this third day of January in the Year of our Lord One Thousand Seven Hundred and Forty Three. Signed: John Watson (seal) (Proved March Term of Court, 1744)

Witnesses: Arch. Nickolls, Joseph Jones. Frank Yeal.

Page 16. Will of William White. "In the name of God Amen, I William White of New Hanover County in the Province of North Carolina, Millwright,...

I give and bequeath to my son William **one** Negro. Whatsoever slaves I have I leave to my loving wife Marg't <u>White</u>. "My will is that as soon as what Estate I have can be disposed of my loving wife Marg't <u>White</u> shall move herself and family to the **Norwood** into any of his Majesties Plantations that she shall think proper." Executors: Marg't <u>White</u> and William <u>Faris</u>. In witness whereof I have hereinto set my hand and seal the twenty sixth day of December, 1743. William <u>White</u>(seal) Proved March Term of Court, 1744.

Page 18. May 2, 1744. William <u>Lithgow</u>, merchant of Wilmington and Mary his wife, to Charles <u>Harrison</u> of same place, Planter, lot on Dock Street in Wilmington joining Richard <u>Hilliers</u> on Second Street. Wit: Dan'l Dunbibin, Thos. *James*, Richard Hilliers.

Page 19. John Marsden "late of Halifax in County of York, Cloath Dresser, the only surviving son of Richard Marsden, formerly of Horhsay in County of York, late of Cape Fear in North Carolina by Elizabeth his wife" to "my sister, Margaret Haynes of Cape Fear" 640 acres on Prince George's Creek, being the Plantation whereon Richard Marsden, deceased, did live and known as the Hermitage, said land described in a deed from Col. Maurice Moore" to "my brother Thomas Marsden." Also 500 acres joining aforementioned land, being one-half of Patent of 1000 acres, dated Feb. 12, 1735, to "my father Richard Marsden, Deed." Also land of "my brother William Marsden." All lands coming into possession of said John Marsden by deaths of his brothers Thomas and William Marsden, late of Cape Fear or by death of my "mother Elizabeth Marsden." Jan. 8, 1743. Page 20. Grace <u>Mitchell</u>, Executrix of the Last Will and Testament of Edward <u>Mitchell</u>, decd., to John <u>Smith</u> of New Hanover County, Carpenter, a lot in Wilmington on South side of Orange Street, Jun. 13, 1744. Wit: John Maultsby, Jr., James Owram.

Page 20. Will of William McFarland. I, William McFarland, Blacksmith,... ordain this my last Will and Testament. Daniel McCauslen, Daniel McRickan, Francis Veale, Executors to receive 20 lbs. currency. To Father all my estate. William McFarland (seal) Wit: Will Wiggins, Morgan Morgan, Alex'r McRickan. Proved June Term of Court, 1744.
