**ONHGS TREASURER'S REPORT**

The financial status of the Old New Hanover Genealogical Society is in good shape. Our income for the year was \$212.59 over our expenses. We budgeted \$3,120.00 for membership dues and received \$4,190.00 in dues. We budgeted \$6,999.96 for income from the sale of books. but received \$4,805.85 with an additional amount of \$566.70 outstanding in charge orders from various libraries. With the decrease in our book sales we had a corresponding decrease in our expenses for publishing and shipping book orders.

We took \$3,000.00 from our checking account and put it into a savings account which brought \$51.86 in interest income. The Society purchased books for the North Carolina Room at the library for an amount of \$1,573.84. These reference books are for the use of the Society members as well as the general public.

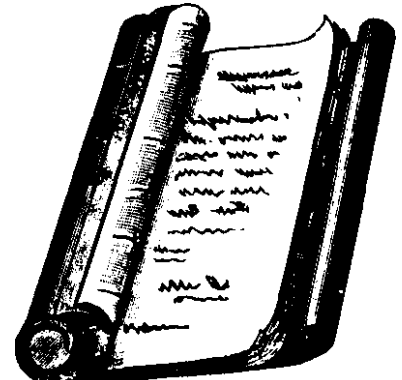

**NEW HANOVER COUNTY COURT OF PLEAS & QUARTER SESSIONS**

[This series submitted by Helen Moore Sammons continues from the March 1994 Courier. The New Hanover County Court Minutes prior to 1800 were abstracted many years ago by Alexander Walker. They are in four volumes and can be purchased from ONHGS. We have previously printed that a courthouse fire destroyed the minutes from 1800 to 1805, but it has come to our attention that they do exist on microfilm out of sequence. Mrs. Sammons began her series in 1805. Spelling was recorded as seen and a \_\_\_ is given when the abstractor found the minutes impossible to read.]

Saturday, 12 April, 1806

Court met according to adjournment.

Present the Worshipful: Samuel Ashe, William Giles, Henry Watters.

A deed from the trustees of the University to Margaret Campbell acknowledged in open court and ordered to be registered.

Ordered that a tax of one shilling on every poll and one shilling on every 300 acres of land be paid for the purpose of repairing the Court House and making the same fire proof.

A. McLan vs J. Garnier - Motion for a new trial argued and motion over-ruled. Appeal prayed and granted, giving R. Mitchell secy.

A deed from Thomas Snead to John Costin by Henry Lutterlow and ordered to be registered.

A deed from John and Richard Bradley to Thos. Hunter proved by A. Hostler and ordered to be registered.

Ordered that the sheriff pay to the representatives of John Sullivan the amt of negro hire due for the hire of Jack, hired under a former order of court.

State of North Carolina. At a court of Pleas and Quarter Sessions **began** and held for the county of New Hanover at the Court House in Wilmington on Monday, the 7th day of July A.D., 1806 and in the 31st year of Independence.

Present the Worshipful: Robert Nixon, Samuel Ash, William Giles.

John Taylor. Daniel Bordeaux. James Moore, David Jones and Samuel Herring appointed commissioners who or any three of them are ordered to run the diving line between the land apportioned to Samuel Bludworth, one of the legatees of James Bludworth, dec'd, and the minor legatees of the said James and to divide the said land and make return to next court. Timothy F. Bludworth, the guardian to the said minors being present and nominating two of the said commissioners.

Allen Shaw excused from the fine imposed upon him for non-attendance at last December term as a juror.

Grand Jury drawn and sworn, Owen Kenan, foreman.

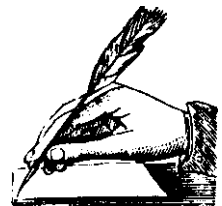

Court met according to adjournment.

Present the Worshipful: Robert Nixon, Richard Nixon, David Jones

Anthony D. Bordeaux came into court and exhibited a commission from his Excellency the Governor of the State, nominating and appointing him a Justice of the Peace for the county of New Hanover and qualified agreeable to the tenor of the same by taking the oath required by law.

Ordered that John Harper, admr. of Joel Parrish, have leave to sell as much of the perishable property of his intestate as will pay himself the sum of 65 lb. 17.

William Sharpless, Sweeting and Timothy Bludworth appointed to audit the accts. of the admr. of Samuel Larkins, dec'd and make returns.

John Beard's admr. vs Robert Anderson - Jury impanelled -

Arch. Cowan, Edward Hansley, F. Gause, Straton Burton. Thos. Robeson, John Barrett. John Atkinson, H. B. Howard, Wm. Wilkinson, David Turnan, Hinton James, and Thos. Howe and find the debt did assume &c and assess pliffs damages 18 lb 5 and costs.

Robert Nixon and Richard Nixon appointed to audit the accounts of the county Treasurer and to burn such certificates as he has in his possession.

Ordered that the election for sheriff of this county take place this evening at half after three o'clock.

Knight vs Nobles- Same jury and find &c and assess pliffs damages 11 lb "0"7 and costs.

Mott vs Excrs of Toomer- Same jury and find &c and assess pliff's damages 25 lb. and costs.

Upon the petition of Richard Quince, permission granted him to emancipate and set free from slavery a negro fellow by the name of Roger, at present the property of the said petitioner and that the said negro slave be hereafter known by the name of Roger Hazel, the said Richard Quince giving bond &c with William Campbell, sec'y.

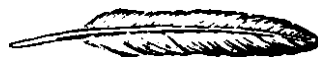
A deed from Mary Hooper to Robert Nixon proved by J. G. Wright, subscribing witness thereto and ordered to be registered.

Wm. Kiddie vs A. D. Moore-plea in abatement. Filed demurrer & rejoinder. Plea over-ruled and demurrer allowed. Appeal prayed and granted, giving bond with A. D. DeRosset and J. G. Wright as securities.

Upon motion to the court whether Hinton James, Michael Shurlock, Samuel Haws and Allan Shaw should be admitted to qualify as Justices of the Peace. they having lost their commission. Ordered that they be permitted to qualify. Robert Nixon and David Jones, Jr. dissented from this opinion.

Samuel Haws and Michael Shurlock came into court and qualified as Justices of the Peace agreeable to law.

Court adjourned till 3 o'clock this evening.



Court met according to adjournment.

Present the Worshipful: William Giles, Henry Watters, David Jones. Jr.

Ordered that Aaron, a negro fellow, the property of Sophia Ashe, be allowed to carry a gun upon the lands of his said mistress. Roger Moore and Thos. F. Davis giving bond &c.

At an election held to elect a sheriff of New Hanover County, there being present the following justices (to wit) Samuel Ashe, David Jones. Jr., Richard Nixon, Robert Nixon, James Foy, Henry Watters. John Cowan, H. Kelly, William Cutlar, A. D. Bordeaux, Michael Shurlock, Samuel Haws, David Jones, Sr., J.M. Gabie, Peter Maxwell, Thomas Bishop, William Giles, Timothy Bludworth, when upon an open and fair balloting, William Nutt was elected by a majority of four votes, there being two candidates.

Almond Hall unanimously elected county treasurer.

James Foy, Edward St. George, and Richard Nixon appointed to divide the real estate of Thomas Picket, dec'd, between John Picket, Hosea Picket, and Jacob Picket.

Motion for a rule on William Jones to show cause on the Joel Parrish, should not be rescinded.

Ordered that William Nutt and Almond Hall come into court tomorrow at 11 o'clock and offer their securities and execute bond agreeable to law.

A deed from William Campbell to John Wayne proved by R. Hasley and ordered to be registered.

Court adjourned to 10 o'clock tomorrow.

Wednesday. 9th July, 1806.

Court met according to adjournment.

Present the Worshipful: Robert Nixon, Samuel Ashe, William Giles, Henry Watters.

David Jones and James Foy appointed to audit the accounts of the admr. of P. Sill and also to audit the accounts of P. Sill as guardian to Oswald Sill's children.

Ward vs Admr. Green- Jury impanelled: John Larkins, John Williams, Arch. Cowan, Chas. Gause, Neh. Harriss, Straton Burton, Jno. Wilkins, Thos. Howe, Jno. Atkinson, Ed. St. George, H.B. Howard, David Turnan. Mistrial. Grand Jury discharged.

Upon the petition of Henry Young and Eliza, his wife, ordered that they have permission to emancipate and set free from slavery a certain female slave by the name of Rose and that the said Rose hereafter bear the name of Rose Toomer, giving bond. &c.

Hoskins vs Bludworth. Same jury and find th debt did assume &c and assess plff's damages 28 lb and costs. Motion for a rule on plff. to show cause whv a new trial should not be granted.

The account sales of the estate of John Henderson rendered to court and ordered to be filed.

The last Will & Testament of Simon Malpass exhibited in court and proved by Nath. Gufford, one of the subscribing witnesses thereto and ordered to be registered.

A deed of mortgage from William Jones to James Henry proved by Dugald McFee, subscribing witness thereto and ordered to be registered.

A deed from William Nutt to Charity Jennings acknowledged in open court and ordered to be registered.

Court adjourned to 4 o'clock this evening.

Court met according to adjournment.

Present the Worshipful: William Giles, James Foy, A.D. Bordeaux.

George Nobles vs Evans- Same jury and find the deft. did assume and assess plff's damages 54"5 & costs- 6 months stay.

Walker vs Mallett & Bradley- Same jury and find the writing &c that the value of the penalty is 576 lb., conditions 228 lb. and assess damages at 60 and costs- 3 months stay.

Same vs Same- Same jury and find the writing &c, that the value of the principal is 1500 lb. and the conditions 435 lb. 4"8 & damages 60 and costs.

Watters vs Stanley & Bludworth- Same jury & find &c and assess plff's damages 23 lb & costs, subject to other payments.

Admr. A. Jocelyn vs William Cutler- Same jury and find the writing &c and find the value of the penalty 503 lb 11"8 and the condition 251 lb 15"10 and assess 60 damages and costs.

Located at 109 East Jones Street in Raleigh, NC, this library is unrivaled when it comes to genealogical resources. Located in the same building which houses the State Library of North Carolina (not to be confused with NC State University Library) and the NC State Archives, it is a must for any North Carolina researcher.

The Genealogical Services Branch maintains an extensive reference collection of published materials. These include family histories, census records and indexes, abstracts or transcriptions of state and county records, cemetery records, extracts from newspapers, published rosters of soldiers, lists of pensioners, bibliographies, indexes, and general reference works on genealogy.

This branch also has a large collection of materials on the colonial period in North Carolina and the other original colonies as well as information on the area from which North Carolinians came and to which they migrated.

In addition to published materials, the collection includes microfilm of surviving census records, 1800-1890, for the entire United States, together with many of their published indexes. Also included is the 1900 and 1910 census microfilm for Georgia, South Carolina, Tennessee, and Virginia, as well as North Carolina and **Soundex** indexes (North Carolina only) on microfilm for 1880, 1900, 1910 and 1920.

Books and periodicals are not available for loan. Microfilm of currently available North Carolina censuses and a collection of county records (usually prior to 1868) may be borrowed by libraries. The county records include court minutes, deeds, marriages, tax lists and wills.

Researchers may write to the Genealogical Services Branch (Genealogy Branch, State Library of North Carolina, 109 E. Jones St., Raleigh, NC 27601) to request copies of specific pages from a book or periodical. Staff will search indexed published abstracts of one county for one name if an approximate **year(s)** is given. A maximum of 20 photocopies (**\$.20** per page) may be sent. A \$1.00 minimum charge is made for all mail requests. The researcher is billed for the exact amount. Do not prepay.

You can also write and ask for Tar Heel Tracks which describes the collection and services offered and an information sheet, Getting Started In Genealogy. All books given to the North Carolina Genealogical **Society** for review in their Journal are donated to the Genealogical Services Branch.

The Genealogical Services Branch has a staff of four including two librarians with more than thirty years experience in genealogical research. Housed on the mezzanine, the branch is open Monday through Friday from 8am - **5:30pm** and on Saturday **9am - 12noon** and 1 to 5pm.

Coming soon to the local history and genealogy room will be 30 compact disks containing 200 million plus records for genealogists. Records which have heretofore only been available at the Church of Jesus Christ of Latter-day Saints, are now available to libraries. A major contribution to the library by ONHGS member, **Tibitha McEachern**, will allow the library to buy, Ancestral File, International Genealogical Index, Family History Catalog, and U.S. Social Security Death Index and Military Index. The computer hardware will allow the library to buy more compact disks in the future. The system should be in place by early September.

**NAMING CUSTOMS IN SCOTLAND**

[The following article was taken from the Australian Tulach Ard and was written by Ted Finn. Forty thousand Scots came to America through the Cape Fear prior to the Revolution.]

Scotland being a country appreciative of its traditions, had a highly **developed** system of naming children. The general custom to which there were some variations, was to name children as follows:

The eldest son after the paternal grandfather.

The second son after the maternal grandfather.

The third son after the father.

The eldest daughter after the maternal grandmother.

The second daughter after the paternal grandmother.

The third daughter after the mother.

Younger children would be named after earlier forbears but, the pattern in their case was less settled.

One variation from the above was for the eldest son to be named after the mother's father, and the eldest daughter to be named after the father's mother. In this case the second son would be named after the father's father, and the second daughter after the mother's mother. Occasionally the second son and daughter would be named after the father and mother instead of the third son and daughter. Another variation was to call the third daughter after one of the great-grandmothers instead of after the mother. In such a case, the fourth daughter would be called after the mother.

In considering the name pattern it must be remembered that certain Christian names had different forms. The Gaelic **Hamis**, for instance, is the equivalent of James, Ian or Iain are Scottish forms of the Latin Johannes which is the English John. Elspeth, with its diminutive Elspie, Isobel and Isabel are forms of Elizabeth. Daniel is the equivalent of Donald.

Before the middle of the 18th century it was very rare to find more than one Christian name, but after that time the gradual introduction of a second Christian name naturally affected the same pattern. Dr. **Maitland** Thomson gives some interesting information on the matter of multiple Christian names. In the year 1760 in Edinburg, he found that only about 1 percent of children baptized had two Christian names. By 1790 this had risen to 7 percent and by 1820 it was nearly 25 per cent.

More than one Christian name for working-class families is very seldom found until the 19th century and even then it is rare to get more than two names. In the upper and professional classes, however, more than one Christian name begins to be more general from the beginning of the 19th century.

The second Christian name was sometimes the name of a godfather or godmother or some patron. The developing custom of giving more than one Christian name brought with it, the custom of including a surname from the mother's side of the family.

Thus a second son, instead of being named after the Christian name of the mother's father, was sometimes given both the Christian and surname.

The custom applied also to the eldest daughter of families. An unusual Christian name (as Teckla) can be a very valuable clue, some unusual Christian names have in fact become almost hereditary in certain families.

Civil registration began in Scotland later than in England and it was not until 1855 that Scottish law required it, however, its late start is its only disadvantage for registration itself in the details which it gives is far superior to that in England and Wales and to most registrations elsewhere.

In 1855 registration was the finest of all years, the amount of information it gives in all certificates is quite astonishing. Unfortunately, it was decided that the difficulties of obtaining, in every case, this very full information made it impracticable; the details required were reduced in 1856, and these were slightly modified and improved upon in 1861.



[The following tax list was submitted by Bill Reaves, who notes. "long before the famous Battle of Moore's Creek Bridge, the first battle of the American Revolution in North Carolina, February 27. 1776, the creek with its' bridge was known as Widow Moore's Creek. Wm. S. Powell in his popular NORTH CAROLINA GAZETTEER says: "probably named for the Widow **Eliz.** Moore, who owned land adjacent as early as 1735". I believe we can now offer a new candidate who is mentioned in the "List of Taxables for the County of New Hanover.. September Court, 1767". In this list is "Widow Margaret Moore" with two slaves, one male and one female. Of the 514 white taxables, she is the only one to have the designation of "Widow" affixed to her name as part of her official name. Have we finally found the illusive lady who unknowingly contributed her name to one of the most important events in the history of our State?"]

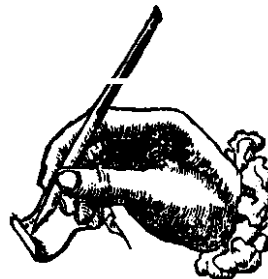

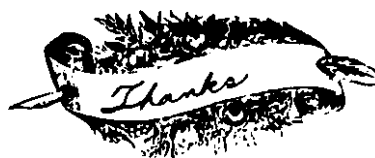

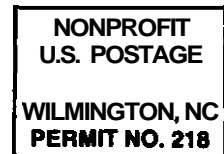
