President's Message

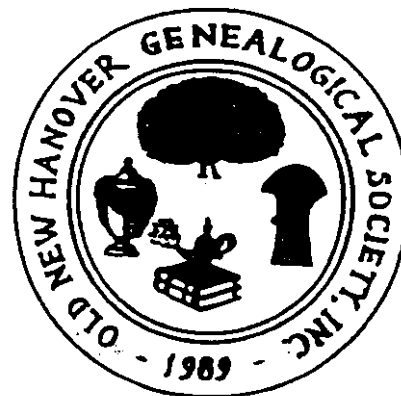

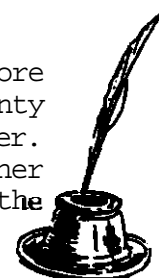

NEW HANOVER COUNTY COURT OF PLEAS & QUARTER SESSIONS

[This series of New Hanover County Court Minutes, submitted by Helen Moore Sammons, is continued from the Spring 1995 Courier. The New Hanover County Court Minutes prior to 1800 were abstracted many years ago by Alexander Walker. They are in four volumes and can be purchased from ONHGS. Mrs Sammons began her series in 1805. Spelling was recorded as seen and a _____ is given when the abstractor found the minutes impossible to read.]



STATE OF NORTH CAROLINA

At a court of Pleas & Quarter Sessions began and held for the county of New Hanover at the Court House in **Wilmington** on **Monday**, the 18th day of Hay AD, 1807 and in the 31st year of Independence.

The court was opened with the usual proclamations.

Present the Worshipful: D. Jones, Senr., Sam'l Ashe, B. Sutton.

Ordered that the election of Sheriff take place tomorrow evening at 4 o'clock.

A deed from John Sellers and Mary Sellers to August Sellers proved by George Bannerman and ordered to be registered.

A Bill of Sale from James Bruff to Sarah Potts proved by Robert Brown and ordered to be registered.

Ordered that an Execution issue to the Sheriff to sell a piece of land, 100 acres, levied upon by Jesse Collins, Constable, under an execution from a justice of the peace, "Thos. Murray vs Benj. Evans".

A Bill of Sale from Joel Henry to Anna Henry; another from the same to Robert Henry; and another from the same to Joseph Henry proved by John H. Swoop (?) and ordered to be registered. Court adjourned till 3 o'clock this evening. Court met according to adjournment.

Present the Worshipful: D. Jones, Senr., Wm. Giles, Sam'l Ashe, B. Sutton.

Ordered that notice issue to all guardians who have failed to settle their accounts to appear at the next court and render their accounts as such, and that all guardians who have been appointed within twelve months render the schedule of the property of their wards to the next court.

James Bland and John Walker excused from the fine imposed upon them for non-attendance at last term as jurors and also excused from attending at this term.

M.R. Wilkins vs George Duncan (Or. Attachment) - James H. Drahorn who was summoned as garnishee to appear this term, appeared and declared that McGill Drahorn was indebted to the debt in this cause at the time of issuing this attachment to the amount of \$172.94 equal to 86 lb. 9["]4 due by open account and that the same became due 10th April, 1807 and that this notice as garnishee in this cause was served upon him before any other.

Wm. H. Rhodes vs George Duncan (Or. Attachment) - Richard Lloyd who was summoned as garnishee to appear at this term appeared and declared that Lloyd & Anderson was indebted to the debt in this cause at the time of issuing this attachment to the amount \$2728.26, equal to 1364 lb. 2["]6 and that the same became due the 11th day of April 1807 and that the notice as garnishee in this cause was served upon him before any other.

Charles Jones also appeared as garnishee in this cause and declared that he was indebted to the debt in this cause at the time of issuing the attachment to the amount of \$282.29. equal to 141 lb. 2["]9 by open account, that the same became due on the 5th day of April 1807 and that the notice as garnishee in this

cause was served upon him before any other.

A Bill of Sale from John Harriss to William Collins proved by R. Harley, subscribing witness thereto and ordered to be registered.

A Bill of Sale from Wm. Buxton to Thomas Cowan, a Bill of Sale from Samuel Barlow to David Turnan, a deed from Hanson Kelly, all proved by R. Harley, and ordered to be registered.

A Bill of Sale from William Nutt, Sheriff to John Barclay acknowledged in open court and ordered to be registered.

A deed from William Nutt, Sheriff, to Thos. Cowan proved by C. Dudley. Jr.. subscribing witness thereto and ordered to be registered.

Court adjourned till 1/2 past 9 o'clock tomorrow Tuesday. **19 May 1807.**

Court met according to adjournment.

Present the Worshipful: Samuel Ashe, John Hill, B. Sutton.

Mary Erwin came into court and made choice of James Bunting as her guardian, giving bond in 500 lb. with Sam'l Bunting and Edward St. George as secys.

The last Will & Testament of William Larkins exhibited in court and proved by Thomas Bludworth, Sr. one of the subscribing witnesses thereto and ordered to be registered and the excrs. therein named renounce their right of executorship.

Admn cum testamento *annex* on the estate of William Larkins granted to Thomas and Robert Larkins giving bond in 3000 lb. with James Larkins and William Larkins, Jr. as secys.

James Larkins, Robert Larkins and Timothy Bludworth appointed to audit the accts of John Taylor, guardian of Daniel Taylor.

Admn on the estate of Samuel Mabson granted to Samuel Mabson, Jr. giving bond of 8000 lbs. with ___ (blank)

Upon the petition of Philip Bazadier ordered that a mulatto woman named Susan be emancipated and set free from slavery and that she hereafter bear the name Susan Bazadier.

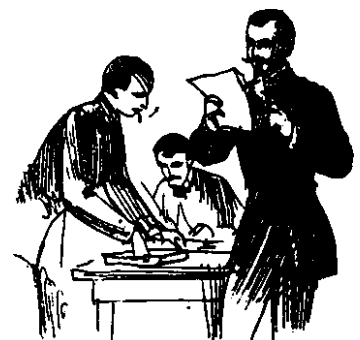

At an election for a Sheriff of this county for the ensuing year, there being present the following Justices, to wit: Wm. Giles, Thos. Bishop, Sam'l Bludworth, B. Sutton, Jno. Hill, H. Watters, D. Jones, Senr., P. Maxwell, D. Jones, Jr., Jno. Swann, James Foy, J.M. Gabie, H. James, Sam'l Haws, Wm. Jones, when upon an open and fair balloting, William Nutt was unanimously elected. William Nutt came into court and offered as his securities Joshua G. Wright and Wm. Campbell.

A deed from C. Walker to William Giles proved by Joshua G. Wright, subscribing witness thereto and ordered to be registered.

A deed from John F. Burgwyn to Duncan McLaurin proved by William Giles and ordered to be registered.

A deed from B. Smith to R. Mitchel proved by S.H. Sibley and ordered to be registered.

Court adjourned till 9' o'clock tomorrow.

Wednesday. 20th May 1807

Court met according to adjournment.

Present the Worshipful: P. Maxwell, S. Ashe, H. Watters. A Bill of Sale from Wm. Nutt. Sheriff, to John Lord was acknowledged in open court and an assignment of the same by John Lord to Ann Cutler proved by N. Hill and ordered to be registered.

The court after mature deliberation gave the following continuation to an Act of Assembly passed in the year 1782 granting to Caleb Grainger the privilege of erecting a toll bridge over Smith's Creek and receiving the toll therefrom viz: That the franchise aforesaid continued for the space of twenty seven years from the period of the original grant and therefore decree that the term created by the said Act of Assembly is now unexpired.

Elizabeth Morgan appointed guardian to Ann Eliza Morgan giving bond in 100 lb. with O. Kenan and R. Eagles as secys.

J. McCanne vs R. Williams- Jury impanelled: Joel Parish. H. B. Howard, Arch. Harper, Wm. Betts, Henry Taylor, Thos. Hunter, Thomas Jennings, Jno.

A Bill of Sale from William Nutt, Sheriff, to Thomas Jennings acknowledged in open court and ordered to be registered.

Ordered that the executions issue to the Sheriff to sell 200 acres of land levied upon by James Jennett, constable, in two causes "Wm. King vs James Towning."

Ordered that the Clerk issue a a warrant to the surveyor of this county upon an entry made in the name of Wm. Jones, dated the 18th July, 1785, No. 457. He the said William having made proof of the purchase survey and fees having been paid.

Issac Atkinson, a native of Scarborough in Great Britain appeared in open court and prayed that he might be admitted to rights of citizenship and naturalized according to the laws of the United States; and it being proved that the said Issac is a person of good moral character and well affected to the Constitution of the United States and he having in open court taken an oath to support the same and having also on oath abjured forever all allegiance and fidelity to all foreign governments &c, particularly to the **government** of Great Britain of which he was formerly a subject, he is therefore admitted according to the rights of citizenship and naturalized according to the Act of Congress in such case made and provided.

A Power of Attorney from Gillam Bass and others to Joshua Potts exhibited in court under the seal of the State of New York and ordered to be registered.

Court adjourned til 3 o'clock this evening.

Court met according to adjournment.

Ordered that the Sheriff do pay out of the county tax the amount of Joseph Jacobs' bill against said county for the repairs to the jail, \$10.67.

Wm. Wilkinson vs Robert Williams-- Same jury and find &c and assess plff's damages 41 lb. 8 and costs.

Hotchkiss, Townsend & Co. vs Peter Ponds-- Same jury and find &c and assess plff's damages 137 lb. 0"2 and costs.

H. Sibley vs same-- Same jury and find &c and assess plff's damages 182 lb. 3" 7 and costs.

The guardian accounts of Ann, Elizabeth, George, and Mary Jennings rendered to court and ordered to be filed.

Court adjourned til 10 o'clock tomorrow.

A deed from Allen Backhouse to Dublin Lee acknowledged in open court and ordered to be registered.

The inventory and account sales of the Estate of Sam's Mason rendered to court and ordered to be filed.

Ordered that notice issue to William Morris to show cause why he should not be removed as guardian and master of W. Hines and that Alex. Hines take said W. Hines into his safe-keeping.

Ordered that Anthony Williamson be appointed guardian of Major Armwood, an orphan, in room of Bartholomew Byrns, who surrenders said orphan to the court, giving bond with John Walker, and Joel Parrish as securities.

R. Langdon fined 20 p as defaulting talisman.

G. Gibbs vs Thos. Howard-- Jury impanelled Joel Parish, Jno. Larkins, Jere Nichols, Thos. Hill, C. Dudley, Sr., Jas. Allen, A.F. McNiell, G. Geer, C. Dudley, Jr., Hy Taylor, Thos. Robeson, and Jno. Blanks and find &c and assess the plff's damages 309 lb 12/1 and costs.

Present the Worshipful: S. Bludworth, Jno. Hill, Jno. M. Gabie.

Jno. M. Gabie, Esq., appointed to take the affidavit of Mary Gabie relative to the execution of a Bill of Sale from Wm Scarborough to Mary Hostler Bernard.

B. Blaney & E. Evans vs John Martin-- Ordered and decreed that John Martin, the debt, pay to B. Blaney the sum of 439 lb. 3"5 and costs.

Ordered that London, a negro fellow of Major John Walker have leave to carry a gun within his master's enclosure at Rocky Point.

Ordered that the county trustee do pay Major Walker's account as Coroner for 17 lb 1¹¹.

J. Bradley vs Jno. Walker-- Motion for appeal granted, giving R. Bradley as secy.

Ordered that Wm. Nutt, Sheriff, be allowed the sum of 25 lb. for his extra services for the last year ending this term.

Ordered that Henry Wright be allowed the sum of 6 lb. annually for taking care of the Court House.

G. Gibbs vs G. Duncan-- Ordered that the garnishment filed amounting to 471 lb. 11.3 be condemned to answer the judgement of the plff.

P. Maxwell and John M. Gabie appointed to audit the accounts of the guardian of G.B. Burgwyn.

Thos. F. Davis, Clerk of this Court, allowed the sum of 25 lb. for this last year's services.

Thomas Hunter, a native of Scotland in Great Britain, appeared in open court and prayed that he might be admitted to the rights of citizenship and naturalized according to the laws of the United States and it being proved to the said court that the said Thomas is a person of good moral character and well affected to the Constitution of the United States and he having also on oath abjured forever all allegiance and fidelity to all foreign government &c and particularly the government of Great Britain of which he was formerly a subject, he is therefore accordingly admitted to the rights of citizenship and naturalized according to the Act of Congress in such case made and provided.

Court adjourned til 3 o'clock this evening.

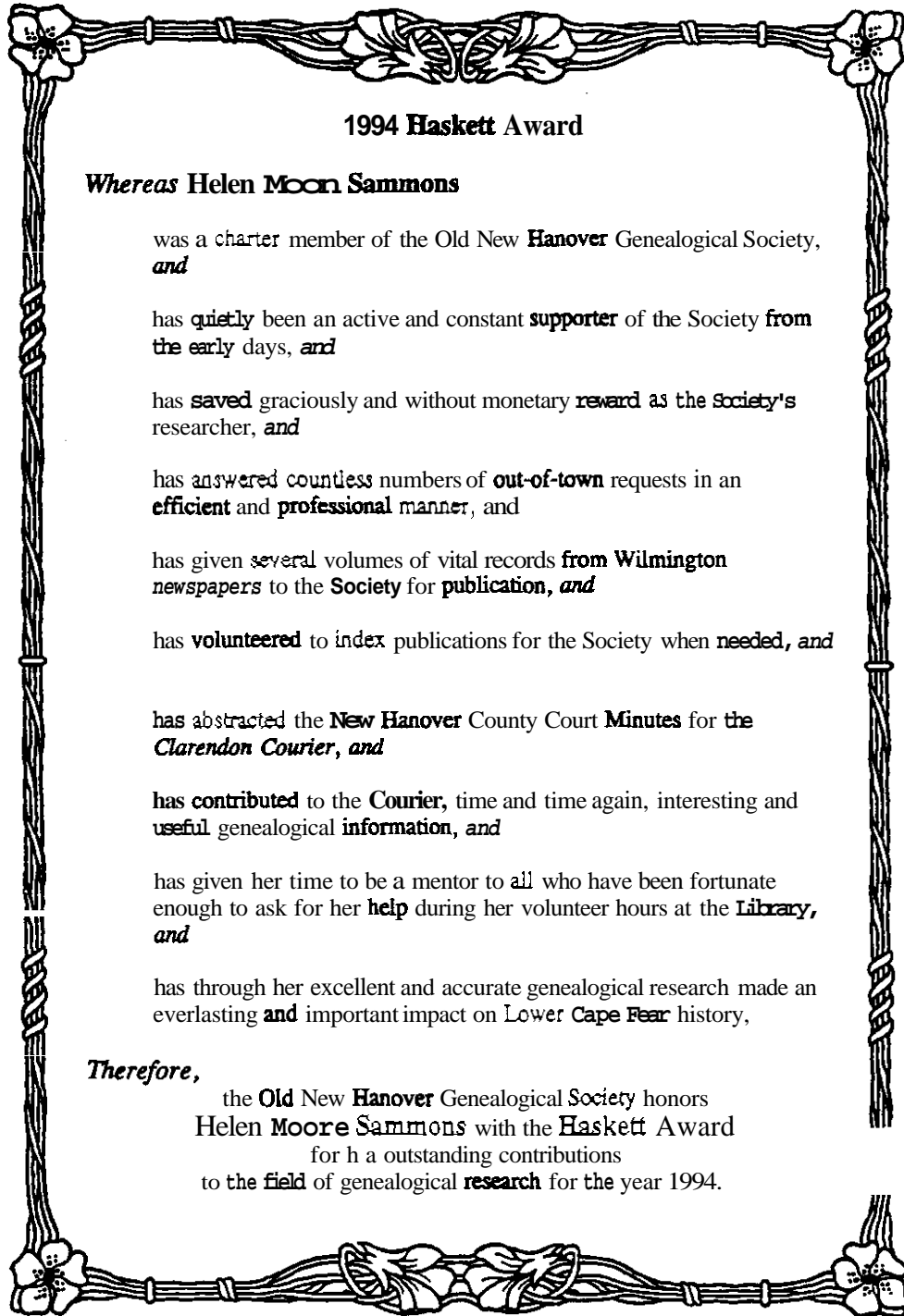

Dear Editor:

In a recent issue you listed some Wilmingtonians who had departed for California in January 1850. I can identify three of these. Ezra Reed Wood and Daniel Wells Wood, brothers, and their brother-in-law, George Ferguson, who had married their sister. These Woods were children of Hettie Wells (Fanning) Wood, a widow, who had moved down from Nantucket in 1840 to join her sister, Caroline (Fanning) Wood, and her brother Phineas Fanning. These Wood children were double first cousins of R.B. and J.C. Wood [who remained in Wilmington].

I have found them in the California gold field counties of the 1850 Census, so we know they survived the trip safely. I intend to follow them in California when time permits. I hope they made big strikes!

I continue to enjoy the Clarendon Courier. It is excellent, and always contains some items that are of particular interest to me as a "descendant" of old Wilmington.

You may request a copy of a family file by writing to Local History Room, New Hanover Public Library, 201 Chestnut Street, Wilmington, NC 28401. Send a self-addressed-stamped envelope and the library staff will advise you as to the number of pages and costs per file.

We have cornered the computer whiz Gerry McKensie into volunteering in the Local History Room. Gerry, a popular speaker at our genealogy fair and workshop in May, will be glad to give you a few pointers on the LDS Family Search and IGI computer files in the Library. Just give us a call, 341-4394, and we will hook you up with Gerry. We appreciate his time and devotion to genealogy.

The latest library additions, thanks to the sale of our publications, include Abstracts of Revolutionary War Pension Files, (4 vol., 5,265 pages); Coharie to Cape Fear. The Descendants of John Williams and Katharine Galbreth of Sampson and Cumberland Counties, (3 vol.); Early Carolina Lays, Main Lines, Spur Lines & Zig-Zags.

Treasurers Report

During the past year from June 1994 to May 1995 ONHGS has continued to receive income from Membership Dues and from the sale of books to adequately cover our expenses and still contribute to the North Carolina Room and other Genealogical and Historical Societies. We purchased books for the N.C. Room in the amount of \$1,634.46 and the Board of Directors has authorized the purchase of additional books in the amount of \$687.83. 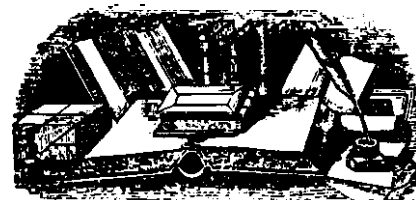

A Glossary of Legal Terminology

[The following glossary covers some of the legal terminology used in early records, ie. court minutes, wills, and deeds. The definitions of the following legal terms were taken from the American Association of State & Local history's Technical Leaflet 1\55. It was compiled by Judge Shelby Myric of Savannah Georgia, for the 1969 World Conference on Records, sponsored by the Genealogical Society of the Church of Latter-Day Saints, Inc., holders of the original copyright. Continued from the SPRING 1995 Courier.]

Letters C. T. A. - Letters of Administration "cum testamento **annexo**", or "with the will attached." Used where a person has left a will but no executor is named therein or the one named was incapable or refused to serve as executor.

Letters of Guardianship - The instrument by which a guardian is authorized by the Court of Ordinary to manage the person or property of a minor or incompetent.

Letters Testamentary - The authentic evidence that the will has been proven, and that permission has been granted to the executor, by the court having jurisdiction, to exercise the powers conferred by the testator in his will.

Levitical Degrees - Degrees of kindred within which persons are prohibited to marry.

Liberum Animum Testandi - Free will in bequeathing.

Lineal - In a direct line of descent.

Maritagium - Marriage.

Mesne Profits - Value of use and occupation of land during period of defendant's wrongful possession; measured in terms of rents and profits.

Militia District - Divisions of counties containing at least 100 males over 21 years of age, liable for militia duty.

Minor - Child under twenty-one years.

Misnomer - Mistake in name; giving incorrect name to a person in a pleading, deed, or other instrument.

Mortis Causa - In view of death.

Muller - Woman or wife.

Muniment of Title - General expression having reference to deeds and other written evidence of title, but including all means of evidence of title, by which an owner may establish or defend title to property.

Next of Kin -- Nearest blood relations.

Non Compos - Not of sound mind.

Nul Tiel Record - No such record.

Nuncupative Will - An oral will declared or dictated by the testator in his last sickness before a sufficient number of witnesses, and afterwards reduced to writing.

Ordinary - An ecclesiastical judge in former times; now a Probate judge.

Pari Passu - In equal degree.

Partition - Division of property.

Perpetuity - Endless duration.

Posthumous Child - Born after the death of one parent.

Prescription - Right by long possession.

Prima Facie - Evidence sufficient in law to raise a presumption of fact or establish the fact in question unless rebutted.

Primogeniture - Descent to the first born.

Privies - Partakers; interested parties.

Probate - The act or process of proving a will.

Processioner - A person appointed by the Ordinary in each militia district to mark off a disputed land line.

Propinquity - Next of Kin.

Putative - Reputed, but not actual

Residence - Place where one actually lives or has his home.

Residuary Legatee - One to whom the balance of an estate is bequeathed.

Residuum - That which remains of a decedent's estate, after debts have been paid and legacies deducted.

Reversion - The residue of an estate left in the grantor, after the end of a particular estate.

Socage - Tenure of land by certain inferior service.

Subscribing Witness - A person who writes his name under an attesting clause. Generally used to indicate a witness who attests the execution of a will by writing his name under the attesting clause.

Sui Generis - Of his own kind or race.

Sui Juris - Of his own right; capable of making a contract.

Tenant - Holder of lands in fee for life, for years, or at will.

Tenants in Common - Holding by distinct title, but by unity of possession.

Testamentary Guardian - Guardian of a child appointed by the deed or will of the child's father.

Testator or Testatrix - The maker of a will or testament.

Teste - The concluding clause in a writ **beginning** with "Witness" and followed by the name of the judge of the court in which the action is brought and including the date.

Tithing - District of ten families.

Trust - An estate held for another's benefit.

Usufruct - Right of enjoying property which is vested in another.

Vested Remainder - Estate to be enjoyed in the future.

Ward - A person over whom or over whose property a guardian is appointed.

Warrant of Appraisement - A writ directed to five disinterested persons, three of whom may act, requiring them, on oath, to fairly and justly appraise and value all personal and real property of the deceased.

Will - The legal declaration of a person's intention as to the disposition of his property after his death.

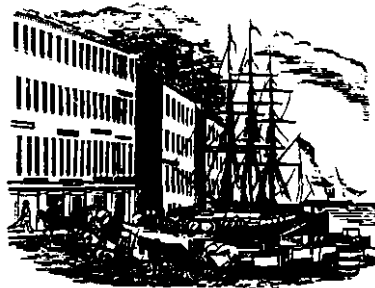

An excellent brochure is currently being circulated by the National Genealogical Society and the Federation of Genealogical Societies. It concerns the misuse of "surname" histories. Not a week goes by when a library patron does not ask for **his/her** "coat of arms" or whether **he/she** should buy a mass produced and mass advertised family history. I think that this consumer information is so valid that I am reprinting the entire brochure, (with permission), for our members.

**DON'T LET THEM
TAKE YOUR NAME
IN VAIN!!**

A variety of companies sells mass-produced items for thousands of surnames. Among these are one-page "surname histories," products showing a coat of arms, and books that feature addresses of individuals who share the same last name. These items are offered by direct mail, sold in airports and shopping malls, and advertised in magazines.

Millions of people buy these products, hoping they will learn something about their own family or share ancestors. Those who suggest that a mass-produced item is part of a customer's individual family background are **mis-**representing genealogy and family history.

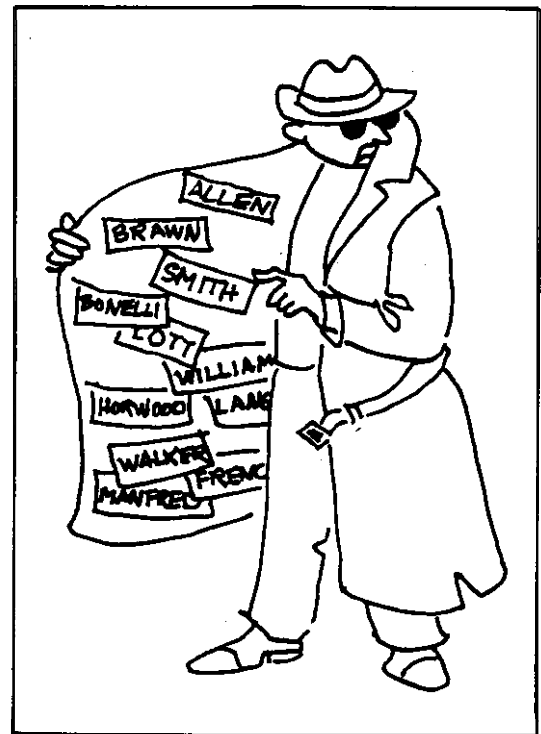
The National Genealogy Society and the Federation of Genealogical Societies believe that there are four things you can **do--** and should-- do when you encounter any of these products.

Be Alert!

Read the offer carefully. Then-- think twice!

* Was the letter you received also sent to thousands of other people with the same last name? .. Do you know many people who can afford to print and mail thousands of letters to sell a book on their family history?

* Does the letter offer a family history, or... .. Does it merely offer a list of addresses of people who have your surname?



PSSST!

**WANNA BUY
YOUR NAME?**

* Does the advertisement offer a coat of arms for your last name? Coats of arms were first granted to individuals-- not to surnames. Then, as now, the right to use these arms was inherited from one's father. -- How could a company that has not researched your family tree know whether you have inherited the right to display a particular coat of arms?

RETURN IT!

If you bought a surname product that you realize has nothing to do with you or your family, you have the right to return it for a refund. Here's how to do that:

- * If you ordered it by mail, you can return it for a refund.
Be sure to enclose your name and address, as well as a statement that you request a refund.
- * At the Post Office, you should buy a "return receipt for merchandise."
- * If you paid for the product by credit card, ask your card company for help getting a credit.
- * If you have not received a refund within six weeks, call the National Consumers League at 1-800-876-7060 (10:00 A.M. to 5:00 P.M., EST) for advice. Or, you can write them at: National Consumers League, 815 15th Street, NW, Washington, D.C. 20005.

COMPLAIN!

It is illegal to conduct schemes or devices to obtain money through the U.S. mails by means of false representation. The legal citation is 39 U.S. Code, Section 3005. The U.S. Postal Inspection Service will investigate any companies that use the U.S. mails to misrepresent mass-produced surname books or coats of arms. But the Service needs to hear from you before it can take action! If you receive a solicitation that you believe misrepresents the product being offered, you should write to the Consumer Protection Division, describing the ways in which you believe the company that contacted you has engaged in false advertising. If you don't have time to write, simply replace the contents in the envelope, reseal it, and cross out your name and address. Then forward it to: U.S. Postal Inspection Service, Consumer Protection Division, 475 L'Enfant Plaza, SW, Washington. D.C. 20260-1100.

TELL OTHERS!

It is important to let others know what genealogy **is...and** what it is not! Here are some ideas for your society to use:

- * Keep a file on products that misrepresent genealogy and heraldry.
- * Contact the consumer news columnist of your newspaper, suggesting that he or she feature an article on this topic.
- * Sponsor a program on surname solicitations. Ask your members who have purchased surname products to give a short talk on their experiences.
- * Offer to speak to local service clubs about products masquerading as genealogy. You will not have to worry about libel if you stick to the facts and avoid specific name calling.
- * Encourage and offer good genealogy classes in your community-- courses which promote solid genealogical research methods.

**Family Cemetery at Moorefields
Hillsborough, North Carolina**

[Many of the early Lower Cape Fear families would travel to the Hillsborough area of North Carolina in the warm months to escape the heat and insect infestation of the coast. They purchased large pieces of property in the region. many of the family members eventually moving there entirely. Therefore, families such as the Waddells, Nashs, and Moores, are familiar to both areas of the State. The following cemetery record was submitted by Nancy **Beeler**.]

5. Betty **Cameron**, daughter of John Donald **Cameron** and Rebecca Christina **Waddell**, she was born Nov. 7, 185?, and died Jan. 2, 1854.
6. Ann Owen **Cameron**, daughter of John Donald **Cameron** and Rebecca Christina **Waddell**, she was born June 8, 1860 and died Jan. 24, 1861.
7. Rebecca Christina **Cameron** and son, John Francis **Cameron**, wife and son of John Donald **Cameron**, she was born Aug. 25, 1826 and died Aug. 6, 1861, the son was born Oct. 8, 1852 and died Jan 9, 1865.
8. Catherine Cameron **Cushman**, daughter of John Donald **Cameron** and Rebecca Christina **Waddell**, she was born Mar. 28, 1855 and died Jan. 9, 1900.
9. Frederick Nash **Waddell**, son of Francis Nash **Waddell** and Elizabeth Davis **Moore**, he was born Apr. 10, 1837 and died Dec. 28, 1868.
10. William **Cameron**, son of Dr. William **Cameron** and **Emma Sinclair Moore**, he was born in 1838 and died in 1845.
11. Hon. Alfred **Moore**, son of U.S. Supreme Court Justice Alfred **Moore**, he was born 1782 and died July 26, 1837.
12. Sarah Louisa **Moore**, daughter of U.S. Supreme Court Justice Alfred **Moore**, she was born Oct. 15, 1795 and died April 26, 1888; and her nephew Henry **Marsden Waddell**, he was born Mar. 19, 1826 and died April 19, 1854.
13. Elizabeth Davis **Moore**, daughter of the Hon. Alfred **Moore** and Rebecca Christian **Williams**, married Francis Nash **Waddell**, she was born Dec. 7, 1807 and died Dec. 30. 1869.
14. Francis Nash **Waddell**, son of John **Waddell** and Sarah **Nash**, he was born July 15, 1796 and died May 1, 1881.
15. Guion Williams **Waddell**, son of Francis Nash **Waddell** and Elizabeth Davis Moore, he was born May 17, 1840 and died Oct. 1911.
16. Susan Eagles **Moore**, infant daughter of U.S. Supreme Court Justice Alfred **Moore**.
17. Augusta **Moore**, daughter of Hon. Alfred **Moore** and Rebecca Christina **Williams**, she was born 1809 and died Sept. 1870.
18. **Mammie Sue**, beloved nurse of the Moore and **Waddell** families.

NEW HANOVER COUNTY DEED BOOK C



[Many of the earliest records of New Hanover County were destroyed in courthouse fires. What was left of the first two deed books, Books A and B, were combined to form Book AB. They have been abstracted and published by ONHGS member Mae Blake Graves. New Hanover County was formed in 1729 from Craven County. Bladen and **Onslow** Counties were formed from New Hanover in 1734, Duplin County in 1750, **Brunswick** County in 1764, part of New Hanover was annexed by Sampson County in 1795, and Pender County was formed from New Hanover in 1875. The following abstract of Deed Book C, which covers many early records for the above mentioned counties, was compiled by Ida Brooks Kellam in 1939. Continued from the SPRING 1995 Courier.]

Page 136. Francis Thomas of New Hanover Co. to Duncan **Cowin** of same place, Planter. 320 acres on North side of Shallote River. June 5. 1747. Wit: Roger **Moore**, William **Dry**.

Page 136. Sept. 15, 1746. Elizabeth **Grainger** of Wilmington, "widow, late the wife of Joshua **Grainger**," decesd. and Caleb **Grainger** and wife Mary, to Joshua **Grainger** of Wilmington, Ship Carpenter. Sd Elizabeth became possessed of house on Dock Street by Will of Joshua **Grainger** which house should revert to his son Caleb **Grainaer** at death of Elizabeth. Wit: Richard **Hellier**. Ann **Hellier**.

Page 137. June 11, 1746. Elizabeth, widow of Joshua **Grainger**, and Caleb **Grainger** and his wife Mary to Thomas **Finney**, all of Wilmington, lot on Dock Street.

Page 138. William **Morris** of New Hanover Co. to William Nichols, Planter of same place, Plantation where sd William **Morris** now lives, being part of tract bought from Charles **Harrison** on White Marsh. Signed: William **Morris**, Mary **Morris**. Wit: Henry **Bishop**, William **Swann**.

Page 138. December 5, 1746. Caleb **Grainger** to John **Mott**, Planter, 30 acres in New Hanover County on Lee's Creek. Wit: Francis **Erwin**, Joshua **Grainger**.

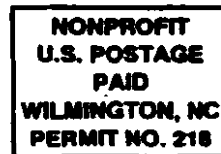
