SLOOP POINT DECLARED OLDEST HOUSE IN NORTH CAROLINA

Sloop Point Plantation's owners and ONHGS members, James W. (Walt) and Mae Blake Graves, have recently learned the exciting news in a letter dated July 28 from William J. **McCrea**, head of the Architecture Branch in the North Carolina Division of Archives and History. In 1994 a team of **dendro**-chronologists evaluated North Carolina's oldest known houses. Dendrochronology is the science of sampling, dating, and aging wood. Fifteen samples were taken from different locations in the house. Samples were also taken from the Palmer-Marsh House in Bath, the Cupola House in Edenton, and the Newbold-White House in Perquimans County - which were thought to be older than Sloop Point. The plantation home was built by John Baptiste **Ashe**, the father of North Carolina's first elected governor, Samuel **Ashe**. Originally sited on a plantation of over 1,000 acres. the home has had 14 or 15 owners. Mae and Walt purchased the house in 1983 and have been carefully restoring and researching it since. The Graves' are "elated that Pender County has the honor of having the oldest house in the state." All of us who enjoy the rich history of the Lower Cape Fear region share in their pride!

NEW HANOVER COUNTY COURT OF PLEAS & QUARTER SESSIONS

[This series of New Hanover County Court Minutes submitted by Helen Moore Sammons is continued from the Summer 1995 Courier. The Court Minutes prior to 1800 were abstracted many years ago by Alexander Walker. They are available in four volumes and can be purchased from ONHGS. Mrs. Sammons began her series in 1805. Spelling was recorded as seen and a ___ is given when the abstractor found the minutes impossible to read.]

STATE OF NORTH CAROLINA

At a Court of Pleas & Quarter Sessions began and held for the county of New Hanover at the Court House in Wilmington on **Monday** the **17th** day of **August** AD, 1807 and in the 32nd year of Independence.

The court was opened with the usual proclamation.

Present the Worshipful: William Giles, H. Kelly, Timothy Bludworth.

Ordered that Wm. Pigford be excused from the fine imposed on him for non-attendance at last term as juror and that he be hereafter exempt from serving on juries.

Cader Hughes, an orphan boy bound to Jethro Darden for four and a half years.

A deed from Wm. Nutt, Sheriff, to Jacob Powell acknowledged in open court and ordered to be registered.

Included are the names of all the census districts, the pensioners for Revolutionary War or military service, and a full name index.

New Hanover County, North Carolina, 1870 Federal Census, abstracted by Delmas D. Haskett and John W. Butler; and arranged and indexed Ann Hewlett **Hutteman**, June 1995, maps, Volume I, 246 pages, \$34.00; Volume II, 289 pages, \$39.00; Volume III, 503 pages, \$65.00 pages. ***In 1870 New Hanover contained present day Pender County and Wilmington, the largest city in North Carolina. Add the numerous newly freed African-Americans, and you have an enormous undertaking! Too large to be printed in one volume, the rural townships are listed in volumes one and two, and Wilmington Township alone in volume three. Included for each name is the age, race, sex, occupation, and value of property. Each volume has an every name index. The set of all three volumes is available for \$125.00.

Marriage & Death Notices from Wilmington, N.C., Newspapers. 1847-1850, compiled and indexed by Helen Moore **Sammons**, August 1995, map, 253 pages, \$33.00. ***Sixty North Carolina counties are represented in these abstracts, the majority are from Bladen, Columbus, **Onslow**, Brunswick, Cumberland, Sampson, **Duplin**, Wayne, and New Hanover. Revolutionary war service is often mentioned as well as destinations of those who migrated from the area. Included is a complete name and place index.

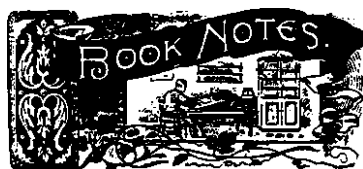

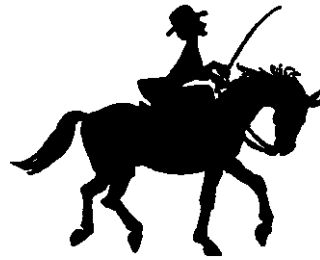
Dr. James Menzies Sprunt

Duplin County Court of Pleas & Quarter Sessions
July Term, 1845

It appearing to the satisfaction of this court that James M. Sprunt formerly a citizen of Great Britain and a subject of Victoria Queen of Great Britain and Ireland has in the Court of Pleas and Quarter Sessions for the County of Onslow in this State duly declared his intention of becoming a citizen of the United States and in all things complied with the requirements of the Acts of Congress in such cases made and provided and the said James M. Sprunt having in open court declared on oath that he will support the Constitution of the United States and that he doth absolutely and entirely denounce and abjure all allegiance and fidelity to every foreign prince, potentate, State, or sovereign whatever and particularly to Victoria Queen of Great Britain and Ireland. It is considered by the court and so ordered adjudged and decreed that the same James M. Sprunt be admitted to become a citizen of the United States and that henceforth he is entitled to all the rights and privileges of a citizen of the United States.

James **Menzies** Sprunt, was born at Perthshire, Scotland. He was educated in Edinburgh, and in 1835 went to the West **Indies** as an accountant with a mercantile company, operated by his brother Alexander. After the company folded James Sprunt decided to come to the United States to seek employment as a school teacher. The ship on which he was a passenger was bound for New York City, but a severe storm arose and disabled it. The ship was forced to make port in Wilmington, N.C. According to a 1927 report by A.R. Hicks, Jr, Dr. Sprunt told of "how Providence changed his plans and sent him to North Carolina." Shortly after leaving St. Thomas, a storm arose and damaged the ship considerably, and the Captain was forced to put into Wilmington for repairs. Almost destitute of means, Dr. Sprunt walked the streets of Wilmington in search of employment when he met Colonel Thomas L. **Faison**, himself in quest of a school teacher. Colonel **Faison** was impressed with this young Scot and engaged Dr. Sprunt to teach at Springhole, seven miles west of Warsaw, N.C. A few days later, Dr. Sprunt traveled to Warsaw, but a heavy snow had fallen during the night, and no one was there to meet him. When he told the citizens there is reason for coming, they informed him that a teacher was needed at Hallsville. He walked the fifteen miles to Hallsville, where he met Nicholas Hall who lived in the house opposite the new Presbyterian Chapel. Though Nicholas Hall had no formal education, he proceeded to examine Dr. Sprunt to see if he was qualified to teach school at Hallsville. Hall had a daughter, **Elenor**, who persuaded her father to let him spend the night. Eventually they were married in 1845.

Dr. Sprunt went on to teach in Hallsville. Richlands, and eventually became the principal of Grove Academy and the Presbyterian Female Institute, which later became James Sprunt Institute. His home still stands in Kenansville. He became a licensed and ordained Presbyterian minister in 1849. He served many congregations in the area. In 1861 he was commissioned as a Chaplain with the 20th Regiment, Company E, North Carolina troops, and served until 1864. From 1866 to 1880 he served as Register of Deeds for Duplin County. His wife **Elenor** died on June 6, 1876, and James Sprunt died December 6, 1884. He has many descendants in the Lower Cape Fear region.

[Many of the earliest records of New Hanover County were destroyed in courthouse fires. What was left of the first two deed books, Book A and Book B, were combined to form Book AB. They have been abstracted and published by ONHGS member Mae Blake Graves. New Hanover County was formed from Craven County in 1729. Bladen and Onslow Counties were formed from New Hanover in 1734, Duplin County in 1750, Brunswick County in 1764, part of New Hanover was annexed by Sampson County in 1795, and Pender County was formed from New Hanover in 1875. The following abstract of Deed Book C, which covers many early records for the above mentioned counties, was compiled by Ida Brooks Kellam in 1939. Continued from the SUMMER 1995 Courier.]

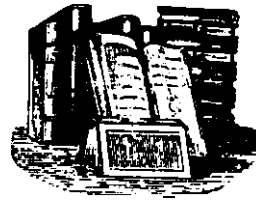

VAIL FAMILY REUNION

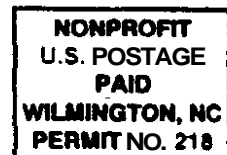
