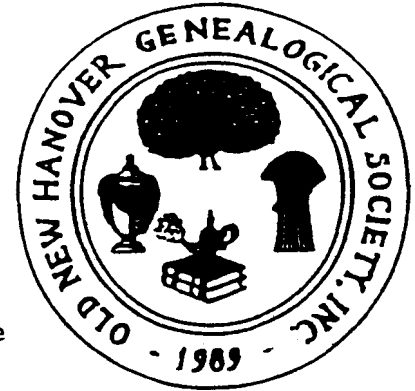
FORT FISHER COMBATANTS CONFEDERATE VETERANS REUNION, WILMINGTON, NC JANUARY 1907

[Ft. Fisher, considered to be the "lifeline of the confederacy," was operational during most of the Civil War. The fort protected the Cape Fear River giving Blockade Runners access to the port of Wilmington. Once in port, the much needed war supplies were loaded on to railroad cars and sent to Lee's Army. Because Fort Fisher was not captured until the end of the War, many men were stationed there over the four years. There is no definitive list of all who served at the fort. The following list of Fort Fisher veterans taken from the Wilmington Dispatch, January 15, 1907 (located in the North Carolina Room, New Hanover County Public Library) helps to establish the names of some of the veterans and their military units. Abbreviations include Co. for Company, followed by a number of the Regiment. For example, the first veteran listed is G.F. Allen, Company K, 40th North Carolina Regiment. Other abbreviations include Batt. for Battalion, Art. for Artillery, Inf. for Infantry, and when appropriate other states and unit information are listed. With this information any descendants can apply to the National Archives for their ancestor's military papers. Submitted by Bill Reaves. 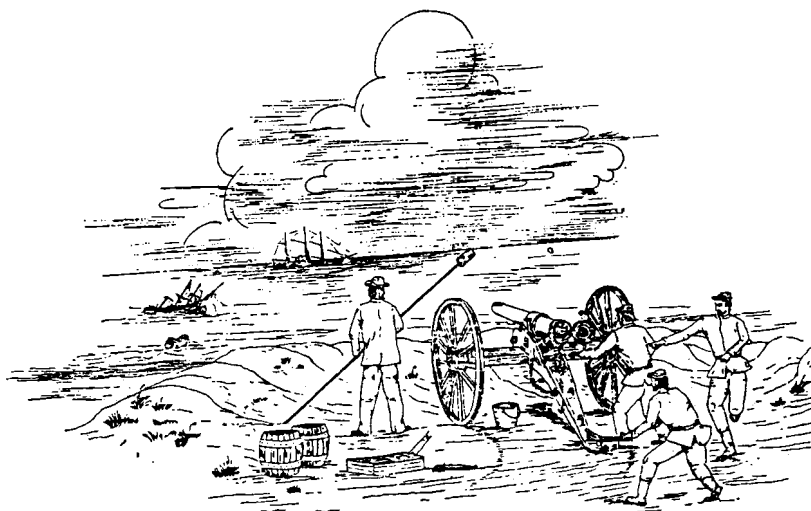

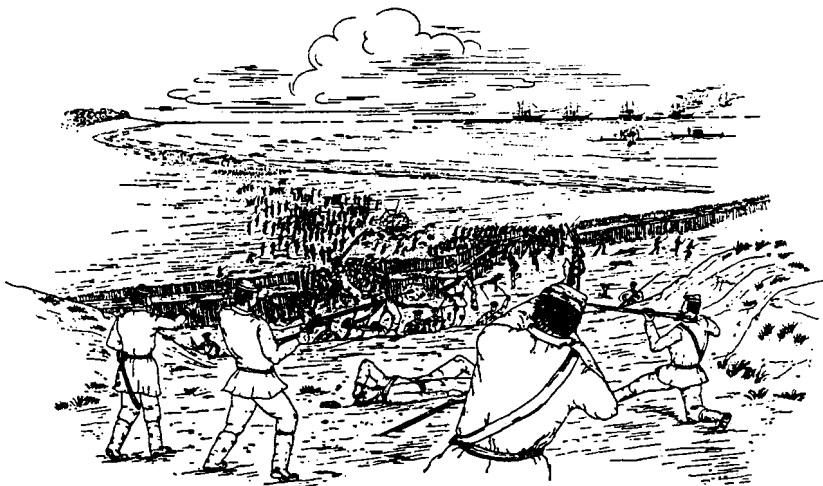

HEW HANOVER COUNTY COURT OF PLEAS & QUARTER SESSIONS

[This series of New Hanover County Court Minutes submitted by Helen Moore Sammons is continued from the Winter 1995 Courier. The Court Minutes prior to 1800 were abstracted many years ago by Alexander Walker. They are available in four volumes and can be purchased from ONHGS. Mrs. Sammons began her series in 1805. Spelling was recorded as seen and a _____ is given when the abstractor found the minutes impossible to read.]

STATE OF NORTH CAROLINA

At a Court of Pleas & Quarter Sessions began and held for the county of New Hanover at the Court House in Wilmington on Monday, the 15th day of Februarv. A.D.. 1808 and in the 32nd year of Independence.

The court was opened with the usual proclamation.

Present the Worshipful: **Sam'l ASHE**, H. JAMES, J. M. GABIE

Owen **KENAN** and Christopher DUDLEY appointed to audit the accounts of the admr. of Wm. WILKINSON, deceased.

Ordered that a commission issue to David LLOYD and Wm. JOHNSON to take the private exmination of Rebecca PHOEBUS relative to signing a deed to P. TATE.

Ordered that Alexander HENRY have leave to erect a grist mill on Rattle Snake Creek.

John M. GABIE and Hanson KELLY appointed to audit the accounts of the guardian of the heirs of John GIBBS.

Admn. on the estate of Elizabeth HENDRICK granted to Evan TAYLOR, giving bond in 30 lb. with Joseph LAMB and Wm. EVANS as securities.

Robert BENNETT and Henry TAYLOR, constables, returned to attend this court.

Admn. on the estate of George **McDONALD** granted to Timothy TEACHEY, giving bond 2000 lb. with Henry JAMES and Owen **KENAN** securities.

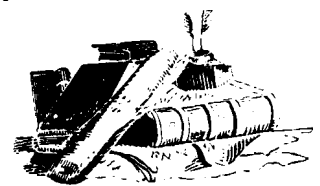

R. CAMOCK vs R. DORSEY- Jury: Jno. GOFF, Daniel O'NEILL, David BARBER, Wm. HARISS, **Nath'l** GUFFORD, Wm. WILKINSON, J. STANLEY, **Sam'l** BUXTON, Chas. GAUSE, Thos. SNEAD, Jno. ATKINSON, and Thos. HUNTER and find &c and assess damages 25 lb. with interest from 22nd May, 1807 till paid.

Admn. on the estate of Wm. GUFFORD granted to Nath'l GUFFORD, giving bond in 4000 lb. with Joseph LAMB and Thomas LEWIS, securities. Christopher DUDLEY, **O. KENAN**, and Jno. M. GABIE appointed commissioners to audit guardian accounts.

At an election for an Inspector of Lumber, there being sixteen Justices present, Joshua JAMES was elected.

A Bill of Sale from Balaam **BATSON** and Elizabeth, his wife, to James HOWARD proved by H. **NIXON** and ordered to be registered.

On the petition of James W. WALKER, satisfying the court of meritorious services of his slave, Virgil, it is ordered that said slave, Virgil, be and he is hereby manumitted and set free. He the said James W. WALKER first giving bond as the law in such cases directs.

Court adjourned till 10 o'clock tomorrow.

Wednesday, 17th February, 1808

Court met according to adjournment.

Present the Worshipful: H. JAMES, W. CUTLER, S. BLACK Richard THOMPSON, an orphan, bound to Wm. **HARRISS**, he giving bond Cc.

Wm. COLLINS vs C. ROGERS- Jury: Jno. GOFF, Thomas **ROBESON**, Jno. **McCALL**, M. **McKAY**, James MARSHALL, Thos. YARBORO, Jas. PORTEVENT, **Sam'l** BUXTON, Chas. GAUSE, Jas. WALKER, Daniel **O'NEILL**, Jonathan STANLEY and find the debt did assume Cc and assess damages 23 lb. and costs.

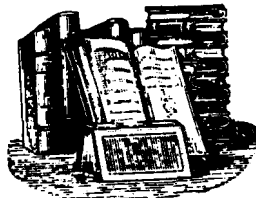

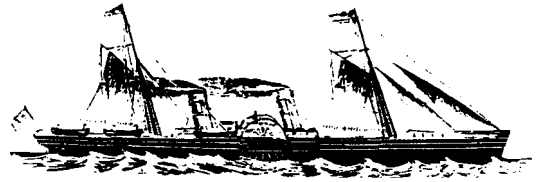

Captain **Thomas Mann Thompson**

[How lucky we feel as genealogists when our ancestors leave us a written record of their lives. We want to know more than their birth, death and marriage dates. We want to know what they did and how they felt about it. Letters, diaries, and memoirs often fill the void. The following letter was written by Capt. Thomas Mann Thompson, a Smithville (Southport) native, to his daughter Lilly in 1896. It gives us insight into the character of Captain Thompson, while providing us with a glimpse into the lives of local blockade runners, pilots and seafaring men. It was submitted by Cecil North Thompson of 2229 Silver Pines Place, Orlando, Florida 32808. He is the Great Great Grandson of Joseph T. Thompson, Captain Thomas Mann Thompson's brother. The photograph of the elderly Captain Thompson was published in The State Port Pilot, Southport, NC, March 29, 1978.1

Tuesday Nov. 24- 96

Dear Lilly,

You have asked me to tell you something that seems more like a dream than a reality. I have forgotten nearly all about my blockade career. As well as I remember I began running the blockade about the last of Feby. 1864. Left here on str- (steamer) "**Emma**" as passenger for Nassau. When we arrived there I was employed as a pilot on Her-Made three trips in and out making seven times I ran the blockade on the "**Emma**" including the time I was a passenger. I then joined the str "**Flora**" made two round trips on her. Joined the str "**Florie**" came out from Bermuda- sprang a leak returned- joined str "**Thistle**"- ran blockade one time on her. Then joined str "**Atlanta**" ran eight times on her- then joined str "**Armstrong**" ran three time on her- joined str "**Let Her Be**" ran six time on her. Joined str "**Coquett**" ran blockade one time on her. Joined str "**Index**" ran three time on her. Went on str "**Elizabeth**" and ran blockade one time on her. I ran blockade from Feby. 24, 1864 until a few days before the fall of Fisher. Made thirty four trips and was fortunate enough never to have been captured. I came in on the "**Atlanta**" once when there were thirteen of the Yankee blockaders in sight all lying around the bar in about two hundred yards of each other. I picked out the widest space between them and came full speed between them. They fired at us but did no damage. Another time I came in by one of them that was anchored in the channel on the bar so that I had to come within about five feet of her and never a sound did I hear from her. I thought at first I would run into and sink her- but saw that I could pass a few feet of her without running ashore- so thought better to get by if I had room, **than** to take the chance of disabling our ship and being captured by the enemy's launches. Once, we were fired upon by a ship and the ball passed between the Captain and myself. We were standing upon the bridge about four feet apart. It staggered both of us- but it was spent ball or it would have stunned us. It fell about fifty yards beyond the ship. Another thing happened- I came in by the blockade squadron in the day time and all this took

while I was running on the steamer "Atlanta". There is one thing I wish to mention, not on myself, but on one of old Smithville's bravest of boy's. It was on the steamer "Armstrong", from Bermuda-bound to Wilmington, N.C. We had a heavy northern gale blowing- the ship was laboring very hard and we had to carry a heavy pressure of steam and our steam pipe bursted. The engineers, firemen and all left the engine rooms and ran up on deck. We were then left to the mercy of a heavy wind and sea. I had just gone down to my room when I heard the squealing of the steam and ran up to the deck, the leadsman coming for me. He said Capt. wished to see me. As I went into the pilot house he said "what is best to do- she will roll herself to pieces." I said- host the jib and get the ship before the wind. We did so and all this time she was steam from stem to stern. The engineers and firemen began to look around to see if any of the men were missing, if so they were scalded to death- all were found but the Smithville boy- he had disappeared. When they did return down, they found the- oiler- the Smithville boy at work with his white lead and canvass. He had the pipes nearly ready to get steam up again. It was not his duty to repair the damage though he took in the situation and knew that the pipe must be fixed at once to save the lives of all on board the ship. The boy was an engineer by trade and was in Bermuda out of work. We had a full number of engineers- so I prevailed up the Capt. to give him an Oilers place. This brave boy was George Price. After we got steam up we had to go under a light pressure and by this time the wind had moderated. We sighted the land next morning to the southward of Charleston. We came along slowly until within about fifty miles of Cape Fear. We got close to the beach and came to anchor so that we could do a little more to our steam pipe. Just before anchoring we saw a signal just at the point of the woods on the beach. It was Federal soldiers seven in number who had been captured by the Confederates and had made their escape and reached the coast thinking that they could get to a Federal ship. They were nearly starved. We showed them the Confederate flag- they came down the beach and waved us to take them on board. I took a boat and crew and brought them to the ship where we both fed and clothed them for they were all nearly naked. We gave them all they wished to eat. We also had seven of our own soldiers on board who had been captured by the Federals and taken north and made their escape to Halifax and thence to Bermuda, two lieuts and five privates. We fitted out with a weeks provisions and landed them with our mail. This was done for fear of being captured on getting into harbor. Of course the federals were held prisoner until turned over to Gen. Whiting in Wilmington which was done three days after landing. We got steam and passed on way and crossed the bar half hour before sundown. The brave boy who faced the steam and repaired the broken pipe when it was the duty of others, and I were home before dark. One other incident- a little chase when on the steamer "Let Her Be". We crossed the bar about eight o'clock one night- sighted a blockader in hot pursuit of us- lost sight of her in about an hour- we thought she had given up. Our ship was very deeply loaded and there was quite a sea- so that we were all awash from stem to stern. We slowed down so that we could go a little

dryer. Nest morning just as day began to snow I walked afr with my glasses and took a look astern. There was the bluejacket crawling along after us about two miles astern. We had to go full speed again and there was a much larger sea than when we were inshore. I think Capt. Gemc must have been along with us on that ship and that was the "Nautiius" that we read of- for we were as much under water as above it. I think chat fellow wanted capture us for he did not give up the chase until about four o'clock that afternoon. By that time we were six or seven miles from him. He gave us sixteen hours of chase of about one hundred and sixty miles!

[Cecil Thompson writes, "when war broke out. both my Great Great Granafather, Joseph T. Thompson and his brother, Thomas Mann Thompson, made a living piloting ships through the northern blockade. Many pilots were captured and many ships lost trying to evade the blockade squadron. Since there was no place for these pilots to disembark after crossing the bar and evading the blockaders, they had to remain on board till the ship reached its destination. The pilot then re-employed on a ship returning to their home port. Pilots took control of the ships only during the transit over the bar going incc or coming out of port. Most of the blockade squadron kept at anchor between the bar and the mouth of the river, just out of cannon range of Forts Fisher and Caswell. Once over the bar seaward bound it was up to the Captain to evade or out run the blockade squadron."}]

RAILROAD PENSION RECORDS

If your ancestor has a Social Security number 700 to 728, he probable worked for the railroad between 1937 and 1943. The SS numbers were designated at the same time the Railroad Retirement Pension was set up. Railroad pension records are available from the Railroad Retirement Board, 844 N. Rush St. Chicago, -- 60611. Records may include information on wages, positions held, and more. As you know the Lower Cape Fear had more than its share of railroad employees.



BRUNSWICK COUNTY, NORTH CAROLINA, LAND GRANT BOOK "A"

[Here begins a new series of early Brunswick County land grants. Brunswick was formed in 1764 from New Hanover and Bladen counties. In 1808 part of Brunswick was taken to form Columbus County. The original land grants can be found at the North Carolina Department of Archives, Raleigh, NC. A microfilm copy of Brunswick Land Grants, 1788-1815, Vol. A can be found in the New Hanover Public Library. These abstracts are taken from an 1883 transcription done by H.K. Ruark, Brunswick County Register of Deeds. The first number given is the page number, the second number given is the land grant number. All of the grants are signed by the then serving NC governor.]

P- 1, #117. William Grisset, Sr. - 50 acres - South side **Waccamaw River** & lower side of Possum Branch. 11 July 1788.

P- 2, #291. Samuel Milliken - 100 acres - West side of Alligator Creek. Mentions William Goodman's line. 13 Nov. 1793.

P- 3, 8331. Benjamin Milliken - 100 acres - includes part of Juniper Creek. 12 Nov. 1793.

P- 4, #262. Samuel Leonard, Sr. - 200 acres - Upper side of Town Creek. Mentions Clarks Old Field. 12 Nov. 1793.

P- 5, #none listed. William Gibbs - 50 acres - East side of Lockwoods Folly River - Mouth of **Landin** Creek. 27 Nov. 1793.

P- 6, 11322. William Keith - 100 acres - On prong of Livingston Creek. Mentions Berringer Moore's upper south corner.

P- 7, #267. Benjamin Simmons - 200 acres - East side of Waccamaw River. 12 Nov. 1793.

P- 8, #294. Abraham Baker - 50 acres - On East side of Pinch Gut Branch called **Ram** Head. Mentions John Hugh Smith. 15 Nov. 1793.

P- 9, #296. Alexander Stephens - 100 acres - West side of Waccamaw River between Cypress Swamp & Seven Creeks on Huckleberry Bay. Mentions it joins Abram Baker's line. 26 Nov. 1795.

P- 10, 11297. James Porterfield assigns of John Porterfield 41,600 acres between Cape Fear River and Lockwoods Folly. Mentions **Abram Baker's** second corner. 26 Nov. 1795.

P- 11, 11300. James Porterfield - Davis Allison, assign of John Porterfield - 32,000 acres - West side of Waccamaw River, Seven Creeks, South Carolina line & Bladen County. Mentions Ann Simmon's Plantation, also Honl. John Rutledge, Esquire.

P- 12, #none listed. **Abram Walls** - 100 acres - Prong of Mill Branch joining Benjamin Robbins upper line. 9 July 1794.

P- 13, #none listed. John Anderson - 150 acres - Moores Creek, joining lands of John Anderson, Sr. 6 Dec. 1794.

P- 14, #none listed. William Gore - 250 acres - East side of Seven Creeks joining Mossy Neck Tract. 8 Dec. 1794.

Editor's note: For a good explanation of how land was granted in North Carolina (applications, warrants, surveys, entries and returns) see North Carolina Research: Genealogy and Local History, by Helen F.M. Leary. First published in 1980 this book has been called the "bible" of North Carolina records, where to find them, and how to use them. It has long been out of print, but a revised edition is forthcoming (May 1996) from the North Carolina Genealogical Society, P.O Box 1492, Raleigh, N.C. 27602. The pre-publication price, which runs until the end of April 1996 is \$40.00 (include \$2.50 for postage and handling).

NEW HANOVER COUNTY DEED BOOK C



[Many of the earliest records of New Hanover Co. were destroyed by courthouse fires. What was left of the first two deed books, Books A and B, were combined to form Book AB. They have been abstracted and published by ONHGS member Mae Blake Graves. New Hanover County was formed in 1729 from Craven County. Bladen and Onslow Counties were formed from New Hanover in 1734, Duplin County in 1750, Brunswick County in 1764, part of New Hanover was annexed by Sampson County in 1795, and last but not least, Pender County was formed from New Hanover in 1875. The following abstracts of Deed Book C, which covers many early records of the above mentioned counties, was compiled by Ida Brooks Kellam in 1939. Continued from the WINTER 1995 Courier.]

Page 214. Jan. 16, 1749. John Rnzor and Nance Rnzor his wife of New Hanover Co. to Peter Drouillard of same place 200 acres on Sturgeon Creek. Wit: Daniel Parin, Mary Parin.

Jacob Royal, son of Isaac Royal decsd. Aug. 17, 1749. Wit: Sarah Dunton, William Winter. Deed recorded in Boston, Oct. 18, 1749. Registered Aug. 20, 1750.

Page 225. Isaac Royal, Esqr. of Charlestown, Middlesex County, Mass. Bay, because of moving, appointed Mr. Richard Quince of Brunswick in North Carolina, mercht., his atty. to take possession of above lands. Oct. 13, 1749. Wit: William Story, William Royal.

Page 246. Edward Moseley, Esqr. of New Hanover Co. to Evan Jones, Planter, of same place, two tracts on one of which said Evan Jones now dwelleth. Jan. 20, 1746. Wit: Elizabeth Guerard, John Cooke, Senior.

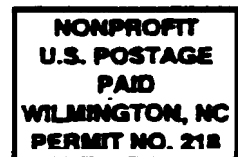
