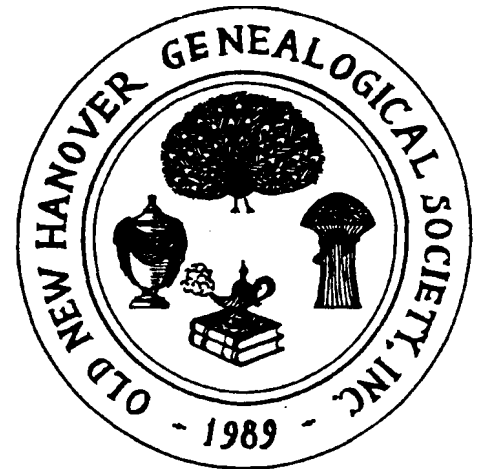

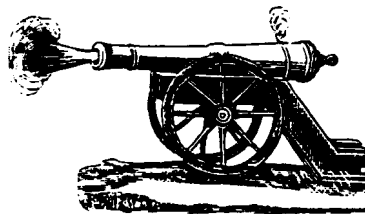

The wounded and captured were sent to Elmira Prison in New York or Point Lookout Prison in Maryland. The following abbreviations are used: Reg. for Regiment, Bat. for Battalion, N.C. T. for North Carolina Troops, N.C.S.T. for North Carolina State Troops, N.C.H. Art. for North Carolina Heavy Artillery, N.C.L. Art. for North Carolina Light Artillery, and * indicates that a soldier was killed in action. The 10th Regiment included the 1st NC Artillery, the 36th NC Regiment included the 2nd NC Artillery, and the 40th Regiment included the 3rd NC Artillery.]

[This series of marriage and death notices submitted by Helen Moore Sammons is continued from the Fall 1997 Courier. These are dated in the **1850's** and can be viewed on microfilm in the Local History Room at New Hanover County Public Library]

Wed 18 Sept 1850- Died: On last Thursday night, 5th **inst.**, Mr. W. J. ALSTON, of Sampson county, N. C. was shot and killed by some unknown person when returning home and only a short distance from his house.
(Intelligencer, 12th **inst.**)

Sat 6 Aug 1853- Married: In this town on the 4th **inst.**, by James L. Corbett, Esq., Mr. William CLARK to Miss Margaret Ann LEWIS.

Sat 14 Feb 1857- Died: John COLE, Sr. of Moore county, N. C. died on the 28th of January, in the 84th year of his age, leaving one hundred and four living descendants.

Sat 28 Feb 1852- Died: On the 19th **inst.**, at the house of her son-in-law, **Willis** Hall, Esq., in Wayne county, Mrs. Elizabeth COLLIER, in her 77th year, widow of the late Probate COLLIER, Esq.

Thur 24 Sept 1857- Died: At Quincey, Florida on the 17th of July last, Catherine **Molton** CONDREY, daughter of the late James HALL, formerly of this place.

Thur 22 Jan 1852- Died: At White Hall, Halifax county, on the 15th **inst.**, **Eliza**, consort of Edward CONIGLAND.

Tues 16 June 1857- Died: In this town on Sunday, 14th inst., Capt. John COSTIN, Harbor Master, aged about 38 years.

Tues 27 June 1854- Died: In this town on Sunday, 25th inst., Sallie Repiton, daughter of Wm. H. and Jane E. COSTIN, aged 1 year, 8 months, and 21 days.

Thur 30 Apr 1857- Died: Kimbrel COUNCIL, of Chatham county, committed suicide on the 17th inst., by hanging himself.

Sat 13 Oct 1855- Died: In this town on the 12th inst., Mr. Joseph F. K. COUTLAR, of Canandagna, N. Y., aged 21 yrs. (New York papers please copy)

Thur 6 July 1854- Died: In this county on 17th May, Mary Jane, and on the 25th, Margaret Ann, twin daughters of Owen R. and Mary E. COWAN, aged 3 years and 5 months. Also on the 10th of June, Cornelia Isabella, aged 1 year and 4 months.

Tues 5 June 1855- Died: In this town on the 1st inst., Platt Dickinson, infant son of R. H. and Eliza J. COWAN, aged seven weeks.

Sat 15 Aug 1857- Died: A man named Charles COZART was found dead on Wednesday last in the barn of Mr. Wm. R. Fraley. (Salisbury Herald)

Sat 27 Aug 1853- Died: In this town on the 22d inst., A. M. Caroline, third daughter of Thomas C. and Mary C. CRAFT, in the 9th year of her age.

Sat 23 Sept 1854- Died: In Charleston, S. C. on the 15th inst., Miss Caroline S. CRAIG, aged 25 years, a native of this place.

Sat 30 Sept 1854- Died: In this town on the 28th inst., at her residence on Princess Street, Catherine, wife of Mr. John B. CRAIG, aged 34 years.

Sat 19 May 1855- Married: In this town on Thursday last, by Rev. S. M. Frost, Mr. John B. CRAIG, of this place, to Miss Virginia G. NANCE, of Fayetteville.

Tues 18 Mar 1851- Died: In this town on Saturday, the 16th inst., John Edward, infant son of John B. and Catherine CRAIG.

Sat 21 Nov 1857- Died: (Columbia, S. C., Nov. 18th) Mr. Matthew CRAWFORD, aged 60 years, formerly a resident of Columbia, S. C., on Monday while traveling to that place on the cars from Charlotte, N. C., where he resided, met with an accident that caused his immediate death.

Thur 30 July 1857- Died: In Leon county, Florida, Elizabeth Ann, wife of John CROMARTIE, formerly of Bladen county, N. C.

Sat 23 June 1855- Died: On Thursday night last in this town, Mr. George W. CROOM, aged 29 years. He leaves a wife and infant child.

Thur 10 Sept 1857- Died: Near Long Creek in this county on the 3d inst., Mary Elizabeth, daughter of Lot and Mary Jane CROOM, aged 3 years, 5 months, and 3 days.

Sat 14 May 1853- Married: In this county on Thursday, 12th **inst.**, by William S. **Larkins**, Esq., Mr. **Lott** CROOM to Miss Mary J. JONES, all of this county.

Thur 15 Nov 1855- Married: In **Duplin** county on the 8th November, by Rev. D. B. Nicholson, Rev. Daniel CULBRETH, of the N. C. Conference, to Mrs. Elizabeth **CARLTON**.

Thur 19 June 1856- Died: Coroner A. A. Hartsfield held an inquest over the remains of Wm. CUMBER, aged about 35 years, a resident of Masonboro Sound who drowned on Sunday last while bathing. He left a destitute family consisting of a widow and four children.

Tues 20 May 1856- Married: In Greensboro on the 14th by Rev. J. J. Smyth, Mr. James D. **CUMMING**, merchant of this place, to Miss Kate, daughter of W. S. **RANKIN**, Esq.

Sat 19 Apr 1856- Died: In Bladen county on the 14th **inst.**, at the residence of John H. Clarke, Miss Catherine A. CURRIE, daughter of **Neill** and Sarah CURRIE, aged 19 years, 4 months, and 2 days.

Thur 11 Sept 1851- Died: In this town on the 4th **inst.**, at the house of her grandfather, Dr. **DeRosset**, Magdalen **DeRosset**, infant daughter of Rev. M. A. CURTIS, of South Carolina, aged 4 months and 24 days.

Tues 20 Apr 1852- Died: On the 5th **inst.**, at the residence of Mr. Cyrus Merriam near Putnam, Ohio, Mr. Edward A. CUSHING, of this town. 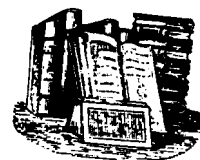

The **original** land grants can be found at the North Carolina Department of Archives, Raleigh, NC. A microfilm copy can be seen in the Local History Room of the New Hanover Public Library. These abstracts are taken from an **1883** transcription done by H. K. Ruark, the Brunswick County Register of Deeds at the time. The first number given is the page **number** of the grant book and the second number is the grant number. **All** of the **grants** were signed by the serving **governor** at the time. ANCIENT WILMINGTON

[The following is taken from the *Wilmington News*, 24 August 1934. It is a reprint of one of the many articles written by James G. Burr, for the *Wilmington Messenger* in the 1890s. Burr, who used the pen name, "Senex," wrote a series of articles describing Wilmington before 1850. Many of his articles have been compiled by Bill Reaves and can be read in the Local History Room of the Public Library, where they have been bound and indexed. If you have an ancestor who lived in early **Wilmington** you **will** be interested to know that the old town has changed **dramatically since** the time that they walked the streets which were soggy and damp from all the wetlands and streams on which the town was built. What follows is a **description** of the topography of the old town. Submitted by **Bill Reaves**.]

"One will note after little observation of the topography of **Wilmington**, that Fifth Street, running parallel to the Cape Fear River is the backbone of a ridge upon which the city is built. The plateau which lies upon the summit of this ridge is variable in width, including oftentimes Fourth or even Third streets on the one side, and Sixth and Seventh streets on the other - and in some cases the level ground almost **overhanging** the river, as between Ann and Church streets. We speak of the natural lay of the land, that is the topography before the many changes that within the past **fifty** years have been made by **grading** and filling the **streets**. The average height of the ridge is **fifty** feet above tidewater, and the highest point is supposed to be at or near the intersection of Seventh and Red Cross streets, perhaps ten feet higher. The descent towards the river is seamed by several branches or **runs**, **taking** their rise sometimes as far back as Third Street and emptying into the river a few hundred **yards** apart. Within the limits of 'Wilmington of the Olden **Time**' these were the streams rising between Third and Fourth **streets** and emptying **at** the foot of Mulberry; Jacob's **run** rising on Fourth street near Princess and pursuing a southwest course until the

river receives its waters **at** Dock Street; and Tan Yard branch rising at Third Street, between Orange and Ann streets **running** about due west, **emptying** into the Cape Fear at a point between the same streets. Boiling Springs branch does not come strictly within our limits, but so nearly that it is given its place here. Rising about **Fifth** Street and **Wooster** Street it **runs** west with an inclination slightly south and **empties** near the foot of **Dawson** Street.

The river front as we see it now gives little idea of the water line even fifty years ago. The business at ~~that~~ time was done between Orange and Mulberry streets, most largely, perhaps, north of Dock Street. After the **building** of the **Wilmington & Weldon** railroad the trend of business was constantly toward the depot. The wharves south of Orange street were used for storage of staves, river lumber and tar. The distillation of turpentine was then in its infancy and a light factor in business operations. Above Mulberry street the water of the river came up to **Nutt** Street in all places where the land had been made, as it was called, by filling in the water lots with ballast or sand. **When** the steamers were first placed in line between **Wilmington** and Charleston (1840s) a bridgeway was constructed to reach the boats and transport passengers and baggage from the railroad **landing** place. Above Campbell Street, on the river front, **fifty** years ago, was woods, or rather swamp. Above **Bladen** street a sheer **bluff** rose from the foot of the swamp and just beyond Harnett Street on the **summit** stood 'Paradise,' then owned by Mr. Robert H. **Cowan**. The locality in general was euphoniously styled "**Hogg's** Folly — precisely why, no one seems to know — but certainly because someone of the name had begun an enterprise of some kind or other which proved an impracticality."

Town commissioners **faced** all sorts of growing pains, including licensing of taverns and other businesses; **hiring** contractors to construct public **buildings**; and **enacting** ordinances concerning slaves, free persons of **color**, the sale of liquor, **traffic**, taxes, bridges: burial grounds, river improvements, stray dogs, cisterns, cook shops, street repairs, drains and waste water, elections, fire departments, gas **lights**, the town guard, street lamps, police **affairs**, the town market, street paving, **railroad** matters, boarding houses, sailors, sidewalks, livery stables, street cleaning, town surveys, **4th** of July celebrations, **etc.** For the genealogist this book provides an excellent portrait of Antebellum life in Wilmington and lists numerous names of inhabitants.

The book is a careful transcription of the minutes, and includes endnotes, a bibliography, and a full index. Interesting **appendices** include short biographies of each commissioner. NEW HANOVER COUNTY DEED BOOK 'D'

[Some of New Hanover County's earliest records were **destroyed** by courthouse fires. What **was** left of the first two deed books, A and B, was combined to form book AB, which was abstracted by Mae Graves many years ago. Deed Book C was published in the *Courier* from 1993 through 1996. Abstracts of Deed Book **D** began in the Summer 1997 *Courier*. New Hanover **County was** formed in 1729 from Craven County. Bladen and **Onslow** Counties were formed from New Hanover in 1734, Duplin County in 1750, **Burnswick** County in 1764, part of New Hanover was annexed to **Sampson** County in 1795, and Pender County, last but not least, broke away in 1875. The following abstract of Deed Book **D**, which covers many early records for these areas, was compiled by Ida Brooks Kellam in 1939/40.1

Page 66. Francis **Dixon**, Planter of New Topsail in New Hanover County to Thomas **McClamy**, Planter of same place, 100 acres on New Topsail Sound, joining Thomas **Nixon**. June 9, 1753. Wit: **Ezekial** Alexander, Thomas **Nixon**.

Page 67. July 1, 1753. John Chalkhill, Gent., late of Brunswick on the Cape Fear River, in North Carolina, but now of London, to Thomas Shubrick and Daniel Crawford, of Charlestown, South Carolina, merchants, "Whereas, the said John Chalkhill and John Russell, now or late Commander of his Majesty's Sloop the Scorpion, stood several bonds for Thomas Shubrick and Daniel Crawford, "a tenement" in the town of Brunswick commonly called Prospect Hall. Wit: Stephen Prew, Samuel Coates. . "Samuel Coates of the Parish of St. James the Apostle in the City of London, Gent." made oath that he saw Chalkhill sign the Philadelphia, the above mortgage. Aug. 7, 1753.

Page 70. John **Hopkins**, merchant of Philadelphia has appointed Mr. Alexander **McKeithan** of Wilmington, North Carolina, merchant, his attorney to collect especially against Robert Murray and Richard Quince. Wit: George **Rankin**, Aaron **Jenkins**.

Page 70. William **Faris**, Esqr. Of Mellville in New Hanover County, North Carolina, to Luke **Bowen**, Planter of New Topsail Sound, 200 acres, on Topsail Road. March 1, 1754. Wit: Felix **O'Neill**, Lesly **MacCarroll**.

Page 71. Mar. 6, 1754. Richard Lyon, Esqr. Of New Hanover to "Honorable Matthew Rowan, Esqr. President and Commander in Chief in and over said **Provence** of North Carolina," 400 acres in New Hanover County on the lower side of Hood's Creek, joining Col. **Halton's** Indian Branch. Wit: James Murray, Felix **O'Neill**.

Page 73. Oct. 13, 1753. Lewis Henry DeRossett, Esqr. of **Wilmington** to John Cook, **Junr.**, Planter of New Hanover County, lot No. 6 in Wilmington, joining James Mitchell, a lot that was William Lord's but now in the possession of the Executors of Robert Walker, deceased, including the wharf. Wit: Sophia Toomer, **Newell** Harriss, Joshua Toomer.

Page 73. Oct. 30, 1753. Daniel Laroche, late of South Carolina by Samuel Swann, his attorney of New Hanover County to Lewis Henry DeRossett, Esqr. of Wilmington, 'Whereas Thomas Sawyer, Tavern Keeper of New Hanover County and Ann his wife, deeded John Porter, Esqr., merchant, 2 lots in Wilmington between Middle Market Street and Ann Street, joining William Lord, now in possession of Executors of Robert Walker, deceased, said Daniel **Laroche** sold to Henry **Danbury** of the Parish of Prince George in Craven County, South Carolina, by said Lewis Henry **DeRossett**— lots No. 7 & 6 & 10. Wit: Sophia Toomer, **Newell** Harriss, Joshua Toomer.

Page 78. **Dec.** 15, 1741. Evan Jones of New Hanover County, Planter, one half **tract** of 1480 acres, on N.E. Branch of Cape Fear River, joining Capt. **Douglass** tract. Wit: Henry Skibbow, Patt. **Boyline**.

Page 79. Alice Russell, widow of John Russell, Esqr. Late Commander of his Majesty's Sloop, **Scorpion**. Said John Russell made his will, published **Dec.** 13, 1752, property to wife Alice, **after** debts paid. Said Alice made Executrix. Said Alice made bond to Richard Quince, merchant of **Brunswick**, because she is moving. She appointed Richard Quince her attorney to sell her property. April 16, 1753. Wit: John Hutchinson, Robert **Nappers**.

Page 81. 1753. Joshua **Grainger** and Catherine his wife of New Hanover County, ship Carpenter, to Isaac Green, Planter of same place, lot on northeast side of Market Street. Wit: Richard Lyon, John Walker.

Page 83. Nov. 27, 1753. John Davis, Jr., Esqr., High Sheriff of New Hanover County, to George Merrick, Planter of New Hanover County, and Eleanor Merrick, Spinster, of same place, who hold suits against the lands of William **Burnie**, Carpenter, deceased. Said Davis did on Nov. 26, cause the land to be appraised by Samuel **Swann**, Richard **Hellier**, John Duboise and John Lyon, and Moses John DeRossett One of the **Executers** of said William Burnie, took said lands for **satisfaction** of above debts, giving legal titles to said George and Eleanor Merrick. Wit: Samuel Neal, Thomas Neal.

Page 84. Joshua Mange of **Halifax**, Nova **Scotia**, merchant, appointed William Moore, Esqr., merchant, of **Brunswick**, North Carolina, his attorney to collect from Mr. James Ellison, Mr. Francis **Kipp**, Mr William Mace, and Mr. Williams of North Carolina for merchandise sold them by Samuel Lowell, late Master of the Schooner, **Friendship**. Feb. 1, 1753.

Compugenics by Gerald McKenzie

We have now completed our first two meetings of the year: Basic Computer Discussion and Genealogical Software. While I was not in town for the second meeting, it was reported to me as being very successful with a lot of interchange between attendees. The first meeting was also most beneficial as evidenced by the same type of interchange. What I've tried to do in these meetings is to get everyone to bring something to the table reciting their experiences related to the meeting topic(s). When this happens it always results in many people benefitting from the sharing of such knowledge or avoiding a pitfall that they did not know of. I encourage the out-of-towners to write to me (care of this publication) about their own experiences related to any of the seven agenda topics listed in the last issue of the *Clarendon Courier*. I'll make sure that their experiences are shared and if appropriate, responded to.

I've had some feedback from the cautions that I advised about "backing up your data" in the last issue. Someone wrote to me about an experience that they had while entering data into a file which had over 3000 names, events, places ... etc. A power line fault occurred which wiped out the most recent data (about a dozen entries) and when she re-booted, somehow in her panic, she wiped out the entire database. She was saved by the fact that she had just sent a GEDCOM file of her entire database to her brother on the previous day. Her brother sent her the file that she had sent him and she imported the file into a new database and recovered all of the data (except of course the dozen or so of the newest entries). Her very next step was to run the program's backup routine and

create a backup file on a floppy disk. And, after she re-entered the dozen entries, she performed a second backup. She was lucky that her brother had the GEDCOM (the equivalent of a backup), can you imagine having to reconstruct and re-enter over 3000 names events ... etc.?

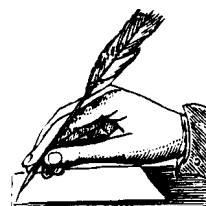
The topic for the month of November was Databases and Sources. It seems that the availability of data being released on CD-ROMs is growing by leaps and bounds. The World Family Tree series by Broderbund (Family Tree Maker) has already reached WFT #13 with many more on the horizon. The most economical way to buy these is in a bundle of five or seven for around \$60.00 ... which is around \$10.00 each versus individual prices of \$29.95 to \$39.95 each. You may have to wait 4-6 months to see a series bundled, but it is worth waiting. Everton's Genealogical Helper has a listing of suppliers of these CD-ROMs in its back pages. A couple of other CDs that have been released which may tweak your interest are: *Official Record of the War of the Rebellion* (seen advertised in the latest Family Tree paper of Odom Library in Georgia); Complete Book of Immigrants CD #350 (listed in *Everton's Helper*); and All in One *Address Book* CD #115 (listed in *Everton's Helper*). I have CD #115 and think that it is great. It lists family associations, vital record sources (as in the *Handybook* by Everton's) and more. As I have mentioned previously, our Local History room at New Hanover County Library has over 100 CD-ROMs for the genealogy computer and is reviewing several more for potential purchase.



Who knows, maybe one day the writing and publishing of genealogies and family histories will be done using the CD-ROM technology. This technology can handle text, graphics (photo and other) as well as sound. With this in mind I urge you to record your elder relatives: their voices, their stories and their photographs. Most genealogical software today can "import" both photographic and audio images. Wouldn't it be great to be able to present a family line of data accompanied by the picture of the people involved and hear some of them telling what

their life was like in their own voice? I know we are all busy and have too many things to do without adding something else, but our elders and their stories are too precious to waste. Somehow or other we must all make time available to sit with these people and record in some way their narration of part of your history.

Computers have revolutionized the methodologies of doing genealogy work. Let's make use of this tool with diligence and integrity.

Upcoming ONHGS Programs

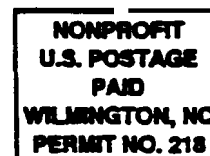
