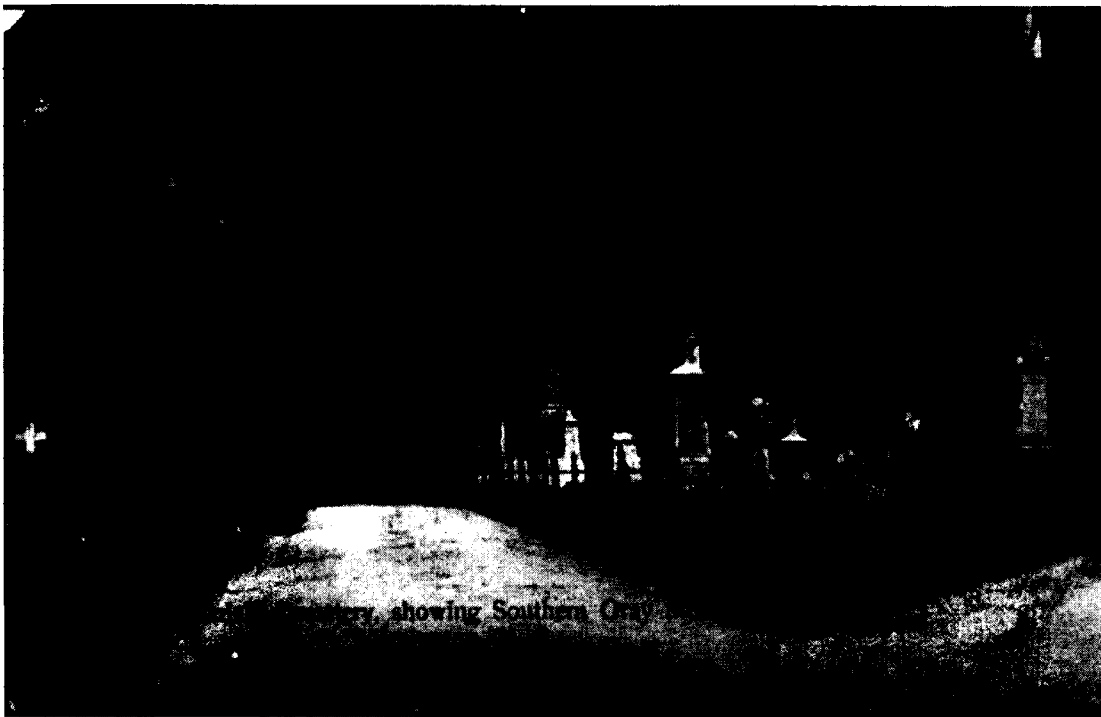

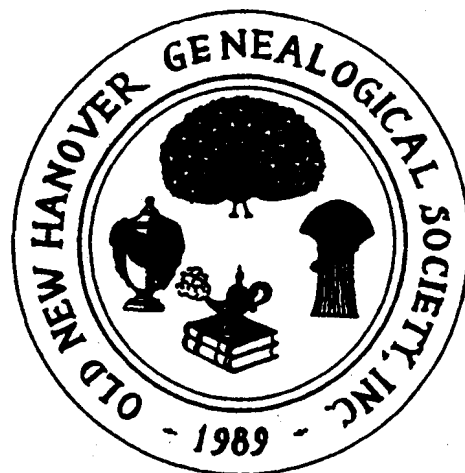
*Oakdale Cemetery, showing Southern Gray Moss - Wilmington, NC*

**A Bibliography of Cemeteries**

**New Hanover County**

*Oakdale Cemetery Records, Wilmington, North Carolina*, 5 volumes, 1852-1879; 1880-1920; 1920-1949; 1950-1969; 1970-1988. Founded in 1852, **Oakdale** is Wilmington's largest cemetery. Many who died before 1852 were also removed to **Oakdale**.

There are 4 different books that cover Bellevue Cemetery which began in 1879 as a private cemetery company. Some of the following compilations are taken from stones, some from the registers, and some include both. It is wise to check all of the volumes. *Burial Records of Bellevue Cemetery, Wilmington, N.C.* compiled by Jeff and Susan Phillips. *Register of Deaths and Burials, Bellevue Cemetery Company, July 1876 - May 1988*, an Eagle Scout project, led by Jonathan T. Rowell of Boy Scout Troop 215. *Bellevue Cemetery, Wilmington, North Carolina, A Directory of Grave Sites*, a photocopy of an old hand written listing. *Lower Cape Fear Gravestone Records, Vol. III (Bellevue Cemetery, Wilmington, North Carolina)*, by Ida Brooks Kellam.

*Prospect Cemetery*, by Emma Yopp Murray. Located in a recently highly developed area north of Wilmington near Highway 117 and Military Cutoff Road, the earliest grave dates to 1860.

*Oak Grove Cemetery, Wilmington, North Carolina*, compiled by Bill Reaves. The original Oak Grove records have been lost. Mr. Reaves compiled them from newspaper notices and death certificates. It is the final resting place of both whites and blacks. There was also a "potter's field" area for unknowns, strangers, criminals and the destitute.

*Masonboro Sound Cemeteries and Other Information*, compiled by Crockett W. Hewlett. Included are the burials in Masonboro Baptist

Church as well as several family cemeteries in the area.

*Inscriptions*, by Elizabeth Francenia McKoy. From St. James Church graveyard, these records include the entire tombstone inscription.

*Gravestone Records, New Hanover County, with Supplementary Records for Pender County*, by Leora H. McEachern. Vol. XI in her cemetery series, this book covers the smaller family and church cemeteries in the county.

*Pine Forest Cemetery Records, 1863-1971*. These are the records of the city's oldest surviving African-American cemetery. They can only be viewed on microfilm.

**Brunswick County**

*Lower Cape Fear Gravestone Records (Vol. I)* by Ida Brooks Kellam. These records, which randomly cover all the counties of Southeastern, NC, were compiled in 1959. Of the 43 cemeteries covered, 25 are in Brunswick County.

*The Cemeteries of Southport (Smithville) and Surrounding Area*, compiled by Dorcas W. Schmidt.

**Pender County**

*Pender County, North Carolina Gravestone Records*, Leora Hiatt "Billie" McEachern. This is a remarkable collection of over 400 family and church cemeteries.

**Onslow County**

*Onslow County Cemetery Records*, compiled by James Michael Whaley. Twelve volumes of hundreds of family and church cemeteries.

*Onslow County, North Carolina, Confederate*

Veterans, compiled by James Michael **Whaley**. This collection includes the cemetery records of **Onslow** County Confederate veterans.

## Census Records

Sometime this Fall, all of the censuses, all years (1790-1920). **all states. all counties** will be available for **seraching** at the library's North Carolina Room. This **service will be provided by** Ancestry for a fee per computer terminal. The library will be paying all costs and **will have at least one terminal** (maybe two) available in the North Carolina Room. There will probably be **another terminal** available at the new library branch (opening in September) at the Landfall Shopping Cntr. **This is incredibly exciting** news for genealogists. Censuses are the "meat and potatoes" of **gencalogical research** and just imagine - no more interlibrary loans!!! Speaking of censuses, the National **Archives will release the 1930** Census on April 1, 2002. Included are 2668 rolls of microfilm. NEW **HANOVER** COUNTY COURT MINUTES  
Court of Pleas and Quarter Sessions  
May Term, 1815

[This series of New Hanover County Court Minutes submitted by Helen **Sammons** is continued from the Winter 2000 Courier. These may be viewed on microfilm in the North Carolina Room of the New Hanover County Public Library.]

Ordered that **subpenas** issue to Mary Norman, wife of Rev. \_\_\_\_\_ Norman and Ann McRee, wife of Robert McRee, subscribing witnesses to the will of Mrs. Amy Turner, dec'd, and compel their attendance at next August term of this court to prove the execution of the will of the said Amy Turner.

John Swann, Jr. to the use of Jno. F. Burgwyn vs Admor of William Hill - Same jury empannelled and find all issues for the Plff and assess damages at \$80.85 with interest from 15<sup>th</sup> June 1813 till paid and costs.

Robert Carter vs Excors of John Hill - Same jury empannelled and find all issues from the Plff and assess damages at \$196.07 with interest from 1<sup>st</sup> August 1814 till paid.

Paoli **Ashe** & wife vs Heirs of Wm Strudwick. Return filed, made a rule of Court and ordered to be registered.

Wm P. Chester vs John **Wilkins** - Same jury empannelled except Wm Richardson in whose room is Thomas **Reston** and find the writing obligatory to be the act and deed of the Deft and assess damages at \$75.79 with interest on \$73.55 from 8<sup>th</sup> of May 1815 and costs.

Same vs Same- Jury empannelled and find that Deft did assume and assess damages \$94.57 with interest from 8<sup>th</sup> of May 1815 and costs.

John Williams vs Israel Judge- Plea of payment since the last continuance.

Court adjourned to tomorrow, 9 o'clock

Tuesday morning- 9 o'clock

Court met according to adjournment.

Present the Worshipful: John Hogg, Wm Hall, Stokely **Sidbury**, Thomas Bishop and John Nelson returned as constables.

Wm Robinson vs Wm Giles - Jury empannelled: Aaron **Bowen**, Duncan **Robeson**, Saml L. Bludworth, James Smith, John Riley, Jonathan Stanley, James Stevens, Wm B. Miller, Wm Richardson, James Moore, Robert **Larkins**, Wm **Larkins**, and find that the Deft's intestate did assume and assess damages at \$112.44 with interest from 26<sup>th</sup> November 1813 and costs until paid and find that the Deft has fully administered.

John Williams vs Abraham Golden- Thomas **Callender** witness on behalf of Plff called and failed.

John F. Burgwyn vs John **Wilkins**- Foregoing jury empannelled and find the issues for the Plff and assess damages at \$132 with interest from 1<sup>st</sup> June 1813 and costs.

Frederick **Simpson** vs Admor of Wm Giles- Same jury empannelled and find the Deft's intestate did assume and assess damages at \$122.84 with interest on \$109.68 from 9<sup>th</sup> May 1815 and costs and further find that the Deft has fully administered.

George Hooper vs Thomas N. Gautier- Same jury except Wm Richardson in whose room is John A. Lillington and find for the Plff and assess damages at \$95.60 with interest on \$80 from 9<sup>th</sup> of May 1815, that there is no payment or set-off.

Administration on the estate of Allen Shaw granted to Mary Shaw, giving bond in \$5000 with **Hinton** James and Colin **McAllister** as securities.

A deed from Almand Hall to Stokely Sidbury.

A deed from Gabriel Holmes, Sheriff, to Joshua James.

A Bill of Sale from John **McMillan** to David Smith- all acknowledged in open court and ordered to be registered.

A Bill of Sale from William C. Lord to John **Cowan** proved by **Sam'l** Bunting, Jr., subscribing witness thereto.

A Bill of Sale from Wm G. Lewis to Solomon **Pigford** proved by Joseph Lamb, subscribing witness thereto.

**Randolph Jefferson Cary (1921-2000)**

A Tribute by Beverly Tetterton

The local genealogical community lost a great man on May 25, 2000. Born on February 13, 1921, Randy Cary was reared in Richmond, Virginia, steeped in the family tradition of one of the state's oldest and most distinguished families. Randy graduated from the United States Military Academy at West Point and chose a life of military service. After retirement from the military, he and his beloved wife, Becky, settled in Wilmington where he worked in the insurance industry. They were active in local affairs and at St. James Episcopal and First Presbyterian Church. During retirement, Randy had time to enjoy his avid pursuit of family history. He was a member of numerous genealogical organizations including the Society of Cincinnati, the Virginia Genealogical Society, the North Carolina Genealogical Society, and was a charter member of the Old New Hanover Genealogical Society.

I met him at the library where he spent countless hours doing research on the Cary clan as well as preparing papers for applicants to the National Society of the Colonial Dames of America. He was always very generous with his expertise and had the ability to graciously listen and show interest in others. His good humor was overflowing. I will never forget the day, when **after** countless hours of preparation, he had received word that he had been accepted into the Society of Royal Bastards (devoted to those who descended from a bastard member of England's Royal Family). I encountered him breathless from running up the library's stairs. Waving his official acceptance over his head he exclaimed, "Beverly, Beverly, it's official, I am a Royal Bastard!"

- In 1989, when the Old New Hanover Genealogical Society was forming, Randy accepted the position of vice president. He was instrumental in getting the society off and running. Among other duties, he was **helpful** in setting up our publications program. He was **mindful** of how many genealogical abstracts were being created by library volunteers and I will always be **thankful** to him for setting up the memorandum which allowed the society to publish these books and share the rewards with the library. From those efforts, hundreds of genealogical books have been added to the library shelves.

Randy and I both served on the Board of Directors of the North Carolina Society. Together, we traveled across North Carolina to board meetings. At the time, NCGS was heading into financial trouble and Randy was **helpful** in starting us on the road to recovery. I really got to know him well during those long drives. It was obvious from our conversations that he was foremost a family man. He was very proud of his sons and his grandchildren. A good listener, he also learned about my family and I cannot think of one time that I saw him that he did not ask about my husband and daughter. One could not find a more sincere friend.

Randy Cary was the quintessential Virginia gentleman. His wisdom, wit and integrity was contagious. A **full** church celebrated his life at First **Presbyterian's** memorial service held on May 26, 2000. The Old New Hanover Genealogical Society joins me in sending our heartfelt sympathy to his family. A fitting repose, he was buried at Arlington National Cemetery.

**NEW HANOVER COUNTY DEED BOOK "D"**

[ Many of New Hanover Count's earliest records were destroyed by courthouse fires. What was **left** of the county's first two deed books, A and B, was combined to form AB. This book was abstracted many years ago by Mae Blake Graves. Deed Book C was published in the *Courier* from 1992 to 1996. This series of abstracts from Deed Book D began in the Summer 1997 issue of the *Courier*. New Hanover was formed in 1729 from Craven County. Bladen and **Onslow** counties were formed from New Hanover in 1734, Duplin County in 1750, **Brunswick** County in 1764, part of New Hanover was annexed to Sampson County in 1795, and Pender County, last but not least, broke away from New Hanover in 1875. The following abstract of Deed Book D, which covers many early records from the above counties, was compiled by **Ida** Brooks Kellam in 1939 and 1940.1

Registers of Baptisms, Marriages and Deaths**

The Rev. Thomas Murphy was appointed Pastor of the Congregation of the Town of Wilmington on January 1<sup>st</sup> 1845, by the Rt. Rev. Dr. Ignatius Reynolds, Bishop of the Charleston Diocese. Murphy superintended the construction of St. **Thomas** Church. This is the seventh in a continuing series of St. Thomas records transcribed in complete by Joseph **Sheppard**. These registers, taken from microfilm housed in the New Hanover Public Library, contain six volumes dating from 1845 to 1968. Baptisms list the child or adult initiate, the parents (P.P.), sponsors (S.S.) and the presiding minister. **Marriages** include bride and groom, witnesses (W.W.) and serving clergyman. Deaths are recorded with the name of the deceased and the officiating priest. Obsequies are proper and appropriate duties in regard to the dead.

His father was Dr. Frederick Gallagher (1806-December 29, 1890) the son of John (1779-September 25, **1832**) and Ann M. (1779-October 27, **1836**) Gallagher. His mother was Ann Catherine (1806-March 20, 1875) the daughter of Henry and Hannah **O'Neill** of Philadelphia. Dr. Frederick Gallagher and Ann C. **O'Neill** were **married** on June 7, 1829 by **A.Byrne** with Bishop John England. Ralph Donnelly, *The Parish Registers of St. John the Evangelist, Washington, NC, 1808-1911* (Greenville, NC: 1984) **5, 8, 42**. The Gallagher family all resided in Washington, **Beaufort** County, NC according to the 1860 **U.S.** Federal Census, pages 1018 and 992. By this census John A., a druggist by occupation, had married Sarah Jane Quinn. He enlisted in **Carteret** County April 17, 1861 as a private in Company G, 10<sup>th</sup> Regiment N.C. State Troops (**1<sup>st</sup>** Regiment N.C. Artillery), present and accounted for **through** October 1861. On November 16, 1861 he was appointed surgeon and assigned to the Medical Department. Louis Manarin, *North Carolino Troops 1861-1865 A Roster* (Raleigh: NC **Dept.** of Archives and History, 1966) 117. Unfortunately, on July 30 he died of a wound accidentally received in the course of a dissection.
