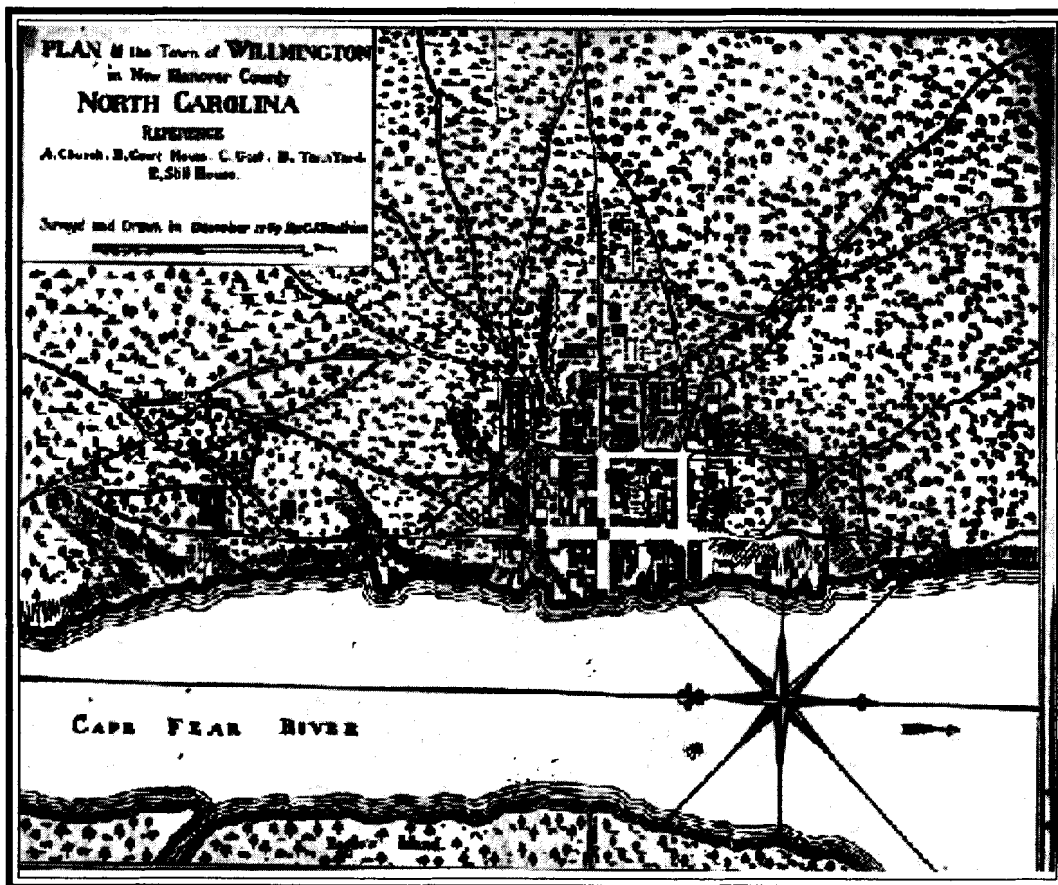

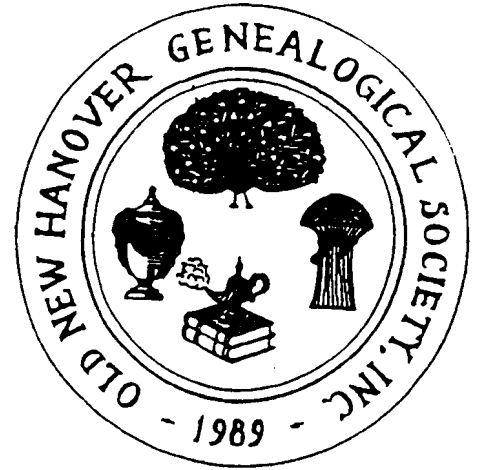

Maps and Genealogical Research by Beverly Tetterton

This is the last in a series of three articles concerning how maps can help you research for your ancestors. This article will be devoted to city maps and all those city dwelling ancestors.

If you have spent boring hours looking at censuses where every occupation was "farmer" try looking at a town census. The **occupations are** varied and give insight into who lived in the neighborhood. Later censuses give addresses, or you can find them in city directories. Once you have the addresses of your ancestors the next step is to find a map.

Until you can visit an archives and search for an old map, go ahead and procure a current one (they are easily available on the Internet). You can instantly get an **overview** of the city and how your family's home related to the town. Is it near a railroad track, a river, or the central business district? If the family changed addresses, where did they move and how does their new location relate to the different parts of the city. Can you tell if their fortunes were waxing or waning?

When you go to a library or archives ask for maps that correspond to the years your family lived or worked in various neighborhoods. If you are lucky you will find maps that indicate where houses were located.

Wilmington's earliest map that shows buildings is the **1769 C. J. Sauthier** map. It shows the little village in it's infancy and the major streets and buildings. It is also topographical and shows the streams which were eventually paved over; the marsh along the river; and the early roads into the town.

Only a few houses survive from that period, the Mitchell-Anderson House at 102 Orange St. and the Brown-Lord House at 300 S. Front Street.

The **Gray's Map of 1881** is the next Wilmington map to show buildings. It was published in **Gray's Atlas** along with maps of most large towns throughout the United States. There are two maps. One shows the central business and residential district, and the other shows the area surrounding it out to the city limits. With remarkable clarity it shows buildings, their size and how they relate to the street. Some buildings and lots have the landowners names attached. There are references to churches and public buildings. It reveals the importance of the railroad showing the many lines entering and leaving the city. The waterfront is lined with **maritime** interests. It is a great place to find out how close your ancestor lived to work, church, and play.

Probably the most useful maps are the Sanborn Insurance Maps. The Sanborn Insurance Company (still in business today) made detailed maps of cities for insurance purposes. They provide the location of the house and it's actual footprint showing porches, bay windows, etc., and what the house was made from (wood, brick, stucco). You can also see how the house changed over time, ie., if the owners added on or modified it. Years that can be found in the NHCPL are 1884, 1889, **1893, 1898**, 1904, 1910, 1915, 1948 and 1955. **If you** find the house you are looking for don't forget to go there immediately and see if it is still standing!

At a Court of Pleas & Quarter Sessions begun and held for the county of New Hanover at the Court House in **Wilmington** on the 2nd Monday in November in the 40th year of the Independence of the United States **1815**

The court opened **with** the usual proclamations

Present the Worshipful: Israel **Judge**, Samuel **Buxton**, Wm. James **Larkins**

Administration on the estate of John **Hall**, dec'd, granted to Edward B. **Dudley**, giving bond in **\$2000** with **Hinton James** and Gabriel **Holmes**, Jr. as securities. Ordered that said admr. have leave to sell the perishable property of his intestate.

Israel **Judge**, Jeremiah **Hand**, and Edward **Armstrong** appointed to allot one year's provisions to Alice Hall, widow of John Hall.

John **Henry**, Robert **Murphy**, Charles **Murphy**, John **Loring**, and George **Bannerman** appointed to divide the personal estate of Thomas **Rogers** amongst his heirs. Lucretia **Roberts** appointed guardian to **Ann**, Thomas, and Sarah and William **Haywood** to attend to their interests in said division.

Benjamin **Rochelle** appointed guardian of David **Mashbourne** giving bond in **\$2000** with Israel **Judge**, Bryant **Wooten**, **Hinton James**, Henry B. **Howard**, and Wm. James **Larkins** as securities.

Ordered that the admr. **ad** collegendium of Abram **Golden** dec'd, have leave to sell lthe perishable estate of his intestate.

Ordered that notice be given to John Bishop and Jacob Clarkson by publication for four weeks in the **Wilmington** Gazette and Raleigh Star, that they may appear at next court to **qualify** as executors of Abram Golden, dec'd; otherwise administration on said estate will be granted.

Administration on the estate of Amy Turner, dec'd, with will annexed, granted to Richard Lloyd and **Hanson** Kelly, giving bond in \$6000 with John McColl, Alexr. Hatridge, and James W. Draughon as secys. Accepted and filed.

Renunciation of Mary Ann Howe to administer accepted and filed.

Mrs. Mary Allen's will was exhibited to court, **proved** and ordered to be recorded.

Court adjourned to 3 o'clock

Admn on the estate of Wm. G. **Hasell** granted to Wm H. Haley, giving bond in \$15,000 with Jesse **Wingate**, John McColl, and Wm McKay as securities.

Dr. A. J. **DeRosset**, Jesse **Wingate**, and Alexr Anderson appointed to allot a year's provisions to Eliza G. **Hassell**, widow of Wm S. **Hasell**.

Administration on the estate of Elizabeth Anderson granted to Daniel Anderson, giving bond in \$200 with Bryant **Wooten** and Israel Judge as securities. Qualified.

Administration on the estate of John Austin granted to Elizabeth Swann, giving bond in \$1000 with Daniel **McLammy** and William Mott as securities.

Richard Taylor appointed guardian to John and Thomas Heatly giving bond in \$100 with Wm B. **Meares** and A. M. Hooper as securities.

Abram Beasley and Samuel Buxton appointed to audit the accounts of Wm Mott as **admr.** of William Moore, dec'd.

Bryant **Wooten** and Benjamin Rochelle summoned as talesmen this day and discharged.

Wallace & Swann vs Robert Mitchell & Wm Mitchell - general issue, set off and stat line - Jury empanelled - John **Larkins**, George Cameron, Wm C. Kemp, Robert Taylor, James Major, Jacob Hartman, Charles **Jenkins**, Lewis H. Toomer, Edward **Winslow**, Thomas Wright, John Calhorda, M. McKay and find that the **Defts** did assume within three years, that there is no set off, and assess damages at \$1035.33 and costs.

Admrs of Thomas Lewis vs William Lewis & David Jones - General issue, payment, accord, and satisfaction - Same jury empanelled and find that **Defts** do owe to the Elff \$87, that there is no payment, accord, or satisfaction nor release and assess damages at \$51.46 and costs. Appeal prayed and granted, giving Joseph Lamb and Joseph **Mumford** as securities.

On motion of Wm H. Halsey, Esq., Robert Rankin admitted to citizenship

Petition of Robert Cochran praying that he may be permitted to emancipate a negro slave named Loraine and her infant child named Susan presented court. Ordered that prayer of petition be granted on petitioner's complying with the requisites of the Act of Assembly, giving A. M. Hooper as security. Bond executed and filed.

Proclamation made that the court will tomorrow proceed to the election of an Inspector of Naval Stores and Provisions.

Court adjourned to tomorrow, 10 o'clock.

14th November 1815

John **Cowan's** will was exhibited to court, proved and ordered to be recorded.

James Jennet's will was exhibited to court, proved and ordered to be recorded.

Election of Inspectors - Justices present, the Worshipful: James Blanks, Israel Judge, Richard **Nixon**, H. B. Howard, Samuel Black, A. J. **DeRosset**, Samuel **Ashe**, **Hinton** James, James Foy, Joseph Lamb. Lewis H. Toomer elected by a majority of ten votes. Offered Dr. James Henderson and Dr. Frederick **J. Hill** who were accepted and he took the oath as Inspector.

Fine of Henry Taylor for non attendance at last term remitted.

Alexr Peden, David Mitchell, Joshua James, John E. Spicer, and Wm B. Miller - Fine and costs as defaulting talesmen- fined **\$2** each

Wm L. and S. Potts vs John **McCale** - Attachemnt - Default and Enquiry. Jury empanelled, viz- John **Larkins**, George Cameron, Joseph Jacobs, Nehe Harriss, Wm C. Kemp, Samuel S. Bludworth, Wm L. Bush, James Mason, John G. Morris, Thomas Wright, **Cullen Fillyaw**, Wm New, Sr, and find that Deft did assume and assess damages at **\$184.83** and costs. Property condemned. In hands of garnishee.

John W. James vs Joseph Brightman - Attachment- Jury empanelled and find that Deft **did** assume and assess damages at **\$152.60**. Property condemned. In hands of garnishee.

Admr. of James Allen vs James Ball - Default & Inquiry Jury empanelled and find Deft did assume and assess damages at **\$134.30** and costs. Samuel Hawes called out, a witness on behalf of Plff. Issue Scifa

Doe on demise of John Walker vs Richard Fenn, Carlton Walker, tenant in possession. Ejectment - Defts enter into common rule and plead not guilty. Jury empanelled and find **Defts** guilty and assess damages at one cent and costs.

Joshua H. Toomer appointed guardian of Anthony B. Toomer and Sarah M. Toomer giving bond in \$4000 with James W. Walker and Lewis H. Toomer as securities.

John W. Walker, Lewis H. Toomer and Henry Young appointed to divide the personal estate of A. B. Toomer, **dec'd**, among his heirs.

Ordered that the **Admr** of John Hall have leave to sell a negro man slave named Hector.
Court adjourned to 3 o'clock in the afternoon.

MORE SOCIETY NEWS

In a letter to David Paynter, Director of the New Hanover County Public Library, our new Society President, James T. Edwards announced that ONHGS had extended a line of credit of \$788.07 to the North Carolina Room, which covers the period **from** June 1,2000 to May 31, 2001.

These **funds** will be spent on genealogical materials. One of the purchases is the 1880 Federal Census for the entire nation on fifty-six compact discs. With the help of the Society, the library will also buy the 1930 Federal Census for North Carolina, when it comes out on microfilm in April 2002.

NEW HANOVER COUNTY DEED BOOK "E"

[Many of New Hanover Count's earliest records were destroyed by courthouse fires. What was left of the county's first two deed books, A and B, was combined to form AB. This book was abstracted many years ago by Mae Blake Graves. Deed Book C was published in the *Courier* from 1992 to 1996. Abstracts from Deed Book D began in the Summer 1997 issue of the *Courier* and ended in the Winter 2001. This begins a new series of abstracts from Deed Book E by John Wright Butler.

New Hanover was formed in 1729 from Craven County. Bladen and **Onslow** counties were formed from New Hanover in 1734, Duplin County in 1750, Brunswick County in 1764, part of New Hanover was annexed to **Sampson** County in 1795, and Pender County, last but not least, broke away from New Hanover in 1875.1

Page 1- Mar. 12, 17-- (year missing) Indenture by John **Rutherford** and wife Frances, of New Hanover Co., Province of N.C., to Mrs. **Ann Wright, formerly of Wilmington**, for the **sum** of Five Shillings, portion of Lot number 1, lying on the North side of Market Street, Sou. comer & down to low water mark, as shown by deed in Book 6 page 483, to Caleb **Grainger**. Wits: William **MacKenzie**, Stephen **Baker**, Henry **Toomer**.

Page 1 - Dec. 1, 1761 - Indenture between Maurice **Moore**, New Hanover Co., Province of N. C. & John **Rutherford**, Esqr, Revenue General of his Majesties **Quit Rents** of of aforesaid Province. That Maurice **Moore** being upward of thirty years of age, for five shillings **lawful** money of Great Britain, granted 640 acres, NE branch of Cape Fear River, at Rocky Point. Same was part of patent granted to Col Maurice **Moore**, deceased, father of same, bearing date June 3, 1735, formerly a part granted, Sept. 9, 1726 to Evan **Jones**. Total patent 1,280 acres & in part granted to Col. Maurice **Moore**, Mar. 5, 1729. Wit.: James **Rutherford**, Alex'r **Duncan**.

Page 2 - Nov. 19, 1760 - Robert **Rowan** vs Arthur **Davis** of Kings Town, S. Carolina, in court action, assigns negro women: **Sapha**, **Catherine** with he **three** children & **Peter & Sally** to Frederick **Gregg**. Wit.: John **Rowan**, Arthur **Browning**

Page 3 - April 20, 1763 - Indenture between David **Brown, Taylor** [sic], of New Hanover Co., Province of N.C., to John **Paine, Merc'6**, 250 pds. Real money, a parcel of lot formerly belonging to William **Dennis &** 40 feet from joining lot belonging to Samuel **Green** on Market Street. Wit.: Thomas **Brown**, Moses John **DeRosset**

Page 4 - May 10, 17 [tom] - Arthur **Dobbs**, Captain, Commander-in-Chief of the Province of N. FROM THE FILES OF BILL REAVES...

QUAINT COLONIAL NAMES

It is an interesting study to trace the underlying reason for many of the curious names which are given to the offspring of the first American colonists. Parents searched for names of deep significance - for names appropriate to conditions, for those of profound influence presumably on the child's life.

Many names have a pathos and sadness which can be felt down through the centuries. Dame Dinely, widow of a doctor, or barber surgeon, who had died in the snow while striving to visit a distant patient, named her poor babe Fathergone.

The children of Roger Clapp were named Experience, Waitstill, Preserved, Hopestill, Wait, Thanks, Decide, Unite and Supply. Madam Austin, an early settler of old Narragansett, had 15 children. Their names were **Parvis**, **Picus**, Piersus, Prisemus, Polybius, Lois, Lettice, Avis, **Anstice**, Eunice, Mary, John, Elizabeth, Ruth, Freelove. All lived to be threescore and ten, one to be 102 years old. Edward **Bendall's** children were named Truegrace, Reform, Hoped For, More Mercy and Restore. Richard **Gridley's** offspring were Return, Believe and Tremble.
