FIND YOUR ANCESTORS IN CITY DIRECTORIES

Where do you look for an ancestor who moves into an area after one decennial census and leaves before the next? What if they didn't stick around long enough to buy property? City dwellers, in particular, often moved into an area looking for economic opportunities and then moved on when prospects looked better somewhere else. The only record of their stay may be found in a city directory. Intended to promote business or generate sales these directories can provide a wealth of information about your ancestor whether they were permanent residents or just passing through.

Directories give the location of the person's residence and indicate if they changed residences often. You would be surprised how many families moved every couple of years. They lead you to the very street and possibly building in which they lived. Even if the structures they lived in are no longer standing you can at least walk the block where your ancestor resided and look into the history of the area of the city in which they lived.

Directories give the occupation of the city dweller and in some cases the name of the business in which they worked, ie., clerk for John Doe and Sons, **Commission** Merchants.

Besides name, address of residence, occupation and place of employment, city directories (depending upon the year) may reveal whether a person was a homeowner or rented, spouse's name, name of children, and number of years the family lived at the address.

You won't find everybody listed in these directories. Towns must be fairly large to warrant a city directory. Remember that they were produced to generate sales, not record inhabitants. Old cities like Charleston or Baltimore have directories back to the early 19th century. Wilmington, North Carolina's largest town and port city from about 1840 to 1910, has city directories from 1860 to present day. Directory companies went in and out of business, therefore some years may not be covered. Wilmington had directories for the following years: 1860-61, 1865, 1867 (two different companies), 1871, 1875, 1878, 1881, 1885, 1889, 1895, 1897, 1900-present day.

African-Americans can be found in the city directories from 1867 when they were listed in their own section. Thereafter and until mid-20th century their race is indicated by a c. or asterisk * after the name.

Another great feature of city directories is that you can look up an address and find out who is living there. This is particularly helpful if you are looking up the history of a house, business or just want to know who else lived on a particular street. Wilmington city directories do not have this cross reference until 1915.

In general, city directories provide a wealth of information about the times in which your ancestor lived. Most directories have a brief history of the area and current economic statistics, as well as indexes to businesses, churches, government offices, schools and other organizations and institutions.

Admr of James Gamble vs Robert **Rankin** - Scifa - General issue, payment and release. Judgment of the court that there is such a record. Same jury and find that there is no payment or release and assess damages at \$324.85 with interest from 30th November, **1813** and costs.

Same vs Same- Scifa- same pleas as above. Judgment of the court that there is such a record. Same jury and find that there is no payment or release and assess damages at **\$251.25** with interest from 21st December 1813 and costs.

Admr of Edward Harriss vs Amos Jones - Case General issue. Same jury and find the Deft did assume and assess damages at \$85 principal and \$14.45 interest and costs.

Levy & Gomez vs admr of William Hill - Case General issue. Same jury and find that Deft's intestate did assume and assess damages at \$100 principal, \$14.25 interest, and \$2 for protest with interest on \$100 from 14th November, **1815** till paid and costs.

Proclamation that Court will proceed to the election of a county Surveyor **tomorrow** morning at 10 o'clock.

Court adjourned to tomorrow 10 o'clock.

Ordered as a general rule of this court that the criminal business be done on Thursday.

¹Rev. James A. **Corcoran** penmanship was neat, clear and easy for the reader to decipher. Corcoran rarely signed without the D. D. *Doctorate of Divinity* and he most always placed his signature in uniformed alignment with the entry.

²Mrs. Alice **Thompson** or **Thomson** was the widow of John H. **Thompson**. He died in **Wilmington** during the 58th year of his age, on the 21st of December 1864. *Daily Journal* Fri. Jan. 22, 1864. They lost two sons in the 'Yellow Fever' epidemic of 1862. The **McAveys** or **McEvoys** are in the 1870 Federal Census for New Hanover County. An Emily **Thompson**, age 10, is listed as well.

³The **Brodericks** marriage was also recorded in New Hanover County Marriage Bonds.

NEW HANOVER COUNTY DEED BOOK "E"

[Many of New Hanover Count's earliest records were destroyed by courthouse fires. What was left of the county's first two deed books, A and B, was combined to form AB. This book was abstracted many years ago by Mae Blake Graves. Deed Book C was published in the *Courier* from 1992 to 1996. Abstracts from Deed Book D began in the Summer 1997 issue of the *Courier* and ended in the Winter 2001. This begins a new series of abstracts from Deed Book E by John Wright Butler.

New Hanover was formed in 1729 from Craven County. Bladen and **Onslow** counties were formed from New Hanover in 1734, Duplin County in 1750, Brunswick County in 1764, part of New Hanover was annexed to Sampson County in 1795, and Pender County, last but not least, broke away from New Hanover in 1875.1

Page 13-14 - February 26, 1761 - Will of John **Swann**, County of New Hanover, **Province** of North Carolina, after just debts paid by Exect. hereafter named as soon as possible & after the same I give & beneath my Bank which God has been pleased to bestow upon me in manner following,

Item: wife, **Ann Swann**, the Plantation I now dwell, with House & improvements, joining the land of Mr. Jeremiah **Vail**.

Item: wife **Ann**, land lying on Turkey Creek and that part of swamp or marsh on the **Eastwest** side of main branch of s'd Creek from the Bridge on main road on s'd Creek up to line of Mr. Geo **Hyne** dec'd & twenty five feet of high land of edge of s'd swamp & on the **westmost** side of s'd Creek from s'd Bridge upward to the land of Mr. **Geo Hyne** dec'd.

Item: If wife be with child at my demise I give, divide & beneath to such child & his or her heirs when he or she shall reach the age of twenty five or **sall** marry, after the death of my **wife** the above Plantation & lands.

Item: To such child upon reaching the age of twenty five or to marry, two third part of my personal Estate of what nature or kind & the other third part to wife & heirs or assignees.

Item: That my wife have use of the two third part of my personal Estate if with child upon my demise for **maintanice** of s'd child until he or she reaches the age of twenty five or shall **marry**.

Item: If wife has no child to reach twenty five or shall many, then in such case I beneath to my wife negro slaves - **Ruthana, Muske, Molly, Diana, James & Jacke**, with all the slaves I received from the late Roger **Moore**, father of my wife, in lien of payment of the sum of Eighteen hundred Pounds real money given & beneathed to my said wife in father's will.

Item: **If I have no child** to reach **Twenty** five or shall marry, I beneath to said wife all my Black Cattle, sheep & Hogs, wherever found & my

Plantation tools.

Item: If I have no child, I beneath to my cousin, John Swann **Jones**, grandson of my brother Samuel **Swann**, if he will change his name to **Swann**, all the above mentioned items (after the death of my wife) except land of Turkey Creek upon condition he reaches age twenty five & changes his name. If not in such case, I beneath to my own right heirs the Plantation & lands above mentioned.

Item: If no child of my own, I beneath to my niece, Jane **Jones**, daughter of my said brother **Sam'l Swann** the land in the main branch of Turkey Creek.

Item: As in above item, I beneath of my nephew Robert **Jones**, Junr., son of my Brother in Law, my part of the land in the town of Wilmington, New Hanover County, purchased by me & his Father. Said Father was to make title by deed for one half to me.

Item: I beneath to my Cousin, John Swann **Waters**, if I have no issue, my negro Girl called Sarah.

Item: If no issue, then to my nephews John **Robe**, Samuel **Robe** & Samuel **Swann**, son of my Brother Samuel **Swann** all my other negro slaves not in my will & to be equally divided between them.

Item: Lastly, I appoint my wife, **Ann Swann**, Executrix & Brother Samuel **Swann**, George **Moore** & Frederick **Jones**, Son in Law of my Brother Executors.

Wit: John M. **Walker**, James **Moore**, Junr. J. A. **Murray** - Probated April 1762, in Superior Court & Registered 4 November 1762.

Page 15 - [Addendum] A memorandum of said declarations amended & where made in writing of the last Will & Testament of me Jno **Swann** which are as follows, this is to say - [A lengthy paragraph *follows consisting of various* words & phrases indexed by the number of lines from the beginning.

The paragraph is in large part unreadable. No attempt was made to transcribe it.] The addendum was witnessed & signed in the year 1761, by J. A. **Murray, Jas Moore, Junr.** Jno **Watters** - Probated 9 April, 1762.

Will of Alexander **Wilson** of New Hanover County, North Carolina.

Item - To wife, Sarah **Wilson**, one third part of my Estate, real & personal to live on my Plantation and have possession during her natural life or until she should **remarry**.

Item - I beneath to my Grand son, Timothy, Jr., my said House & Plantation Home - I beneath to my oldest son, Timothy, my Plantations and the appertinances (except as before named to my wife).

Item - I beneath my land of the **westside** of the Creek opposite my said Plantation to my second son, Alexander.

Item - I beneath to my **third** son, Thomas, ten *sheep, that is to say, six Ewes & fourantlers of those* that are a year old.

Item - I beneath all the net residue of my stock of cattle, sheep, Hogs & Horses to my sons & daughters to be equally divided. Wife, Sarah, to keep enough on said Plantation to support herself or as long as she remains a widow.

Item - I apoint my wife, Sarah, and my friend Edward **Priee**, Executors of this my last will.
Page 16 - Wit: Jno **James**, Silas **Bowen**, Timothy **Bloodworth**. Registered 4th November 1762 - James **Moran** Register.

January 15, 1762. Will of **Susannah Martindale** of the County of New Hanover, State of North Carolina.

Item - All my just debts and funeral expenses be paid.

ONE LAST WORD...

The man who has nothing to boast of but his illustrious ancestors is like a potato - the only good belonging to him is underground.

Item - All my real & personal Estate in the province to my beloved son James **Ray**.
