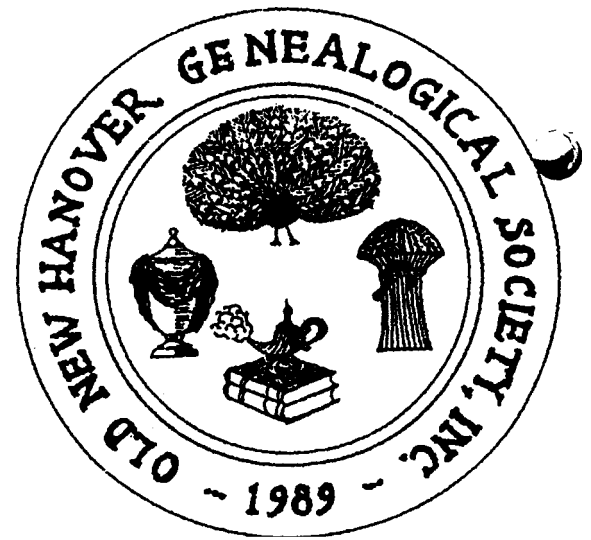

SURNAMENAMES

Although the Romans were the first in western civilization to have family names (*cognomina*), it was not until about 1100 A.D. that a second name became common in Europe. The second or surname was added when it became necessary to distinguish one from another the many *Johns, Marys* and others who had received saints' names when they were baptized. The French nobility introduced the practice into Britain, hence *surname*, which has an old French derivation.

The most common scheme was to identify a man by his given name and that of his father. From very ancient times, the Jews used this system, with X *ben* (meaning son of) Y. In English, John, son of **Richard**, became John Richardson. There are thousands of names in this *patronymical* (father's name) way of determining surnames. *Wilson, Jackson, Johnson, Williamson* are some of the most common. In America, with our diverse population, you may encounter *-ian* (Armenian), *-sen* (Danish and Norwegian), *-nen* (Finnish), *-pulos* (Greek), *-ez* (Spanish), *-wicz* (Polish) and *-ovitch* (Russian), all meaning *son of*. Prefixes can also indicate descent: *Ap* (Welsh), *Mac, Mc* (Scottish, Irish), *d'* (Norman) and *O'* (Irish), the latter actually denotes grandfather rather than father. *Fritz* is a corruption of the French *fi* (son) and at one time indicated one born "on the wrong side of the blanket." In those days, it usually was better to be a bastard son of Somebody, than an legitimate son of nobody, according to name expert and author, Leonard R. N. Ashley.

A surname could be determined by occupation. Hence, *Smith* from Blacksmith, *Cook* from food preparer, *Miller* from grain grinder, *Fisher* from fisherman, and so forth. Some of these surnames are from occupations and terms which we no longer have. For instance, a *Cooper* was a barrel maker, an occupation not very prevalent today.

Location is also a source of these names.

John may have resided near a stream; therefore, he would be designated John *Brook*; or, John may have lived in a place called York, hence, John *York*.

Physical characteristics also contributed to the origin of surnames. An unusually small person would be called *Short, Small, Little or Lytle*. A large man might be named *Longfellow, Large, Lang* or *Long*. Many persons having the characteristics of a certain animal would be given that animal's name. For instance: a sly person might be named *Fox*; a good swimmer, *Fish* and a quiet man, *Dove*, etc. The surname was passed on to descendants despite their appearance or occupation.

The average person might have gotten his surname from a nickname. The most famous of the nicknames were given to royalty: Charles the Bold, Charles the Idiot, Ivan the Terrible or Erik Pinchpenny. Ordinary people became John *Wise*, John *Proudfoot*, John *Strangeways*, etc.

The most common surnames in North Carolina in the Federal Census of 1790 were *Smith, Williams, Jones, Davis, Moore* and *Taylor*, which reflect the fact that the majority of the NC citizens at that time were of English origin. Nearly fifteen per cent of the population were from Scotland, with names such as *McLeod, McCloud, Robertson* and their many derivatives.

We all have heard of unusual coincidences, such as a surgeon called *Slaughter* or a Dentist named *Payne* or the *dry* goods store - *Ketchum and Cheatham*. Nowadays, we rarely encounter the following names listed as heads of household in the 1790 census: *Spitsnoggle, Madsavage, Crampeasy, Rottenberry, Laughinghouse, Wentup, Grabtale, Bump, Gouge, Beersticker* and *Tart*.

NEW **HANOVER** COUNTY COURT MINUTES
Court of Pleas and Quarter Sessions
May Term, 1816

[This series of New Hanover County Court Minutes submitted by Helen **Sammons** is continued from the Winter, 2003, Courier. These may be viewed on microfilm in the North Carolina Room of the New Hanover County Public Library.]

John **McDuffie** vs Malcom **McAllister** - Isaac Alderman called out on his subpoena and failed. Judgment nisi against him. Ordered that Scifi issue against said Isaac Alderman to show cause why an attachment should not issue against him at next court

Samuel Pitts vs Isaac Arnold - case general issue - setoff, stat line, accord and satisfaction. Same jury and find that the deft did assume within three years, that there was no setoff nor release, nor accord and satisfaction, and assess damages at \$80 and costs.

Admrs of Henry Wright vs Caleb **Robeson** - debt - general issue, setoff, Payment at and after the day - Same jury and find that the writing obligatory is the act and deed of deft and that the debt has been paid.

Account sales of the estate of Abraham Golden, deceased;

Inventory and account sales of the estate of James Jennett, deceased;

Inventory of the estate of Daniel **McKay**, deceased;

Division of Negroes between Ann Nutt and her children;

Inventory of the estate of Robert **Nixon**, deceased;

Division of the personal estate of Thomas Rogers, deceased;

Inventory of the estate of James Shaw, deceased;

Inventory and account sales of James Telfair, deceased;

Audited account of the estate of Joshua **Wooten**, deceased.

All rendered to court and ordered to be filed.

Administration on the estate of Thomas **Leddon**, deceased, granted to Thomas **Ledden**, giving bond at \$400 with James Simmoons, Wm **McCurdy** as securities. Thomas **Leddon** qualified.

Ordered that Bryant **Wooten** enter into bond for \$400 for the maintenance of a bastard male child begotten on the body of Tela **Casteen** and for indemnifling the parish, etc, with Samuel James and Benjamin Rochelle as securities and that he pay unto the hands of Tela **Casteen**, the mother of said bastard child, 20 lbs annually for three years.

The will of William Swann Nichols was exhibited in open court and proved by Gabriel Holmes, Jr., one of the subscribing witnesses, and ordered to be recorded and Caleb Nichols qualified as Executor thereto.

Administration granted to Jacob **Hartman** on the estate of Samuel Sexton, deceased, giving bond in the sum of \$2500 with Jacob Levy and Henry Taylor, securities.

Israel Judge, Samuel James, and Thomas Player appointed to audit the accounts of Moses Manning, executor of Thomas Ramsey, deceased

Joseph D. **Broadham** has agreed for the sum of 23 lbs to testifl on behalf of the State against Ezekial **Trussel** on Thursday next

Court adjourned to 3 o'clock in the afternoon

Court met according to adjournment

Present the Worshipful: Henry B. Howard, Samuel Black, James S. Green, John Hogg

Ordered that the usual allowance for extra service be made to the officers of this Court and to the bell ringer for the year 1815

Administration on the estate of Alexander Hostler granted to James S. Green, giving bond in \$4000 with Wm H. Halsey and Charles Wright, securities

Ordered that the sheriff surrender the mulatto boy named Harry to Samuel Kingsbury, his master, with payment of all costs

Ordered that Hannah Collins aged about 15 years be bound to Anna Smith until she arrives at the age of 18 years, on giving bond with Wm W. Jones as security

John R. London qualified as administrator of John London, deceased.

Ordered that Joseph Jacobs be allowed his account, to wit: eight dollars for expenses of burying a deceased man, name unknown, at Mr. Waddell's plantation below the town of Wilmington.

A deed from David Anderson to Wm W. Jones proved by Niel **McLaurin**, subscribing witness thereto

Afternoon 3 o'clock

Court met according to adjournment

Present the Worshipful: J. W. Walker, Wm H. Vann, Thomas Devane

Jesse George, a talisman, discharged

Gilbert Geer, for the Wardens of the Poor vs James Marshall - general issue- Caveats perfu____, release, accord and satisfaction - referred - Ordered that the award of the referees be made the judgment of this court.

President of the State Bank vs Owen **Kenan** - Same jury except Jesse George in whose room is John Williams and find that the debt did assume and assess damages at \$546 with interest from 12th Aug 1815 and costs.

Same vs Same - Same jury and find for the plff \$651 with interest from 18th August 1815 and costs

Same vs Same - Same jury and find for plff \$100 with interest from 29th July 1815.

John Nelson vs Robert **Simpson** - Not guilty, justification, lender of _____. Same jury and find the debt not guilty.

The Governor for William Motte vs James W. White, Wm **McKay**, and Gilbert Geer. Debt. Default and inquiry. Same jury except Wm Motte and Daniel **McLammy** in whose room is Thomas C. **Reston** and John Everitt and find the writing obligatory to be the act and deed of the debts, that the condition of the bond are not performed and find that the debts do we the sum of \$200 to be discharged b the payment of \$38.65 and assess damages at 6 cents and costs.

President of the Bank of Cape Fear vs Samuel Bunting, Jr. General issue, payment setoff, stat line - Jury empanelled. Viz: James Simmons, **Kinchen** Powers, Jacob James, John Taylor, Thomas C. **Reston**, Edward St George, George Jennings, John **Everitt**, John St George, George Tessler, Richard Saunders, John Wilkings and find that debt did assume within three years, that there is no payment nor setoff and assess damages at \$356 with interest from 18th

August 1815 and \$2 for protest and costs.

Same vs Andrew **McJulian** - Case- general issue- Same jury and assess damages at \$356 with interest from 18th August 1815 and \$2 for protest and costs.

Ordered that administration on the estate of James Shaw be granted Daniel Sellers giving bond in 7000 lbs with Duncan **Robeson**, Niell Murphy and Daniel Kerr as securities. The said admr has permission to sell the perishable estate of his intestate.

Ordered that Thomas **Leddon**, admr of Thomas **Leddon**, deceased, have leave to sell the perishable estate of his intestate.

Ordered that Jacob **Hartman**, admr of Samuel Sexton, deceased, have leave to sell the Negroes of his intestate. (Bond not executed by securities). Jacob **Hartman** qualified as admr of Samuel Sexton, deceased, by direction of a majority of the court although bond not executed by securities.

H. B. Howard on the bench and defecting John Julius Gause appointed guardian to Benjamin Roberts Nutt, John Nutt, and Henry Nutt giving bond in 6000 lbs with John D. Toomer and A. M. Hooper securities

Ordered that Rebecca Ann Southerland of the age of 11 years be bound until she is 18 years of age to Mrs. Susan Wright to learn the art and mystery of a seamstress upon Mrs. Wright's signing the indenture with Charles Wright as security, agreeable to the Act of the Assembly in such cases made and provided.
Court adjourned to 9 o'clock tomorrow

Ordered that Hannah, formerly the property of Hanson (?) Allen, of Brunswick, be emancipated on giving bond agreeable to Act of Assembly.

Ordered that commission issue to take the private examination of Susan M. Tooley, wife of Philip C. Tooley.

Joseph **Mumford**, Esq. appeared in open court and exhibited his commission as Justice of the Peace and qualified.

Michael Boney, defaulting talisman, fined \$2.

Ordered that Peter Smith be appointed guardian for Lewis, John, and Rebeccah Collins, giving bond in \$300 for each with Charles B. Gause and William Morris as securities who are approved by the court consisting of Joel Parish, H. B. Howard, W. J. **Larkins**, and Wm H. Vann.

James **Bowen** about nine years of age bound to Aaron **Bowen** until he arrives at the age of twenty one.

Tax laid by the court for county uses for 1815: five cents for every \$10 value on land; forty cents for every white and black poll; twenty cents on each white and black poll for jail tax

John Hambleton vs John Hulet - appeal docket. Jury empanelled: James Simmons, Kinchen Powers, Jacob James, John Taylor, Edward St George, Daniel **McLammy**, John

Walker, Alexander Peden, John Everitt, Frederick Foy, James Mashborne, Richard Saunders and find deft did assume and assess damages at \$6 and costs. On motion, judgment agt securities

President of the Bank of Cape Fear vs admrs of Henry Wright. Case-general issue- Same jury and find that **defts'** intestate did assume and assess damages at \$60 with interest from 7th March 1815 **anc** costs

Christopher Dudley, Sr. vs admr of R. Williams. Scifa-general issue- Same jury and find that a Negro named Sam claimed by other persons has come to the possession of the deft

Same vs Same- Scifa- Same jury and same verdict

Nathan and Lot Williams vs Elizabeth Dorsey - Case default and inquiry - Same jury and assess damages at \$59.26 and costs.

Samuel Champlain vs executors of R. Davis - case default and inquiry - same jury and find for plff and assess damages at \$92.75 with interest from 3rd July 1815

Administrator of D. **Lamock** vs John **Wilkinings** - Case, general issue, same jury and find that deft did assume and assess damages at \$150.57 with interest from 13th September 1811 and costs. Appeal prayed and granted giving bond with Archibald F. **McNeil** and Thomas **Cowan**, securities.

Peter Cotton vs administrator of Wm S. **Hasell**. Case, general issue. Same jury and find that deft's intestate did assume and assess damages at \$163.66 with interest from 17th December 1815 and costs.

William Guthrie vs administrator of William Hall - Appeal docket - same jury and find for the plff and assess damages at \$50 with interest from 3rd September 1813 and costs
Court adjourned to 3 o'clock in the afternoon

Afternoon 3 o'clock

Court met according to adjournment

Present the Worshipful: Henry B. Howard, Joseph Lamb, John Garnierl day

Ordered that the sheriff of the county be authorized to hire a guard to attend the jai and night until the prisoners, Samuel and Benjamin Spa____ are returned tot he county of Craven.

The sheriff representing to the court the insufficiency of the jail and protesting against the same, moved that an order might be made and directed to the Colonel or commanding officer of the county requesting him to furnish a guard for the safekeeping of the prisoners committed to the jail. The court doubting their authority to make such an order and apprehending the great expense that would be incident to it execution, refused the motion.

The court consisting of Henry B. Howard, John Garnier, Joseph **Mumford**, Joel Parish, Wm H. Vann, Wm J. **Larkins** and Joseph Lamb proceeded to the election of a sheriff, when Gabriel Holmes, Jr. was unanimously elected upon giving bonds agreeable to the Act of Assembly with Wm W. Jones, Thomas F. Davis and A. M. Hooper as securities. Bonds, execution and filed.

Duncan **Robeson**, Esq. exhibited his commission as a Justice of the Peace and qualified according to law.

Paoli **Ashe** vs Wm L. Bush. General issue- Jury empanelled: James Simmons, Kinchen Powers, Jacob James, John Taylor, Edward St George, Daniel **McLammy**, Alexander Peden, John Everitt, Frederick Foy, Richard Saunders, John Walker, James Mason and find the

writing obligatory to be the act and deed of the deft and assess damages at \$50 with interest from 1st July 1815 and costs

John **McDuffie** vs Isaac Alderman - Scifa - general issue. The court adjudge that there is such a record. Judgment according to Scifa.

William Harriss vs John Neale - Debt - General issue- setoff. Same jury and find that the deft does owe the sum of \$80.56, that there is no setoff and assess damages at \$16 and costs.

Same vs Henry H. Neale - case general issue, setoff, stat line - same jury and find that the deft did assume within three years, that there is no setoff and assess damages at \$68 with interest from 5th Jan 1814 and costs.

Henry B. Howard vs James Mason - case, general issue. Same jury except James Mason in whose room is James Mashborne and find that the deft did assume and assess damages at \$112.50 principal and \$1.66 interest, and costs.

Lewis A. **Nixon** vs Frederick Foy - Lewis and John Messick called out on their subpoenas and failed - issue scifa.

James Usher vs Michael Boney - Case, general issue. Same jury and find that deft did assume and assess damages at \$276.16 with interest from 28th November 1815 and costs.

Executor of Wm S. Nichols - case-general issue - payment, setoff, stat line- Same jury and find that the deft did assume within three years, that there is no payment nor setoff and assess damages at \$207 with interest from 18th August 1815 and costs.

Court adjourned to 9 o'clock tomorrow

Thursday 9'clock

Court met according to adjournment

Present the **Worshipful**: Henry B. Howard, William Hall, Wm Isler **Larkins**, John Hogg, John Garnier

Henry Taylor, talisman, discharged

State vs Joseph Lamb- John Harriss prosecutor. Witness called out and failed

State vs William Isler **Larkins**- nonfeasance- pleads not guilty. Jury sworn and empanelled, viz: James Simmons, **Kinchen** Powers, Jacob James, John Taylor, Edward St George, Daniel **McLammy**, Miles Blake, William Richardson, John Walker, **Hillary** Moore, Richard Saunders, Samuel Potter, and find the defendant guilty in manner and form as charged in the indictment.

Fined \$6 and costs. Fine and costs paid.

State vs Ezekiel Trussell- Assault & battery- Pleads not guilty- Same jury and find the defendant guilty in manner and form as charged in the indictment. Fined \$1 and costs.

A deed from Philip C. **Tooley** and Susan M. **Tooley** proved by Donald R. **McLeod**, subscribing witness thereto. Ordered that a commission issue to Obed Macy, George Swain, William **Armfield** and _____ **McKeon**, or any two of them to take the private examination of said Susan. Ordered that Capt. Thomas Calllender, Gabriel Holmes, and Thomas **Cowan** be appointed to audit the accounts of the Executor of Wm H. Hall.
