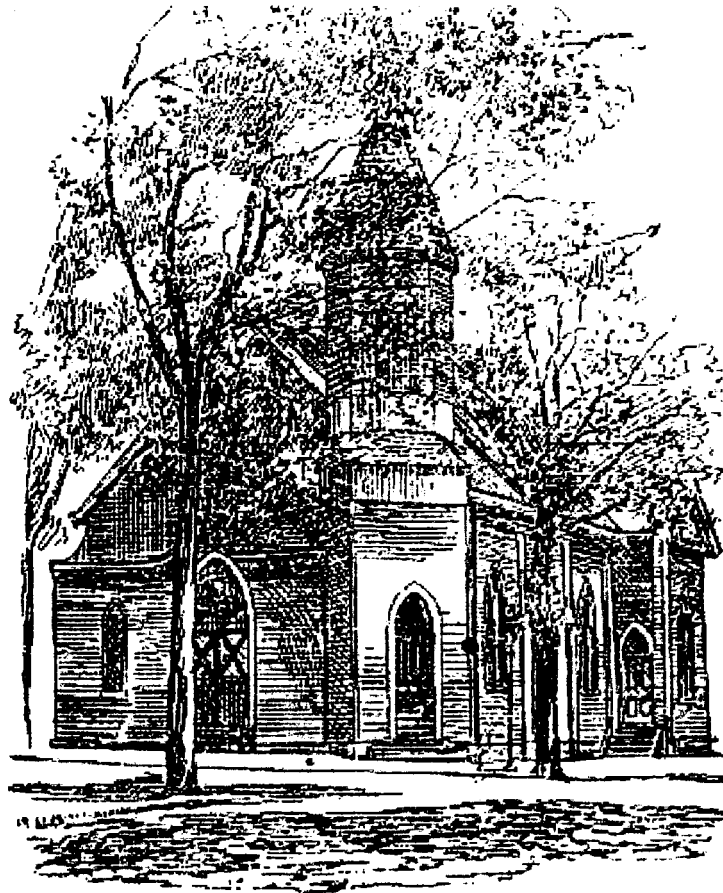

At a Court of Pleas & Quarter Sessions began and held for the County of New Hanover at the Court House on the second Monday of August, being the 12<sup>th</sup> day of August in the 41<sup>st</sup> year of Independence AD 1816

The court was opened with the usual proclamations

**Jacob Casteen** defaulting juror at last term excused

The will of **John Miller** exhibited in open court and proved by **Sweeting Bond**, one of the subscribing witnesses and ordered to be recorded.

Richard Lloyd, Esq. Apointed county Trustee giving Hanson Kelly and James H. Draughon as securiteies

Ordered that the county Trustee apply to the county court of Craven in order to be reimbursed for the expense of the guard who guarded Benjamin & Samuel Sparrow, to wit: \$240, and ordered that the county Trustee be allowed that sum in the settlement of his accounts with the county.

Charles B Morris be appointed Constable on giving bond with Charles **Nixon**, Samuel Bunting and Henry Perrin as securities

Ordered that a commission issue to take the depositions of Francis Duboe, John Joseph **Lapan** and Anthony Chanet touching what they know concerning the residence of Dominique Cazeau in the United States of America

John Nelson appointed Constable for the town of Wilmington giving bond with George Tipler and Henry Perrin as securities

Gabriel Holmes, Jr. and A. M. Hooper appointed to audit the records of Richard Lloyd, county Trustee. Made report and ordered to be filed

Court adjourned to 3 o'clock in the afternoon
