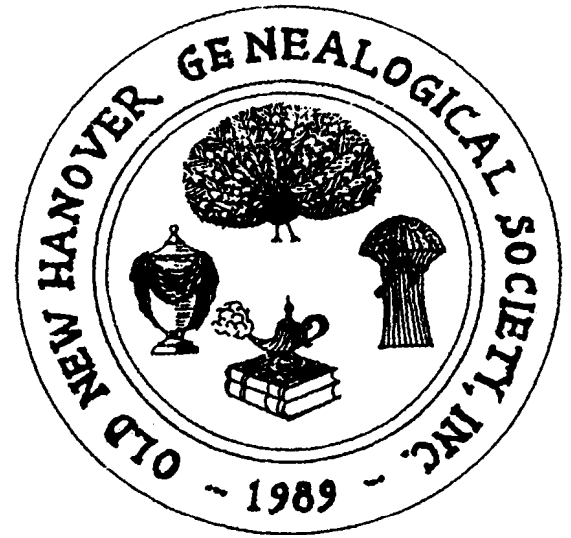

**LETTER FROM THE PRESIDENT**

In about six months we will be in the midst of looking for new officers. The terms of office will expire for the President, V. Pres., Treas., Secretary and Member At Large at the end of May, 2005. The new officers would take over June 1" and preside at the first meeting in September of 2005. Also we are searching for a Bulletin Editor for the "Clarendon Courier." Ann Hutteman, who has been doing a great job, would like to retire from that position. Also needed is a publicity director to be sure that we get our meeting notices in the paper and the guest speaker and subject matter mentioned. Beverly Tetterton has been doing this for years and would like to see someone else have a chance.

We proposed at the last Board Meeting to reduce our meetings to 4 per year, September, November, March, and May, beginning Sept. 2004. This would reduce the load on prospective officers in the future. We will have to revise our By-Laws to do this. If you have any pros or cons let me know.

I plan to appoint a nominating committee early in the fall so we can begin the task of finding interested parties that will step forward and take the responsibility of keeping this organization on a forward path. I need one person from the general membership, so if that appeals to you let me know.

Club members do a lot good things. I personally have been transcribing the obituaries since 1998 from the Wilmington Star and Wilmington Journal to a disc and provide copies to the library. John Butler proofreads these and many other documents. Helen Sammons does research for people requesting genealogical information from the area. Kay Berg is transcribing the 1900 US Census data for this area. Ken Davis is indexing the "Reaves Collection" and an inventory of Greenlawn Cemetery and is being subsidized by the club. Ann Hutteman is proof reading and indexing this inventory. Peter Ambler is our Web Master for our web site and is doing a great job. Joseph Sheppard has transcribed the wills from Brunswick County Deed book A, 1764-1772, which should be available for purchase by the May picnic. Carol Weiss is transcribing the minutes from the Hopewell Presbyterian Church. We sell the transcriptions and half of the profits are allocated to the North Carolina Room at the Library for the purchase of books. As an added item, I would like to see someone step forward and transcribe the marriages and births from the newspapers each week. I would anticipate that it would take about an hour or two at the most to do the marriages and births once a week from the Sunday paper, using the Microsoft Excel program.

It would be a shame to lose all this because we have no one to accept an office with the club.

Any member interested in being nominated, please see me, or any board member.

Act of Congress December 12<sup>th</sup> 1812 and January 2<sup>nd</sup> 1812

It appearing to this Court that the office of Register of this county, now vacant, will probably remain so unless the fees of said office are raised. Ordered therefore that an application be made by a representation and memorial from this Court to be signed by the Chairman to the Honorable, the General Assembly of this State, for relief in the premises in the words following, viz: To the Honorable the General Assembly of the State of North Carolina. The representation and memorial of the County Court of New Hanover respectfully showeth that at November term of this Court last past, the Register of this county resigned his office. The court, anxious to have the office filled, has respectfully given notice of their intention to hold and elect a proper person to fill the same, but in vain, as no candidate appeared and they are instructed and do believe that none will unless the fees of the office are raised. The court, fully sensible of the necessity of the office being held and executed by some proper person and of the inconvenience that the county and individuals have suffered and will continue to suffer from the office remaining vacant, pray your Honorable body grant relief in the premises by passing an act raising the fees of the Register of this county fifty percent on the rates now by law established and that the same may be passed at as early a period of your session as can be conveniently be done with a proviso that the said act have operation and effect immediately from and after the passage of the same - New Hanover County Court, August Term 1816.

In open court - By order and direction of said Court in their name and behalf - signed by John Hogg, Chairman, and that the clerk hand said memorial to one of the members of their county with a request on the part of this court that he, with the other representatives of this county in the General Assembly, have a Bill brought in and passed into an Act in the next General Assembly carrying into effect the prayer of the memorial.

Know all men by these presents that I, **Augustus Newman**, of Newport in the county of Newport and State of Rhode Island, merchant and surviving partner of the firm of **Thurston & Newman**, have constituted and ordained and made and in my stead and place, put and by these presents do constitute, ordain, and made in my stead and place Hobbs, Geer & Co. of Wilmington in the State of North Carolina to be my lone sufficient, lawful attorneys for me and in my place and stead and to my use, to ask, demand, record, and receive of and from all and every person or persons whomsoever the same shall or may concern, all or singular sum or sums of money, debts, goods, wares, merchandise, effects and things whatsoever they shall or may be found due owing, payable, belonging and coming into the firm of the late **Thurston & Newman**, formerly doing business in the said State of North Carolina and more particularly to receive any sum of money that may have been received of Samuel Estabrook and now in the hands of the County Court Clerk, giving and hereby granting unto my said attorneys my full and whole strength, power, and authority on and about the premises and to take and use all due means, course, and process in the law for the obtaining and recovering the sum of monies and receipts therefore in my name and to execute due acquittance and discharge for the premises to appear and the person of me, the constituent, to represent before any governor, judge, justice, officer, minister of the law whatsoever in any court or courts of judicature and others on my behalf, to answer, defend and reply to all actions, courses, matters, and things whatsoever relating to the premises. Also to submit any matter in dispute to arbitration otherwise with full power to make and substitute one or more attorneys under them, my said attorneys, and the same again to revoke and generally to say, to act, transact, determine, accomplish, and finish all matters and things whatsoever relating to the premises as fully, amply, and effectually to all intents and purposes, I, the said constituent, if present, ought or might personally; although the matter should require

more special authority than is herein comprised. I, the said constituent, **ratifying** allowing firm and valid all and whatsoever my said attorneys or their substitutes, shall **lawfully** do or cause to be done in about the premises by virtue of those presents. In witness whereof, I have hereunto set my hand and seal the twenty fifth day of May in the year of our Lord one thousand eight hundred and **fifteen** - Signed, sealed and delivered in the presence of Henry Sherborne, Public Notary and David Terry.

The society has funded the project, which will include the purchase of a copy of the microfilm which will be placed in the North Carolina Room. We may be on the way to **identifying** some of the brave souls who are in **Oakdale**.

Gravestone Records of *Greenlawn Memorial Cemetery, Wilmington, NC, Volume One - Four* are available for sale. Beginning in 1947, these valuable records contain over 15,000 entries and were compiled by J. Kenneth Davis, Jr. He was assisted by Nancy Spivey Nelson, James Michael Whaley and Clifton C. Williams. Volumes One - Three list the decedents in alphabetical order. Volume Four is a supplemental index by Ann Hewlett Hutteman of the known maiden names and the names of the parents of the deceased persons. The project was a mammoth task and is augmented by data from the New Hanover County death and birth indexes, the *Wilmington Star-News* obituaries, the Reaves Collection in the North Carolina Room and *Obituaries in Wilmington Newspapers, 1998-2002* by Jim Edwards. A splendid map of the cemetery is provided in Volumes One - Three.
