Wills of Brunswick County, North Carolina
Records of Deeds Book B 1772 - 1790
 By Joseph E. Waters Sheppard

The Wills of Brunswick County Deeds Book B are the final and fourth in a continuing series from the *Clarendon Courier* Summer 2005. The wills were read from microfilm housed in the Special Collections Department of the New Hanover Public Library. Brunswick County wills were recorded into Will Books after 1790 and recopied into, for example, *Brunswick County Records of Wills Book A, 1764 - 1921*. The wills in these books are no longer chronological. The best advice to find a will after 1790 is to use the *Brunswick County Clerk of Court Office Cross Index to Wills, 1764 - 1968*. The cross index lists devisor, devisee, when probated, book and page number. Books that are listed with (R.O.) next to the letter indicate the will was recorded in the Brunswick County Deeds, or also called, Real Estate Transactions, Books A or B. Please contact the author or the Old New Hanover Genealogical Society for a copy of any printed original source listed in this series. Enjoy.

First I give and bequeath unto **Isaac Ludlam** Son of **Jeremiah Ludlam** one Cow & Calf Secondly I give and bequeath unto **John Ludlam** Son of **Jeremiah Ludlam** 1 Cow & Calf Thirdly I give and bequeath unto **George Stanton** Son of **John Stanton** three Cows & Calves Fourthly I give and bequeath unto **Lois Stanton** daughter of **John Stanton** three Cows & Calves Fifthly I give and bequeath unto **Eliza Stanton** Daughter of **John Stanton** three Cows & Calves Sixthly I give and bequeath unto **John Stanton** Junr three Cows & Calves and after the paying of the aforesaid Legacies I give and bequeath unto my Uncle **John Stanton** who with my beloved friend **Needham Gause** I appoint Executors to this my Will & Testament . . . Seal this third day of August in the year of our Lord one thousand Seven Hundred and Eighty two

Samuel Watters, DBB pages 240 – 242

In the Name of God Amen I Samuel Watters of the County of Brunswick and Province of North Carolina being of Sound mind and memory do hereby make and ordain this to be my last Will and Testament in Manner and form following That is to say I Will and desire that my Just Debts be first paid by my Executors hereafter named

I give and bequeath to my Son Samuel Watters to his Heirs and assigns forever a part of my Plantation called Hale Point or Dollisons meaning that part of the Plantation where the clearing and Buildings are bounded above by the line of Joseph **Watters's** Bluff Plantation and below by a Branch that Runs into the Swamp below the Negroes Houses from thence running back according to a line hereafter to be Described

I give and bequeath to my eldest Daughter Sarah Watters her Heirs and assigns forever all the lands I am possess on the North West River below the Branch aforesaid described . . .

I give and bequeath to my Daughter Martha Watters . . . all that piece or parcel of land by me taken up containing two hundred Acres be it more or less situated over the River opposite to Hale point joining Mr. John Rowan's land at the mouth of Black River

I desire and devise that my Executors do sell my Plantation known by the name of Green Banks or also the low Lands on the opposite side of the River joining Ephraim Vernon's land on the North West River the Money arising from such sale to be put out at Interest until my Daughter Mildred Watters be of the age of Eighteen and then principal and Interest to be given up to her for her own proper use and behalf

I desire my Plantation on the white Marsh my land at Rattle Snake and all other Lands I may die possessed of. . . shall be sold . . .

I desire My Mills and Lands on Causey Swamp to be worked for the Benefit of my Estate for the span of Ten Years the profits arising from the same to be applied here as of the Payment of my Debts the Residence to be Divided among my wife Elizabeth Watters and my Children . .

I desire that my Executors will make a due and sufficient Title to James Clordy his Heirs and Assigns to Lands he bought from me thereover by the Name of the Horse Shoe in the County of Bladen

I Will that all my Blooded Horses, Mares and Colts be sold for the payment of my Debts except my mare Colt called Silk Stockings which I give to my Son Samuel . . .

. . . It is my further desire that my said Wife Elizabeth be allowed in her proportion to choose my **Mullatto** Wench called Chloe . . .

A Message from the Society's Secretary

Carolyn Corbett, Secretary of the Old New Hanover Genealogical Society wishes to pass on the following information:

Your Genealogy Work

You spend time, travel, and money collecting information about your family. Now what are you going to do with all those papers? Do you want the information to be shared with others? We have heard the horror stories of what happens to family pictures, family Bibles, and other genealogy information being improperly disposed of after someone dies.

Many public libraries with local history and genealogy departments would accept the donation of your family papers or a copy of your family's history. There are also institutions in the towns and regions where your families originated. Your local genealogy or historical society may be interested to print your story in their local journal. State Archives, National Archives, Daughters of the American Revolution are other possibilities.

What about those loose ends with your reference materials? Pass your *How-To books* onto friends or family. Identify your collection of photos and date interviews with older family members. Have you written your own life story? It will be interesting to a future generation family genealogist. It doesn't have to be eloquent; just document your sources. Consider writing short biographies of your ancestors too. Print your books or information with a good grade of paper, especially acid free. Paper is still a reliable way to pass on genealogy work. Digital media changes very fast and keeping up with the technology may prevent the information from being unreadable.

Remember, time is not on your side so get organized. A new idea is to make a historical-genealogical codicil to you will that will give directions about what to do with your genealogy.

The photograph on the cover of this edition of the *Courier* is Pembroke Jones (1858-1919), a native of Wilmington, financier and president of the Standard Rice Company. "Keeping up with the Joneses" has been attributed to trying to maintain the opulent lifestyle of Jones and his wife, Sadie Green. While in the Cape Fear area they lived in the Dudley Mansion at 400 S. Front Street and on Wrightsville Sound at Airlie and Pembroke Park. The illusive Mr. Jones either rarely had his photograph taken or the photographs have been lost, even to his own descendants. Local historians have been looking for a good photo of Mr. Jones for many years.

Recently, a descendant of the London family, who now lives in Ohio, dropped off a box of photographs at the library. She said that she had no heirs, so rather than throw the papers and photographs away; she took the time to bring them back to Wilmington. What a surprise it was to find the excellent photograph of Pembroke Jones in the collection! His mother was a London and her sister raised him. Hence, the photograph turns up in the London collection.

You never know how important your family papers and photographs are to others. Before throwing them away, try to find a good resting place for them!
